Trial date is tentatively set for the first part of December, 1968, and it would be appropriate if the lead is covered in an expedite fashion. For your assistance, there is enclosed a diagram of the hotel area and location of the shooting.

23 copies of the FD-302 should be submitted.

Investigation at Portland, Oregon, has revealed the name of JIM BAILEY as being present at the hotel at the time of the assault on Senator KENNEDY. BAILEY was a former resident of Beaverton, Oregon, but has moved from this area. His home is thought to be someplace in the state of Washington, and his grandmother (name unknown) resides at 1009 N. Bethel, Street, Olympia, Washington, phone number 206-357-6470. On 12-9-68, Beaverton, Oregon, Postal Authorities state that their records show a JIM BAILEY, 2435 S. E. Ecole, Apartment 89, Beaverton, Oregon, as being gone, no address as of 8-7-68.

On 12-10-68, KATHY TAYLOR, 26 S. E. 71st Street, Portland, Oregon, stated that JIM BAILEY lives in Washington with his grandmother. His exact address is unknown but she may have a record of it at her home, and will immediately contact the FBI when this is learned.

On 12-17-68, KATHY TAYLOR, 26 S. E. 71 Street, Portland, Oregon, stated that the address she had for JIM BAILEY was at his grandmother's home (name unknown) at 1009 N. Bethel Street, Olympia, Washington, phone number 206-357-6470.

At 8:00pm this date writer was on duty at the Rampart Detectives, LAPD, and received information from Policeman LAWRENCE DE LOSH, Juvenile Division, Los Angeles Police Department, Extension 2805, that he has received several telephone calls from a personal friend, Mrs. HOWARD (JOAN) OTTO, 226 Hubble St., Houghton, Michigan, Area Code 906, telephone 482-7269, concerning captioned matter. DE LOSH said Mr. & Mrs. OTTO formerly lived in the Pasadena area, and that Mrs. OTTO knows many people in the Pasadena area who are acquainted with the SIRHANS. Mrs. OTTO also furnished following additional information to DE LOSH:

She said that SENATOR FULBRIGHT will be the next victim of an assassination attempt. DE LOSH is unaware of the basis for her statement in that regard. However, he said that Mrs. OTTO told Dr. ROBERT NARA, a dentist, on 5/31/68, that SENATOR ROBERT KENNEDY would be killed. On the night of the assassination she was watching TV, and when her husband told her that she should go to bed she said she wanted to continue to watch, ~~as~~ she felt that KENNEDY was going to be killed. Mrs. OTTO has furnished information to FULBRIGHT's office concerning her "prophecy" of h~~b~~ having been slated for assassination.

Mrs. DE LOSH said that JACK RUBY's brother comes to Houghton, Michigan every 6 weeks, in connection with some business in which he is engaged. (Significance of above not known by DE LOSH).

DE LOSH indicated to Mrs. OTTO that the F.B.I. might wish to talk with her, and she said she was frightened. She said that if she is contacted that she does not want the local Police Department notified that she is being contacted, or notified of above information.

DE LOSH said Mrs. OTTO is a highly intelligent person of Armenian background, and that he did not regard her as being mentally disturbed.

Above furnished to SA WILLIAM J. NOLAN by telephone for purposes of setting out lead to have Mrs. OTTO interviewed.

On 12/12/68, Lt. ROY KEENE, LAPD, SUS Unit, advised Attorney GRANT C. COOPER, one of three attorneys representing SIRHAN BISHARA SIRHAN, had presented to the District Attorney's (DA's) Office a letter setting forth 16 items which he desired in addition to that information previously furnished to him.

On 12/13/68, a meeting was held between representatives of the Los Angeles Police Department, Los Angeles County DA's Office, U. S. Attorney's Office, and the Los Angeles Division. At that meeting it was the stated intention of the DA's Office to refuse to make available to COOPER those items requested in the letter. Deputy Los Angeles County District Attorney JOHN HOWARD, however, advised that in all probability Superior Court Judge HERBERT V. WALKER would order those items be made available to COOPER in the event COOPER appeared before him formally requesting the.

On 12/23/68, COOPER appeared before Superior Court Judge WALKER at which time JOHN HOWARD representing the Los Angeles County DA's Office was present. At that time, COOPER made formal demand upon the DA's Office for the items desired under the California Law of Discovery. Judge WALKER granted the motion ordering those items turned over to COOPER. The DA's Office immediately complied with the court order.





The investigation of the Senator Robert F. Kennedy assassination has been distinguished by a mutual and parallel undertaking on the part of this Department and personnel of the Federal Bureau of Investigation. This duplication of effort by our two agencies has resulted in a completed investigation painstakingly thorough and accurate to a degree commensurate with the historical significance of the incident.

Criminalists from the Los Angeles Police Department made the necessary examinations and conducted the related analyses of all the physical evidence connected with the case. Desiring to maintain the highest level of integrity in every phase of the investigation, the Chief of Police and the District Attorney agree that a back-up analysis by personnel of your agency would obviously strengthen this phase of the investigation. A separate and independent analysis would be of value in later refuting any claims attacking the validity of the examination by a single department and should preclude disputes or frivolous complaints.

If such an analysis can be made by your agency, the District Attorney recommends that in the interest of preserving the control and continuity of evidence that it be done at the Los Angeles Police Department, using our laboratory facilities and equipment as required.

Enclosed herewith is a letter received from ROBERT A. HOUGHTON, Deputy Chief of Police, Los Angeles Police Department (LAPD), in connection with the captioned case.

In connection with the enclosed letter, it was ascertained on a confidential basis from Deputy Chief ROBERT A. HOUGHTON that all of the ballistics examinations have been conducted for the LAPD by Officer DE WAYNE WOLFER of their Scientific Investigative Division. WOLFER also testified before the Los Angeles County Grand Jury in securing the indictment of SIRHAN B. SIRHAN. According to Deputy Chief HOUGHTON, in a comparatively recent murder case involving former Deputy District Attorney JACK KIRSCHKE of Los Angeles wherein KIRSCHKE was found guilty of the murder of his wife and her paramour, WOLFER also furnished the testimony concerning ballistics examinations that was one of the major factors in the conviction of KIRSCHKE. HOUGHTON advised that it was learned on an extremely confidential basis that a petition for a writ of habeas corpus will be filed in the KIRSCHKE case some time within the next thirty days wherein the validity of WOLFER's ballistics examination will be subject to attack. It is for this reason that the LAPD and District Attorney's Office desire that independent examinations be conducted in order to back up the testimony of Officer WOLFER. Deputy Chief HOUGHTON further advised that should the FBI not be in a position to

conduct these examinations, it is possible that the Los Angeles County Sheriff's Office could handle the ballistics examination.

The current policy of the Bureau with regard to conducting examinations of material already handled by other experts was explained to Deputy Chief HOUGHTON and to the District Attorney's Office. However, they requested that this matter be referred to our Washington headquarters for consideration.

The trial of SIRHAN B. SIRHAN entered into its preliminary stages as of 1/7/69 and at the present time is engaged in the filing and hearing of motions on the part of the Defense.

It is recommended that, in view of the trial being under way and the long-standing policy of the FBI Laboratory concerning examinations, and also that there is little or nothing to be gained for the FBI in conducting these examinations, the District Attorney and the LAPD be advised that these examinations cannot be conducted.

It should be noted that the information concerning Officer WOLFER's ballistics examination being attacked in the KIRSCHKE case is a matter of extreme confidence within the District Attorney's Office at Los Angeles.

The Bureau is requested to advise at the earliest possible time.

In accordance with information previously received regarding former SA WILLIAM R. TURNER, as set forth in reairtel, the writer has continued to follow this aspect of captioned investigation.

On 1/6/69 Captain HUGH BROWN, Commander, Homicide Bureau, Los Angeles Police Department (LAPD), who has also been coordinating the investigation of the assassination of the late ROBERT F. KENNEDY for the LAPD, was contacted. BROWN advised that his Department has conducted no investigation regarding TURNER, nor have they received any information regarding him since the LAPD received a tape recorded interview of JERRY OWEN conducted by TURNER, as set forth in reairtel.

On 1/8/69 Deputy Los Angeles County District Attorney DAVID FITTS, one of the three-man prosecutive team responsible for the prosecution of SIRHAN, was contacted regarding TURNER. FITTS explained his office has received no information concerning TURNER, and he is aware of no investigation being conducted with respect to him other than that previously having come to the attention of the LAPD concerning TURNER's interview of OWEN.

On 1/9/69 Lieutenants CHARLES HIGBIE and ROY KEENE, both of whom have been assigned to the special unit investigating the KENNEDY assassination for the LAPD, advised that nothing has come to their attention concerning TURNER since receipt of the taped interview of OWEN.

KEENE continues to remain active in the investigation being conducted by the LAPD and stated any information concerning TURNER would necessarily have to come to his attention. Likewise,


