Reference is made to Chicago memorandum dated January 20, 1967, concerning instant matter.

On January 24, 1967, CG T-1, who has furnished reliable information in the past, furnished the following information relating to Wayne Sparks which she recently learned:

Sparks indicated recently to close friends that he has a pistol or revolver that he keeps in his car. He did not identify the type, caliber or make of firearm. Sparks stated that he does not carry the gun on his person because that would be against the law. Sparks advised that he felt everyone should have access to a gun in case "somebody tries to give trouble."

Sparks further advised that he has resided in Chicago for eight years having formerly lived in a small town in western Massachusetts. Sparks advised that prior to living in Massachusetts he had resided with his family in Jeffersonville, Indiana.

WAYNE SPARKS; THREAT TO KILL U.S. SENATOR ROBERT F. KENNEDY MADE ON JANUARY 14, 1967

Sparks reportedly told his close friends that the "Kennedys" control Massachusetts because of their immense wealth. He also stated that he has a dislike for all the "Kennedys". He indicated the "power of the Kennedys" is sickening.

Sparks related that he is a racing car enthusiast and has been arrested on a number of occasions in the state of Illinois as well as the state of Indiana for speeding.

CG T-2, who has furnished reliable information in the past, advised on January 24, 1967 that Wayne Sparks wife's name is Frances and resides with him at 6128 South Morgan Street, Chicago, Illinois. Wayne Sparks is currently employed as a "dispatcher" for the Lion Match Corporation, 3433 West 48th Place, Chicago, Illinois. CG T-2 related that Sparks' mother, his sister, Jane, and brother Charles reside at 3440 South Morgan Street, Chicago, Illinois. Richard Sparks and Wesley Sparks also brothers of Wayne Sparks currently reside in Chicago.

Records of the Traffic Control Divisiom, Chicago Police Department, Chicago, Illinois as checked on January 24, 1967 reflect the following information which pertains to Wayne Sparks, who was born on January 17, 1944.

Sparks resides at 3440 South Morgan, Chicago, Illinois has Illinois driver's license S 162-8924-4048, which is scheduled to expire on February 17, 1968. Sparks has Social Security Number is 5' 10", weighs 136 pounds, brown hair and has hazel eyes.

AT INDIANAPOLIS, INDIANA. Will check indices for any information relating to WAYNE SPARKS.

AT JEFFERSONVILLE, INDIANA. 1. Will check appropriate sources in an effort to ascertain whether WAYNE SPARKS was born at Jeffersonville, Indiana or elsewhere in the state.

2. Will through established sources only attempt to obtain additional data relating to WAYNE SPARKS.

For Indianapolis information, WAYNE SPARKS has been associated with the NSRP at Chicago and reportedly is acquainted with one RICHARD GRANT, also an NSRP member, who recently moved from Chicago to Jeffersonville, Indiana.



At 1:10 p.m. on January 17, 1967, CG T-1, who has furnished reliable information in the past, advised the following at Chicago, Illinois:

Rights Party (NSRP) was held at the headquarters at 2237 North Western Avenue, on January 14, 1967.

At this meeting Wayne Sparks, a member of the NSRP, stated the following in the presence of five persons who were in attendance:

"It looks certain Bobby Kennedy will become President of the United States in 1968 or certainly 1972. I would like to assassinate Bobby Kennedy and would do it, regardless of what would happen to me if I thought I would be successful. Bobby Kennedy is all wrong and represents everything I hate."

CG T-1 stated Sparks has indicated opposition to anyone he believes is for integration or equality of races.

A characterization of the NSRP is attached hereto as an appendix.

WAYNE SPARKS; (RACIAL MATTERS - ORGANIZATION) THREAT TO KILL UNITED STATES SENATOR ROBERT F. KENNEDY MADE ON JANUARY 14, 1967

CG T-1 advised on January 17, 1967, that Sparks resides at 6128 South Major Street, Chicago, Illinois, and reportedly is employed as a laborer for Lion Match Corporation, 3433 West 48th Place, Chicago, Illinois. CG T-1 describes Sparks as being in his early 20s, of the white race, 5'8" tall, 140 pounds and resides with his wife. CG T-1 further advised that Sparks is not known to have any firearms.

On January 17, 1967, Miss Barbara Fazio, Personnel Manager, Lion Match Corporation, 3433 West 48th Place, Chicago, Illinois, advised that records available to her reflects one Wayne L. Sparks who was born on February 17, 1944, is currently employed by the Lion Match Corporation at 3433 West 48th Place, Chicago, Illinois. Miss Fazio stated Sparks commenced employment on April 8, 1964, and has worked continuously for Lion Match Corporation since that date to the present time. She related that his office title would be that of "dispatcher." She further advised that Sparks reportedly is married and resides with his wife at 3440 South Morgan Street, Chicago, Illinois, having formerly lived at 3315 South Morgan Street, Chicago, Illinois. Sparks according to Miss Fazio works Monday through Fridays from 7:45 a.m. until 4:15 p.m.

On December 27, 1966, James Tabor, Supervisor, Auto Registration Section, Secretary of States Office, Springfield, Illinois, advised that a check of records available to him failed to reflect any license being issued to Wayne Sparks, with address of 6128 South Major Street, Chicago, Illinois. Tabor indicated that their records reflect one Wayne L. Sparks, 3440 South Morgan Street, Chicago, Illinois, was issued a 1966 Illinois license plate, number RF 7570 which was issued on February 18, 1966. Tabor stated this license was issued for a 1962 Buck, two-door, hard-top, VIN 411 054 859.

WAYNE SPARKS; (RACIAL MATTERS - ORGANIZATION) THREAT TO KILL UNITED STATES SENATOR ROBERT F. KENNEDY MADE ON JANUARY 14, 1967

On December 28, and 29, 1966, Bill Logan, Supervisor, Drivers License Section, Secretary of States Office, Springfield, Illinois, advised that their records do not reflect any Illinois drivers license as having been issued to a Wayne Sparks with an address of 6128 South Major Street or 4728 South Hermitage Street, Chicago, Illinois. Logan was unable to locate an Illinois drivers license for anyone with the name Wayne Sparks of Chicago, Illinois.

CG T-1 referred to above also advised on January 17, 1967, that Sparks has been attending NSRP meetings at Chicago since the summer of 1966, to the present time.

CG T-2, who has furnished reliable information in the past, advised on August 16, 1966, that one Parkie Scott, who he described as an Ohio organizer for the National Knights of the Ku Klux Klan, Inc., (NKKKK) was in Chicago on August 13, 1966, with several of his associates. CG T-2 indicated Scott and his associates met with several individuals at Chicago who were identified as members of Chicago Branch of the NSRP. Included in this group was Wayne Sparks, 6128 South Major Street, Chicago, Illinois, telephone number 581-2633.

Public records of the Illinois Bell Telephone Company at Chicago, Illinois, as checked on January 18, 1967, reflect that telephone number 581-2633 is currently listed to Wayne L. Sparks at 3440 South Morgan Street, Chicago, Illinois.

CG T-2, referred to above, further advised on August 16, 1966, that Parkie Scott and several of his associates contemplated returning to the Chicago area over the weekend of August 20-21, 1966, for the purpose of either holding a klan rally or demonstration against the recent and future planned marches by Negroes in that city.

A characterization of the NKKKK is attached hereto in the appendix section of this memorandum.

WAYNE SPARKS; (RACIAL MATTERS - ORGANIZATION) THREAT TO KILL UNITED STATES SENATOR ROBERT F. KENNEDY MADE ON JANUARY 14, 1967

On September 14, 1966, CG T-3, who has furnished insufficient information to determine his reliability, advised he is employed at the Lion Match Corporation of America, 3433 West 48th Place, Chicago, Illinois, and first became interested in the NSRP through the efforts of Wayne Sparks, who was also employed by Lion Match Corporation of America.

CG T-3 advised that Wayne Sparks has a brother, Richard Sparks, who reportedly is interested in the activities of the NSRP.

CG T-3 advised that Richard Sparks resides at 922 West 35th Place, Chicago, Illinois, having telephone number FR 6-3834 and reportedly works for a Ford Motor Agency in Chicago.

Sergeant Robert Baker, Intelligence Division, Chicago Police Department, Chicago, Illinois, advised on January 17, 1967, that a check of Police Department records at Chicago, Illinois, failed to reflect any information that could be associated with Wayne Sparks, described above.

CG T-4, an individual with whom insufficient contact has been had to establish his reliability, advised on January 17, 1967, that he is employed by a private organization at Chicago, Illinois, which is acquainted with some individuals who are active in the MSRP at Chicago as well as similar-type organizations. CG T-4 advised that he does not have any information relating to any individual with the name Wayne Sparks, as described above.

A source advised on February 8, 1966, that the Chicago branch of the National States Rights Party (NSRP) is located at the NSRP National Bookshop at 2237 North Western Avenue, Chicago, Illinois. The Chicago branch of the NSRP was officially opened on December 29, 1965, when Dr. EDWARD R. FIELDS, National Director of the NSRP, spoke at a rally held at 2237 North Western Avenue, Chicago.

The above source also advised that the National Office of the NSRP is located at Augusta, Georgia, and the Chicago branch of the NSRP subscribes to the policies of the National Office of the NSRP. The NSRP believes that there should not be race mixing between whites and Negroes and that Negroes in the United States by conducting demonstrations and causing riots are causing a breakdown of law and order in the United States. The NSRP believes that the Jews and the Negroes should be exposed in their attempts to have integration between whites and Negroes.

A second source advised on July 26, 1966, that the Chicago branch of the NSRP continues to be located at 2237 North Western Avenue, Chicago.

# NATIONAL STATES RIGHTS PARTY (NSEP)

On November 26, 1957, a source advised that the United White Party (UWP) was organized at a convertion held in Knowville, Tennessee, on November 10, 1957. An article in the November 16, 1957, issue of the "Greenville Piedmont," a newspaper of Greenville, North Carolina, reported "the recent formation of a new political party, to be known as the United White Party. According to the article, the party was formed at a recently held meeting in Knoxville, Tennessee, at which many Klansmon were represented. The UWP was reported as being opposed to all "race mixing organizations and individuals."

The July, 1958, issue of "The Thunderbolt," self-described as the "official Racial Mationalist Organ of the National States Rights Party" (NSRP), reported that rank and file "States Righters" had merged with the UTP under "the banner of the National States Rights Party," with national offices at Post Office Box 261, Jeffersonville, Indiana.

In November, 1958, a source advised that the MSNP is composed of past members of Klan-type organizations and notorious anti-Semites.

Issue No. 19, dated June, 1960, of "The Thunderbolt" announced the address of the headquarters of the MSDP had been changed from Jeffersonville, Indiana, to Post Office Box 785, Birmingham, Alabama.

Issue No. 69, dated July, 1965, of "The Thanderbolt" announced the address of the new headquarters of the MSRP as Post Office Box 184, Augusta, Georgia.

On August 4, 1965, a source advised that ADWARD R. FIELDS, the Information Director of the HSRP and Editor of "The Thunderbolt," is the individual who actually controls the MSRP.

Issue No. 72, dated November, 1988, of 'The Thunderbolt' reflects Dr. EDWARD R. FIELDS to be Vational Director of the NSRP as well as Editor of 'The Thunderbolt."

"The Thunderbolt" continues to publish articles attacking Negroes and persons of the Jewish faith.

# APPENDIX

NATIONAL KNIGHTS OF THE KU KLUX KTAN, INC. (NKKKK)

A source advised that on May 22, 1960, the National Grand Council of the Knights of the Ku Klux Klan met at Atlanta, Georgia, to discuss consolidation of the Klan's unity of effort and activities to establish a National Fund, and a National Secretary, and to design a new flag. The meeting was attended by representatives of the Federation of Ku Klux Klan, Alabama; Association of the Ku Klux Klan, Florida; Southern Knights of the Ku Klux Klan, Florida; Association of Georgia Klans, Georgia; Knights of the Ku Klux Klan, North Carolina; Association of South Carolina Klans, South Carolina; Dixie Knights of the Ku Klux Klan, Tennessee; and Kyksos Klan, Texas.

This source advised that at a consolidation meeting at Atlanta, Georgia, September 2-5, 1960, at which the North Carolina and Texas Klans were not represented, it was resolved and passed that their name be changed to National Ku Klux Klan.

A second source advised in March, 1964, that several meetings of Klan groups were held during the period 1960 to 1963 in an effort to unite the Klan groups under a single leadership.

The organization was granted a charter in DeKalb County, Georgia, November 1, 1963, under the name National Knights of the Ku Klux Klan, Inc., as a "patriotic, secret, social, and benevolent order."

Reference is made to Chicago memoranda, dated January 20, and January 25, 1967, concerning instant matter.

On February 10, 1967, CG T-1, who has furnished reliable information in the past, advised that Wayne Sparks was interviewed by members of the Chicago Police Department, Chicago, Illinois, and denied ownership of any firearms. CG T-1 stated he had learned Sparks indicated to Chicago police officers that he is against taking human life under any circumstances, unless it would be in direct defense of his own life or as a member of the Armed Forces.

On March 23, 1967, Lieutenant Francis O'Malley, Detective Division, Area 3, Chicago, Illinois Police Department, advised that he, with other Chicago police officers, interviewed Wayne Sparks at his place of employment on February 6, 1967. O'Malley advised that Sparks admitted belonging to the National States Rights Party (NSRP), Chicago, Illinois.

A characterization of the NSRP is attached hereto as an appendix.

Sources utilized in the characterization of NSRP have furnished reliable information in the past.

Lieutenant O'Malley stated that Sparks indicated the NSRP was anti-communist and opposed to integration of the races.

Sparks indicated, according to Lieutenant O'Malley, that he did not hate Bobby Kennedy, but was opposed to his political beliefs.

Lieutenant O'Malley further advised that Sparks denied ever having made a statement threatening the life of Senator Robert F. Kennedy.

Lieutenant O'Malley stated that Sparks indicated that he is against taking human life and would not do so unless as a member of the Armed Forces which would be necessary or in defense of his own life.

Lieutenant O'Malley stated that Sparks indicated he does not own any firearms at the present time, but that while in high school, he had a starter's pistol, but gave the pistol to another student at the time of his graduation. Lieutenant O'Malley advised that, with Sparks' permission, his vehicle was searched and no weapons were found.

Lieutenant O'Malley stated that Wayne Sparks indicated he is presently separated from his wife, Frances Sparks, and currently resides at 6128 South Major Street, Chicago, Illinois, while his wife resides at 3440 South Morgan Street, Chicago, Illinois. Sparks stated he owns a 1962 Buick, two-door, hardtop, red in color, having motor serial number 411054859, and 1966 Illinois license plate RF 7570. Sparks advised Lieutenant O'Malley that he has tried to enlist in the Armed Forces, but has been rejected for physical reasons.

On February 20, 1967, CG T-2, who furnished reliable information in the past, advised that Wayne Sparks attended a meeting of the Chicago Branch of the NSRP, which was held on February 18, 1967, at 2237 North Western Avenue, Chicago, Illinois.

CG T-2 advised that Sparks was present when it was stated at this NSRP meeting that the Chicago police had interrogated Wayne Sparks concerning his feelings toward Senator Kennedy. It was indicated the belief that someone at Sparks' place of employment may have informed the police of Sparks' feelings about Senator Kennedy.

According to CG T-2, Sparks did not indicate any additional information concerning his contact by the Chicago Police Department.

SPARKS SHOULD BE CONSIDERED ARMED AND POSSIBLY DANGEROUS IN VIEW OF ALLEGATION THAT HE OWNS A FIREARM.

#### DETAILS:

Investigation in this matter was predicated upon information received from CG T-1, on August 16, 1966, reflecting WAYNE SPARKS, 6128 South Major Street, Chicago, Illinois, telephone number 581-2633, met PARKIE SCOTT, National Knights of the Ku Klux Klan (NK KKK), Incorporated, Organizer for the State of Ohio, on August 13, 1966, at Chicago, Illinois.

CG T-1 advised on August 16, 1966, that SPARKS was described as a follower or member of the National States Rights Party (NSRP), Chicago Branch, at Chicago, Illinois.

A characterization of the NK KKK and USRP are hereinafter attached in the Appendix Section.

## I. BACKGROUND

### Birth Data

On February 7, 1967, Mrs. ARLENE NOLAN, Bureau of Vital Statistics, Indianapolis, Indiana, advised records available to her reflect one WAYNE LEE SPARKS was born February 17, 1944, at Jeffersonville, Indiana. His father's name was listed as JOHN WESLEY SPARKS and his mother's maiden name was BESSIE DUNN.

#### Residence

On March 23, 1967, Lieutenant FRANCIS O'MALLEY, Detective Division, Area Three Police Department, Chicago, Illinois, advised WAYNE LEE SPARKS, who was born on February 17, 1944, at Jeffersonville, Indiana, was interviewed and furnished the following information relative to his residence on February 6, 1967.

SPARKS advised that he currently resides at 6128 South Major Street, Chicago, Illinois. He advised that his wife, FRANCES SPARKS, from whom he is separated, currently resides at 3440 South Morgan Street, Chicago, Illinois.

On June 14, 1967, CG T-2 advised WAYNE SPARKS continues to reside at 6128 South Major Street, Chicago, Illinois.

CG T-2 advised on January 24, 1967, that WAYNE SPARKS had indicated that he had resided in Chicago, Illinois, for eight years and he formerly lived in a small town in western Massachusetts. According to CG T-2, SPARKS indicated that prior to living in Massachusetts, he had resided with his family in Jeffersonville. Indiana.

## **Employment**

On January 24, 1967, CG T-3, advised that WAYNE SPARKS was employed at that time as a "dispatcher" for the Lion Match Corporation, 3433 West 48th Place, Chicago, Illinois.

On January 17, 1967, Miss BARBARA FAZIO, Personnel Manager, Lion Match Corporation, 3433 West 48th Place, Chicago, Illinois, advised that one WAYNE LEE SPARKS, who was born on February 17, 1944, was currently employed by the Lion Match Corporation, at 3433 West 48th Place, Chicago, Illinois.

Miss FAZIO stated SPARKS commenced employment on April 8, 1964, and has worked continuously for Lion Match Corporation since that date. She related that his office title would be that of "dispatcher."

Miss FAZIO related that SPARKS allegedly resides with his wife at 3440 South Morgan Street, Chicago. According to Miss FAZIO, SPARKS works five days a week (Monday through Friday) from 7:45 a.m. until 4:15 p.m.

On June 14, 1967, Miss FAZIO advised SPARKS continues his employment at Lion Match Corporation in the same capacity and on the same schedule as described above.

#### Military Status

SPARKS advised Lieutenant FRANCIS O'MALLEY, Police Department, Chicago, Illinois, on February 6, 1967, that he had attempted to enlist in the United States Armed Forces but has been rejected for physical reasons which he did not disclose.

## II. CONNECTIONS WITH HATE TYPE ORGANIZATIONS

Affiliation with National States Rights Party (NSRP)

WAYNE LEE SPARKS has been attending NSRP meetings at Chicago, Illinois, since the summer of 1966 through February 18, 1967, when regularly scheduled meetings of the NSRP in Chicago ceased.

(CG T-2, 1/17/67) (CG T-2, 2/20/67)

#### PARKIE SCOTT

PARKIE SCOTT, Ohio Organizer for the National Knights of the Ku Klux Klan, Incorporated, was in Chicago with several of his associates and met several individuals from Chicago who were identified as members of the Chicago Branch of the NSRP.

Included in this group was WAYNE SPARKS, 6128 South Major Street, Chicago, Illinois, telephone number 581-2633.

(CG T-1, 8/16/66)

Public records of the Illinois Bell Telephone Company at Chicago, Illinois, reflect that telephone number 581-2633, is currently listed to WAYNE L. SPARKS at 3440 South Morgan Street, Chicago, Illinois, and was so listed on August 16, 1966.

#### Automobile and Drivers License

On December 27, 1966, JAMES TABOR, Supervisor, Auto Registration Section, Secretary of State's Office, Springfield, Illinois, advised that a check of records available to him failed to reflect any license being issued to WAYNE SPARKS with address of 6128 South Major Street, Chicago, Illinois. TABOR indicated that his records reflected one WAYNE L. SPARKS, 3440 South Morgan Street, Chicago, Illinois, was issued a 1966 Illinois license plate number RF 7570, which was issued on February 18, 1966. TABOR stated this license was issued for a 1962 Buick, two door hardtop, VIN 411 054 859.

Records of the Traffic Control Division, Police Department, Chicago, Illinois, as checked on January 24, 1967, reflect the following information which pertains to WAYNE SPARKS, who was born on February 17, 1944. SPARKS resides at 3440 South Morgan Street, Chicago, Illinois, and has Illinois Driver's License Number S 162 8924-4048, which is scheduled to expire on February 17, 1968.

On March 23, 1967, WAYNE SPARKS advised Lieutenant FRANCIS O'MALLEY, Police Department, Chicago, Illinois, that he owned a 1962 Buick, two door, hard top, red in color

having Motor Serial Number 411 054 859. SPARKS indicated his 1966 Illinois license plate number was RF 7570.

On June 7, 1967, CG T-2 advised that he had learned that WAYNE SPARKS had sold his 1962 Buick to one of his friends, and was currently attempting to obtain a newer vehicle.

#### Activities of Subject

A meeting of the Chicago Branch of the NSRP was held at the NSRP headquarters at 2237 North Western Avenue, Chicago, Illinois, on January 14, 1967.

(CG T-2, 1/17/67)

At the meeting of NSRP at Chicago on January 14, 1967, WAYNE SPARKS, a member of the NSRP, stated the following in the presence of five persons who were in attendance:

"It looks certain Bobby Kennedy will become president of the United States in 1968 or certainly 1972. I would like to assassinate Bobby Kennedy and would do it, regardless of what would happen to me if I thought I would be successful. Bobby Kennedy is all wrong and represents everything I hate."

(CG T-2), 1/17/67)

SPARKS has indicated opposition to anyone he believes is for integration or equality of races.

(CG T-2, 1/17/67)

SPARKS indicated recently to close friends that he had a pistol or revolver that he keeps in his car. SPARKS did not identify the type or make of firearm. SPARKS stated that he does not carry the gun on his person because that would be against the law. SPARKS advised that he felt everyone should have access to a gun in case "somebody tries to give trouble."

(CG T-2, 1/24/67)

SPARKS reportedly recently told his close friends that the "KENNEDYS" controlled Massachusetts because of their immense wealth. SPARKS also stated that he has a dislike for all the "KENNEDYS." SPARKS indicated the "power of the KENNEDYS" is sickening.

(CG T-2, 1/24/67)

SPARKS was interviewed by members of the Chicago Police Department, Chicago, Illinois, on February 6, 1967, at which time he denied ownership of any firearms. SPARKS indicated to Chicago Police Officers that he is opposed to taking human life under any circumstances unless it would be in direct defense of his own life or as a member of the armed forces.

(CG T-2, 2/10/67)

On March 23, 1967, Lieutenant FRANCIS O'MALLEY, Detective Division, Police Department, Chicago, Illinois, advised that he, with other Chicago Police Officers interviewed WAYNE LEE SPARKS at his place of employment on February 6, 1967, at which time SPARKS furnished the following information:

SPARKS indicated that he was a member of the NSRP at Chicago, Illinois. SPARKS stated the NSRP was anti-Communist and opposed integration of the races.
