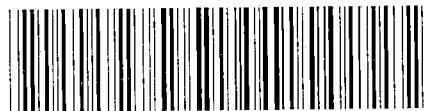

INFORMATION CONCERNING

On 4-3-68, efforts were made to contact Captain JOSEPH AHERN, Director, Division of Subversive Activities, Massachusetts State Police, State House, Boston, Mass., concerning the captioned matter. He was not at his office and in his absence JANET KEATING, secretary, was notified of this threat against Senator KENNEDY. Subsequently, Captain AHERN contacted the writer and was furnished substantially the same information given to Miss KEATING. Later Captain AHERN advised that he had determined there was no record on VAN BUSKIRK with the Office of the Mass. Commissioner of Probation, Boston, Mass.

He had further ascertained that VAN BUSKIRK has a gun permit under A84460 with the North Andover, Mass. Police Department. This permit was issued in April, 1966, and expires 4-25-68.

On April 3, 1968, Robert Graffum, Security Officer, Raytheon Company, Lowell Street, Andover, Massachusetts, advised an employee at that plant made an anonymous telephone call from within the plant and furnished the following information which may or may not be true.

Carl Blanchard VanBuskirk is an employee at the Raytheon Company, Lowell Street, Andover, Massachusetts. For the past two or three weeks, VanBuskirk has been making abusive and derogatory comments concerning the family of the late President of the United States, John Fitzgerald Kennedy. VanBuskirk has made statements to the effect that the best thing that ever happened was the assassination of John Fitzgerald Kennedy and they ought to get rid of the whole Kennedy family. VanBuskirk is a member of the National Rifle Association. He loads his own ammunition and he recently said he was going to go home and load up some bullets and carve Robert F. Kennedy in them. VanBuskirk has never made a flat statement he was going to kill any members of the Kennedy family and he does not know if VanBuskirk is sincere or serious about the other statements he has made.

**CARLTON BLANCHARD VAN BUSKIRK, Also Known As
Carl Blanchard Van Buskirk;
SENATOR ROBERT F. KENNEDY - VICTIM**

The Boston Office of the Federal Bureau of Investigation advised that Robert Graffum, Security Officer, Raytheon Company, Andover, Massachusetts, advised that he received a telephone call from an anonymous male from within the Raytheon plant. The anonymous caller stated that Buskirk, an employee at Raytheon Company, made statements to his fellow employees for the past two or three weeks to the effect that the best thing that ever happened was the assassination of John Fitzgerald Kennedy, and that they ought to get rid of the whole Kennedy family. Graffum advised that the United States Air Force has security cognizance for the Raytheon plant.

Buskirk is a member of the National Rifle Association, loads his own ammunition, and recently stated that he was going to load up some bullets and carve Robert Francis Kennedy's initials on them.

Buskirk was born April 25, 1930, at North Andover, Massachusetts. He served in the United States Army from 1952 to 1954, Serial Number US21284124. Buskirk resides at 160 Water Street, North Andover, Massachusetts, and is employed at the Raytheon plant as an inspector and tester with a confidential clearance.
