Communism is using new techniques in foreign warfare which is kill yourselves as for example what happened in East and West American soldiers were killed and not one American soldier's blood was shed.

We thank you for giving this matter the greatest consideration hoping that you will be against the aggressors (Zionists) for the sake of justice and the world peace, thank you.
