



Subject to go to United States of America. On 26 March 1965, Subject immigrated to America. He entered New York City as an immigrent and was issued Immigration Registration Certificate No.

Naturalization Service (Annex "I"). Then he came to the United States, he was a holder of Passport No. of the Republic of Arak of Yemen.

From New York City, Subjecttransferred his residence to San Francisco, California. He was employed is a seamen with the Texco Shipping Company, making trips clong the eastern coast of United States, including the cities of San Francisco and Los ingeles, California and Seattle, Washington, is far as New Orlian, Lupisiana. He He resigned from the said company and got an employment with the U.S. Merchant Marine Lines in San Francisco. He was a worker in the engine from of "SS Coscas Pock Three" of the said lines, bringing army supplies from United States to Victnam. Said ship passes by either Olongapo City or Subic Bay, Philippines, for replenishment of oil and water supplies.

On 2 August 1963, said ship left San Francisco, Californie for her third trip to Vistnam. It arrived at Olongapo City on 23 August 1968 for provisions. Thile the said ship was docked at Olongapo City. Subject had a quarrel with some members of the crew. Subject was accused or suspected by the American crew members of the said ship of having something to do with the assassingtion of San. Robert Kannady because he is a Yemenite and a resident of San Francisco, California. The accused killerof Sen. Kennedy is also from Yemen. During the said incident, the chief cook and an oiler of the said ship tried to stab Subject with a knife. Subject, however, was able to parry the knife (Subject showed these Agents the scars on his fingers as the result of the reid thrust) and dave into the sea. He was later picked up by the Philippine Coest Guards and some Americans from Subje Bay. He was given first aid treatment at the base hospital and later transferred to the Vedical Center in Manile for observation and further treetment.

While Subject was on a six-hour pass from the hospital allegedly to report to the Burcau of Immigration, Anila, he met three unidentified Muslims who invited him for a drink in one of the bars. From there, the proceeded to a bar at the Manila Domestic Ariport where they continued drinking. Subject claimed that after drinking with the Muslims, he felt dizzy and later lost consciousness. According to Subject, when he woke up the following morring, he was already in Iligan City.

From Ilijan City, Subject proceeded to Merzwi City. He stayed for three months at the house of a cartain Madji Ilawi in Marzwi. City, While in Marzwi City, he was introduced by Madji llewi to the people of Marawi City and Malabang, Lanao del Sur, that he is a muslim priest. Because Subject is not really a Muslim but a Jew, he did not like the idea and requested H dji Alawi and even Commissioner Temeno of the Bureau of National Integration to oring him to the American Embassy in Manile.

When Subject insisted to go to Manila, he was maltreated by Muslims in Marawi City. On 10 December turned over to the PC authorities at 1968, he was Camp Evangelista, Cagayan de Oro City for interro-gation. Subject was later turned over to the Bureau of Immigration, Cagayan de Oro City for further disposition. Subject is now detained at the City Jail, Cagayan de Oro City.

Several papers and documents were found in the person of herein Subject (Innex "C"). These papers are now in the possession of the Bureau of Immigration Officer, Cagayan de Oro City for safe-keeping.

Subject is an applicant for American Citizenship in San Francisco, California (Annex "D"). He is also a holder of a temporary driver's license in the state of California (Annex "E"). No CA No cumeil areat Subject's photograph and fingerprint chart are files,

His sworn statement dated 13 December 1968 aller that given to these Agents is also enclosed in this report (Annez "H"). A personal letter wonitt report (Annex "H"). A personal letter written in Arabic, found in the possession of Subject is also attached in this report as Annex "J".

Subject speaks and knows very little inglish. There was a great difficulty in interrogating said Subject even with the help of a Lebeness interpre-ter. Subject expressed bitterness over the way he was treated by the local authorities and the Bureau of immigration officials. We claimed that he lost all his money ( dollars and Fhilippine pesos) while he was deteined in Marawi City. He also exhibited to these igents the wounds in-flicted on his head and face while he was under detention.

Thile there is truth on the origin of herein Subject and the circumstances surrounding his entry into the Philippines, these Agents expressed some doubts as to the real reason why and how he was brought to Lenao. There is no way, however, in establishing the real purpose why he came to Iligan City and stayed in Marawi City for three months without reporting to the proper authorities.

## Subject: ALI ALI ACHNED SAID - page four -

As to the elligation that Subject has something to do with the assessination of Sen. Robert Kennedy, there is no evidence gathered in the course of investigation, to link Subject to the swid killing. This claim is only based on the fact that Subject is a Yemenite and a resident of San Francisco, California. But Subject in his sworn statement given bo these Agents claimed that he was aboard a ship from Vietnam somewhere in Panama during the time of said assassination. This needs varification with the American auth rities to determine the veracity of this claim.

The personal letter written in Arabic found in the person of herein Subject should be submitted to translation to determine the contents of the same. This may be a good source of information regarding Subject.

Subject could not produce any paper to show that his entry into the Philippines is lawful. He is now in the custody of the Bureau of Immigration, Cageyan de Oro City for final disposition. In a conference with Atty. Celso Liloc, Euraau of Immigration Officer, Cayayan de Oro City, it was disclosed that he has orders from the Commissioner of the Bureau of Immigration, Kanila to file corresponding charges against Subject for violation of Immigration Law, before the City Fiscal of Cageyan de Oro City. This case would be the basis of eventual deportation of Subject from the Philippines.

#### CONCLUSION:

Subject has unlawfully entered the Philippines. There is no ovidence, however, to link him in the essessination of Sen. Robert Kennedy.

#### RECOMMENDATION:

In view of the foregoing, it is respectfully recommended that this report be forwarded to the Assistant Director, Domestic Intelligence Division, this Bureau for his information and further action; and that this case be considered closed and termineted as far as this Region is concerned.

SUBJECT GRAB-BED THE CANERA AND DESTROYED THE FILM. THEN MANDANGAN ACOSTED HIN AND FOUND. THAT HE DID HOT HAVE ANY PASSPORT OR VISA. SUBJECT JAS BROUGHT TO MARAFI CITY IN SS TAKEN DOWN BY THE PC THICH HE ANSTERED IN BROKEN ENGLISH. SUBJECT CLAIMED TO HAVE PAPERS SHOTING HE IS A CREY MEMBER OF U. S. 



Q - Please state your name, age, occupation and other personal circumstances. - ALI ILI ACHMED SAID, born on 15 September 1933 at ANZAR, YEMEN, of ALI ACHMED NAMEH SAID, married to FAYZEH SAIDI, cleaner in the engine room of OSCAS F.T. U. S. Lines, San Francisco, California, United States of Americap 180 7th Street, Gan Francisco, California, Holder United States.

- 3 Q With whom are you staying in San Francisco, California? A I am renting a room there but I do not have any companion because I only stay there for one, two or phree weeks and then sail in our ship.
- 4 Q Where are your parents now? A They are already dead. They died in Yemen, in my country.
- 5 Q How about your wife, where is she now?
  - 1 Two children, HEZAM 12 years old and MAHALLIA 11 years and they are staying with my brother, MOHAMMAD ALI, in Temen.

5 - Q - How about your wife, where is she now?
A - FAYZEH SAIDI is also dead and she died three years ago.

8 - Q - What is your citizenship?


