

> Our Los Angeles Office advised that it has been determined that the owner of the 1958 Chrysler located by the police department in the area of the shooting is one Robert Jean Gindroz. This individual is a chef at the Ambassador Hotel and is definitely not the person who has been arrested by the police department. Gindroz was born on 1-5-32 in Switzerland. He is being interviewed by Bureau Agents and Los Angeles police officers to determine the circumstances under which the unidentified subject possessed a key to his car. The subject has been arraigned in Los Angeles on local charges - six counts to commit murder. He is being held under \$250,000 bond. At the time of his arrest, the subject had a small amount of loose change, one car key (for the previously-referred to 1958 Chrysler) and four \$100 bills, the serial numbers of which are being obtained so that they can be checked through NCIC.



Early this afternoon Larry Cummings in the office of Senator Birch Bayh of Indiana called to report a phone call he had just received from a Daniel Young, Route 1, Greencastle, Indiana, (code 317, telephone TE9-2665). Young indicated to Cummings that he thought he knew how the man who attempted to kill Senator Kennedy could be identified.

Young indicated that around 1961 (it was shortly before Raul Castro took a trip to Moscow) he saw a film on television showing Castro in Cuba dedicating some type of building. Castro introduced a man on the platform to the audience and Young recalls a resemblance between this man and the individual who shot Senator Kennedy early this morning. Young saw this film on a local television station in Indiana. He had no further specific information concerning the identity of the individual.

Mr. Cummings stated that Young appeared to be a middle age man and was rather excited.

John Hightower, host of the program "Controversy," on WFAN-TV, Channel 14, telephonically contacted my office and spoke to SA Bland. Hightower, who occasionally furnishes information which he feels to be of interest to the FBI, stated that on his program on the night of June 4th, the controversial New York attorney Mark Lane appeared as one of the guests. He stated that Lane commented critically, as he has consistently done in the past, of the Warren Commission report but in addition made the statement during the course of his comments "There are guns between Robert Kennedy and the White House."

Hightower stated that in view of the developments in the shooting of Robert Kennedy today he wanted the FBI to have this information. He said he did not know whether there was any significance in the statement. Hightower said that Lane is supposed to return as a guest to his program on WFAN-TV, Channel 14, during the program this evening, June 5th, between 7 and 10 p.m.

Lane is the New York Attorney who wrote "Rush to Judgment" which was highly critical of the Warren Commission report, the CIA, the FBI and the Secret Service. Of late, he has been associated with New Orleans District Attorney James Garrison in his so-called probe of the John F. Kennedy assassination.


