YEAR BEEN TO JORDAN WITH FATHER WHOM HE STATED WAS CONNECTED WITH A CONSULATE OR EMBASSY IN THE UNITED STATES. HE ALSO COMMENTED THAT HE SPENT THREE WEEKS IN JAIL WHILE IN JORDAN. DETAILS NOT REVEALED. KHALAF STATED WOULD BE IN ST. LOUIS SHORT TIME AND WAS LEAVING NIGHT OF JUNE THREE NEXT FOR CHICAGO AND THEN TO CALIF., EXACT LOCATION UNKNOWN. KHALAF PROVIDED NO REASON FOR TRIP, HOWEVER, STATED "SOMETHING BIG IS GOING TO HAPPEN WITHIN THE NEXT THREE DAYS".

WISE STATES KHALAF APPROXIMATELY TWENTYTWO OR TWENTYTHREE YEARS OF AGE, DOES NOT RECALL ANY ANTI-AMERICAN OR ANTI-KENNEDY REMARKS ON PART OF KHALAF, FURTHER DESCRIBED BY WISE AS BEING PROFICIENT IN FIVE OR SIX LANGUAGES. KHALAF ALSO INQUIRED WHETHER OR NOT WISE KNEW OF ANYONE DESIRING TO PURCHASE A LINCOLN CONTINENTAL MARK THREE AUTOMOBILE WHICH HE STATED HE WOULD SELL CHEAP AT EIGHTTHOUSAND DOLLARS.

MATTESON CURRENTLY EMPLOYED BY GREEN THUMB STABLES, LOS ANGELES. INTERVIEWS OF PERSONNEL THIS ESTABLISHMENT DETERMINED THEY HAD NEVER SEEN SIRHAN CONTACTING MATTESON. MATTESON CURRENTLY LIVES IN TACK ROOM NUMBER TWO, BARN NUMBER THREE AT HOLLYWOOD RACE TRACK.

KENSALT

This is to record as a matter of information the details concerning a telephone call which I received from the above-captioned individual at my home late last evening concerning the "Kensalt case," the case involving the assassination of Senator Robert F. Kennedy. Miss Shanahan, who was not previously known to me, in a very demanding, overbearing manner, advised me that during a press conference which Chief of Police Thomas Reddin of Los Angeles had on 6/5/68, he had made a statement to the effect that the Los Angeles police had checked with the FBI in Washington concerning possible membership of Sirhan Sirhan (the accused assassin) in any "subversive organizations." She also advised that Reddin had stated that a similar request had been made to the FBI concerning possible membership of Sirhan Sirhan in any "nationalist groups."

In a very demanding manner, Miss Shanahan stated she wished to know what information the FBI had in its files concerning possible membership of Sirhan Sirhan in such groups. I, naturally, told her I could not comment on this. She then demanded to know if the FBI maintains files on "nationalist groups" and if the FBI considers such groups as subversive. It was obvious from the manner in which she put her question that she did not feel that "nationalist groups" of any kind should be considered subversive and that she did not feel the FBI had any right in maintaining files on such groups. In answer to her question, I again told her that I could not comment. She then stated that she wished to have the comments of the FBI regarding the quality of the protection being given to Sirhan Sirhan by Los Angeles authorities. Again I told her that the FBI could not comment on this matter.

At this point, she became extremely abusive to me and berated me for my lack of cooperation with a press reporter stating that if I was acting as the "spokesman for the FBI," I certainly was not being very cooperative with the press because I had given her none of the information

she desired. Frankly, her attitude toward me was such that had she been a male, I would have replied unkindly. Instead, I attempted to be as polite in my conversation with her as I could in spite of her abusiveness.

You have advised me that you received a subsequent call from Miss Shanahan at your home after she completed her conversation with me during which she asked you to comment on the same things as she had asked me and you also advised her you had no comment to make. You have also advised me that she complained to you about my lack of cooperation with her.

As you are aware, it would not be proper for the FBI to comment on any of the questions which she posed to me. I got the definite impression that she and the "New York Times" felt that the FBI had no right to maintain files on "nationalist groups" of any type and my "no comment" replies to her frustrated her in her apparent attempt to write a story which would have criticized the FBI for maintaining such files. This is typical of the slanted news coverage which the "New York Times" gives to any story which in any way involves the FBI. We will continue in this office to be extremely circumspect in all our dealings with representatives of this newspaper.


