His father listed as SALIM SIRHAN, born Palestine, 1875, and his mother as NASRA KADER, both deceased. His wife MARIAM KADAR, born Salt, Jordan, 1902, not U.S. citizen. In 1965, listed SIRHAN SIRHAN, TOM SIRHAN and SALIM SIRHAN, references in U.S., all at his Detroit address. His wife, MUDALLALAH EID MUZHER SIRHAN, born Taybeh, 1904, not U.S. citizen. He listed his children in U.S. in 1960 as AWAD, KARIM, FAHIM, ADEL, GHALEB and ABED AID SALIM SIRHAN. He has also listed daughter NIHEM, born Taybeh, 1/23/48. [S-1] ~~u~~

SALIM's son, SIRHAN SALIM SIRHAN, born Jerusalem, Palestine, 6/15/34, claimed citizenship through naturalization of father, gave legal residence in April, 1957 as 1211 Hubbard St., Detroit. He was enlisted in U.S. Army in April, 1957, ASN RA 16 470 219, in Germany. He has sister, ALICE SIRHAN, born Jerusalem 4/15/38. [S-1] ~~u~~

AID's daughter, NIHEM SALEM SIRHAN, born 1/23/48, at Taybeh, resided June, 1962, at Taybeh, where had been since birth. She spelled her father's given name as AYED rather than AID. She claimed citizenship through father's naturalization. [S-1] ~~u~~

WFO found no mention of subject SIRHAN BASHARA SIRHAN in these files and no evidence showing what relationship, if any, above persons have with subject or his family. Purpose of this airtel is to assist Bureau and Los Angeles in making eliminations. WFO will supply lengthy reviews of their passport files if needed.

On 6/6/68, ELWIN G. HAWTHORNE, Route 2, Brownwood, Texas, telephone 643-5837, telephonically communicated with the Dallas Office at which time he advised as follows: *INFORMANT*

B. APPROX 1929
He stated one FRANK MALLER, whom he described as a member of the "underworld" told him approximately one year ago that the underworld would "take care" of the people in high places including ROBERT KENNEDY. HAWTHORNE stated MALLER resides in Long Beach, California, and is physically described as a WM, 39 years of age, 5'10" tall, with only one eye. HAWTHORNE said his attorney, Mr. BEN WHITEHEAD, a resident of Santa Ana, California, telephone 547-0011, is aware of MALLER's activities in the underworld.

HAWTHORNE advised he met MALLER when he (HAWTHORNE) lived in Long Beach from 1961 to 1966. He claimed he received the above information from MALLER in 1967 when he travelled to Long Beach to visit with friends. HAWTHORNE could not furnish an address for MALLER.

HAWTHORNE requested that the FBI send him to Long Beach so he could solve the matter involving the assault on Senator ROBERT F. KENNEDY and "expose the underworld."

Following receipt of the above telephone call from HAWTHORNE, an Agent of the FBI contacted Sheriff JOE R. TOWNSEND at Brownwood, Texas, to ascertain if Sheriff TOWNSEND is acquainted with HAWTHORNE. At the time contact was made with Sheriff TOWNSEND, he advised the interviewing Agent that approximately five minutes before the Agent made contact with TOWNSEND, HAWTHORNE called TOWNSEND to advise him that "the FBI had called and wanted him, HAWTHORNE, to go on a special assignment to the West Coast." HAWTHORNE requested TOWNSEND to "tell his attorney" that he would be gone to California for two or three weeks.

Sheriff TOWNSEND said he is acquainted with ELWIN G. HAWTHORNE and Sheriff TOWNSEND described HAWTHORNE as a "half-crackpot" and usually drunk.

No further action is contemplated in this matter at Dallas in view of information concerning HAWTHORNE provided by Sheriff TOWNSEND. Above information being furnished Los Angeles for background information concerning HAWTHORNE in the event HAWTHORNE makes contact with the Los Angeles Office at some time in the future.

SENATOR KENNEDY. SA SULLIVAN OBTAINED BACKGROUND INFORMATION CONCERNING SIRHAN SIRHAN AND THEN LEFT TO TELEPHONE THIS INFORMATION TO THE LOS ANGELES OFFICE. WHEN HE RETURNED SERGEANT BRANDT ADVISED THAT ARRANGEMENTS HAD BEEN MADE WITH ADEL TO GO TO THE SIRHAN RESIDENCE. BASED ON THE COMMENTS MADE BY SERGEANT BRANDT, SA SULLIVAN PRESUMED ONLY ORAL ARRANGEMENTS MADE AND HE DID NOT OBSERVE ANY WRITTEN CONSENT.

SA SULLIVAN ACCOMPANIED SERGEANT BRANDT, AND DETECTIVE JIM EVANS, HOMICIDE DIVISION, LAPD, AND ADEL SIRHAN IN A LAPD CAR TO THE SIRHAN RESIDENCE, SIX NINE SIX EAST HOWARD STREET, PASADENA. UPON ARRIVAL IT WAS DETERMINED THE ENTIRE BLOCK WAS CROWDED WITH VEHICLES WITH APPROXIMATELY TWENTY REPORTERS ON THE FRONT LAWN. NEIGHBORS AND MANY ONLOOKERS WERE GATHERED AROUND^D. TELEVISION CAMERAS WERE SET UP AND INTERVIEWS OF VARIOUS PEOPLE IN THE CROWD WERE BEING CONDUCTED. SA SULLIVAN OBSERVED UNIDENTIFIED NEWSMAN EXAMINING TRASH IN THE TRASH CANS. ADELST RSTHAN AND DETECTIVES BRANDT AND EVANS ENTERED THE FRONT DOOR. SA SULLIVAN ACCOMPANIED OTHER LAPD DETECTIVES TO THE REAR OF THE HOUSE TO DETERMINE IF ANYTHING HAD BEEN TAKEN BY NEWSMEN IN THE TRASH CANS. ON JUNE SIX LAST SUPERVISOR CHESTER E. ST. 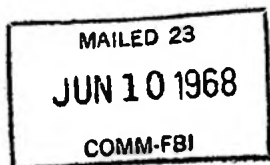
