

SHE WORE BLACK SHOES, DID NOT CARRY A PURSE, AND DID NOT WEAR GLASSES. SERRANO STATES THE MOST DISTINCTIVE FEATURE OF THIS WOMAN IS HER "FUNNY NOSE" WHICH SHE DESCRIBES AS A "BOB HOPE" TYPE. AND THEREFORE DURING THIS INTERVIEW HE WAS PINNED DOWN MORE CLOSELY. USING THE BEGINNING OF HIS JOB WITH LA COUNTY. HE NOW IS SURE THAT THE NIGHT HE MET WITH SIRHAN WAS APRIL THIRTY. SIXTY-EIGHT. CROWE STATES THAT WHILE AT PASADENA CITY COLLEGE (PCC) IN NINETEEN SIXTY-FIVE HE AND AN ASSOCIATE, DOUG LAYFIELD (PH). WERE ACTIVE IN FORMING AN AD HOC COMMITTEE THAT DEALT WITH PROBLEMS OF DISCRIMINATION AGAINST NEGROES. ALSO WHILE AT PCC HE TRIED TO FORM A CHAPTER OF THE STUDENTS FOR A DEMOCRATIC SOCIETY (SDS). THIS EFFORT MET WITH NO RESULTS BECAUSE OF A LACK OF INTEREST BY STUDENTS AT PCC. WHEN HE LEFT PCC IN NINETEEN SIXTY-FIVE. CROWE WENT TO THE UNIVERSITY OF CALIFORNIA AT LOS ANGELES (UCLA). WHEN HE GOT TO UCLA HE JOINED THE W.E.B. DU BOIS CLUBS OF AMERICA. WHILE IN THE W.E.B. DU BOIS CLUB. AND IN NINETEEN SIXTY-SIX, CROWE WENT TO THE W.E.B. DU BOIS CLUB NATIONAL CONVENTION IN CHICAGO AS A WEST COAST REPRESENTATIVE. IN APRIL, NINETEEN SIXTY-SEVEN, WHILE STILL A STUDENT AT UCLA HE END PAGE ELEVEN

AND SEVEN OTHERS FORMED A STUDENT CLUB OF THE CP. THEY PAID DUES BUT HE DID NOT PAY DUES TO ANY NATIONAL GROUP OR HEADQUARTERS DIRECTLY. THE STUDENT CLUB OF THE CP, OF WHICH HE WAS A MEMBER, MET TO DISCUSS POLITICAL MATTERS. HE DESCRIBED HIS JOINING OF THE CP AS A NATURAL CONSEQUENCE OF CP FRONT ACTIVITY IN THE W.E.B. DU BOIS CLUB. HE REMAINED ACTIVE IN THIS CP CLUB UNTIL MARCH, NINETEEN SIXTY-EIGHT WHEN HE GRADUATED FROM SCHOOL. HIS SEVEN CLUB MEMBERS GRADUATED WITH HIM AND THEY ARE ALL NOW MEMBERS OF AN EX-STUDENT CLUB.

WITH REGARD TO SIRHAN, CROWE STATES HE CONSIDERED HIM
"ERRATIC" IN HIS POLITICAL PHILOSOPHY, AND THOUGH ESSENTIALLY
LIBERAL AND LEFT OF CENTER, HE HAD DEPINITE PHASES OF HIS
THINKING WHERE HE WAS RIGHT OF CENTER, PARTICULARLY ON THE SUBJECT
OF THE STATE OF ISRAEL.

WHEN ASKED WHAT HE MEANT BY LIBERAL, CROWE STATED POLITICALLY LIBERAL. PRESSED FOR MORE DEFINITE INFORMATION, CROWE STATES HE DOES NOT KNOW SIRHAN'S ECONOMIC PHILOSOPHY. POLITICALLY SIRHAN FAVORED MOVEMENTS THAT ARE CONSIDERED BY THE GENERAL POPULACE TO BE LEFT OF CENTER. CROWE STATES SIRHAN WAS OPPOSED TO THE VIET NAM WAR.

SIRHAN COULD NOT HAVE KNOWN ANY MEMBERS OF THE W.E.B. DU BOIS

CLUB THAT CROWE WAS IN. CROWE STATES FURTHER THAT SIRHAN COULD

NOT POSSIBLY KNOW ANY OF THE OTHER SEVEN MEMBERS OF HIS STUDENT

CP CLUB.

ON MAY SECOND LAST THEY MET AT EIGHT P.M. AND ATE DINNER AT BOB'S RESTAURANT, SIXTEEN SIXTEEN EAST COLORADO, PASADENA. THEY PLANNED TO SPEND THE EVENING TOGETHER AND ATE LEISURELY. FROM EIGHT P.M. TO NINE P.M. WHILE THEY WERE AT BOB'S RESTAURANT, SIRHAN TOLD CROWE ABOUT WORKING WITH HORSES, FALLING OFF, AND GETTING HURT. CROWE TOLD SIRHAN ABOUT JOINING THE W.E.B. DU END PAGE THIRTEEN

BOIS CLUB, ABOUT JOINING THE CP AND TOLD SIRHAN, BECAUSE HE

EMBASSY ROOM WHEN IT WAS DECIDED TO GO TO THE PRESS ROOM. THIS

RESULTED IN THE ROUTE THROUGH THE KITCHEN AREA WHERE SENATOR

KENNEDY WAS SHOT.

HE DID NOT NOTICE THIS INDIVIDUAL IN ROOM AFTER SEEING HIM THIS ONE TIME, NOR DID HE RECALL SEEING A FEMALE WEARING POLKA DOT DRESS IN AREA. MASHAYEKHI DID NOT TALK WITH THIS INDIVIDUAL. MASHAYEKHI STATED A FRIEND, LONNY WORTHEY, ALSO ATTENDED CELEBRATION WITH HIM AND ALSO OBSERVED THIS INDIVIDUAL IN ABOVE ROOM. MASHAYEKHI RESIDES TWO FIVE TWO SO. MENTOR, APT. EIGHT, PASADENA, CALIF., AND EMPLOYED AS SHOE SALESMAN AT CHANDLER SHOE STORE, THREE SIX ZERO SO. LAKE AVE., PASADENA.

WAS REFERRED TO HIM BY ARGONAUT INSURANCE COMPANY, LOS ANGELES, WHO REPRESENTED EMPLOYER. TASHMA EXAMINED SIRHAN ON AUGUST FIFTEEN, SIXTY-SEVEN FOR FACIAL DISCOMFORT, INABILITY TO ROTATE EYE AND POOR SIDE VISION. EXAMINATION REFLECTED SIRHAN HAD SYMPTOMS WHICH WERE NOT ORGANIC IN ORIGIN AND HE EXHIBITED A CLEAR PATTERN OF INCONSISTENCY. NO FURTHER MEDICAL TREATMENT DEEMED NECESSARY.

FORREST L. JOHNSON, M.D. (NEUROSURGEON), ONE ONE TWO SEVEN WILSHIRE BOULEVARD, LOS ANGELES, CALIFORNIA, ADVISED SIRHAN REFERRED TO HIM FROM ARGONAUT INSURANCE COMPANY, LOS ANGELES, WHO REPRESENTED EMPLOYER. JOHNSON EXAMINED SIRHAN ON SEPT. FIVE, SIXTY-SEVEN AND ON OCT. NINE, SIXTY-SEVEN FOR DISCOMFORT OF CHIN, LEFT EYE AND LOW BACK. NO EVIDENCE OF NEUROLOGICAL PROBLEMS DISCOVERED AND SIRHAN WAS FOUND CAPABLE OF RETURNING TO WORK. HE DESCRIBED SIRHAN AS HAVING A SURLY PERSONALITY.

RE LOS ANGELES TEL TO CLEVELAND SIX EIGHT LAST.

MANUEL M. AND AMPARIO SERRANO ONE NINE FOUR NINE WEST TWO SEVEN STREET. LORAIN. OHIO. PARENTS OF SANDRA SERRANO. ADVISED SHE TELLEPHONICALLY CONTACTED THEM ON SIX FOUR LAST AT APPROX-IMATELY SIX PM EDT TO CONGRADULATE HER BROTHER UPON HIS GRADUATION FROM HIGH SCHOOL. SHE CALLED AGAIN AT TEN THIRTY PM EDT ON SAME DATE STATING SHE WAS AT KENNEDY'S CAMPAIGN HEADQUARTERS AND THAT KENNEDY WAS GOING TO WIN THE CALIFORNIA PRIMARY ELECTION.

SANDRA TELEPHONICALLY CONTACTED HER MOTHER BY COLLECT CALL AT APPROXIMATELY THREE THIRTY AM EDT ON SIX FIVE LAST AND WAS HYSTERICAL SHE SAID SOMETHING TO THE EFFECT THAT IT COST HER THREE DOLLARS TO GET THE TELEPHONE. SHE STATED THAT KENNEDY HAD BEEN SHOT AND WHEN HER MOTHER SAID "WHAT?" SHE REPEATED THE STATEMENT. SANDRA STATED SHE DID NOT KNOW IF KENNEDY WAS DEAD AND STATED HE HAD BEEN SHOT AFTER HIS SPEECH. SHE WAS HYSTERICAL DURING ENTIRE TELEPHONE CONVERSATION AND HER MOTHER WAS UNABLE TO RECALL HER MENTIONING ANYTHING ABOUT OBSERVING SHOOTING. BUT SHE KEPT REPEATING "WHY DO ANYTHING LIKE THIS. SUCH A GOOD MAN". SHE ASKED TO SPEAK WITH HER FATHER BUT HE

AT APPROXIMATELY EIGHT AM EDT ON SIX FIVE LAST SANDRA AGAIN
TELLEPHONICALLY CONTACTED HER MOTHER AND AT THIS TIME STATED SHE HAD
BEEN ON THE TERRACE AT THE AMBASSADOR HOTEL PRIOR TO KENNEDY'S
SPEECH. AND SHE HAD SEEN TWO MEN AND A WOMAN WHOM SHE DESCRIBED ONLY
AS THE MEN BEING MEXICAN DASH AMERICAN AND THE GIRL AS BEING WHITE.

SHE FURTHER STATED AFTER THE SHOOTING SHE OBSERVED JUST ONE OF THE MEN AND THE SAME GIRL RUNNING FROM THE HOTEL AREA. SHE DID NOT ELABORATE FURTHER NOR DID SHE FURTHER DESCRIBE THESE INDIVIDUALS.

MRS. SERRANO ADVISED SHE COULD RECALL NO FURTHER DETAILS OF THE CONVERSATIONS WITH HER DAUGHTER. AND SHE DID NOT MAKE NOTES DURING ANY OF THE CONVERSATIONS AS SHE DID NOT THINK IT IMPORTANT AT THE TIME.

PARENTS DESCRIBED SANDRA AS A GOOD GIRL, WHO DOES NOT SMOKE
OR DRINK, AND WHO IS LEVEL HEADED, AS WELL AS MENTALY AND EMOTIONALY
MATURE. SHE GRADUATED FROM HIGH SCHOOL IN LORAIN IN JUNE OF NINETEEN
SIXTY SIX. MAINTAINING C+ AVERAGE. MAJORING IN BUSSINESS ADMINISTRATION
