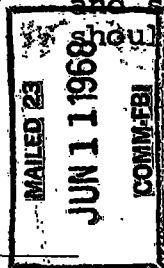

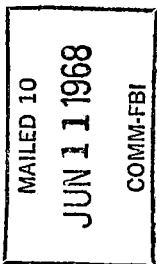

News releases reviewed by the Bureau indicate that Jesus Perez and Paul Grieco are witnesses with first hand information concerning captioned case. Perez may be an employee of the Ambassador Hotel and indicated to the news media that subject Sirhan Bishara Sirhan asked him three or four times if Kennedy would pass through the narrow passageway where Sirhan was standing just prior to the shooting. Grieco was identified by the press as a senior at Woodbury College, who was in the Kennedy party in the immediate vicinity of the Senator at the time of the shooting. Senator Kennedy is supposed to have asked "Is Paul alright" immediately following the shooting.

If not already done, Los Angeles should interview Perez and Grieco for any pertinent information they may be able to furnish concerning this case.

# *First Thoughts Were For the Other Victims*

LOS ANGELES, June 5 (UPI) — "Is everybody okay? Is Paul all right?"

These were the words that Sen. Robert F. Kennedy uttered seconds before lapsing into unconsciousness early today, according to Paul Grieco, 21, a Woodbury College senior.

Grieco was among the first

to extend aid to Kennedy after the Senator was shot down in the Ambassador Hotel. He held Kennedy's bleeding head in his hands until an ambulance crew arrived.

"Kennedy's first thoughts were for the other wounded," Grieco said. "Kennedy said, 'Is everybody okay? Is Paul all right?'"

Kennedy was referring to Paul Schrade, a union official who suffered a scalp wound in the shooting. Schrade was a few steps behind the Senator when the shooting took place.

"I told him everybody was okay and you're going to be okay — just lie still," said Grieco. "Then I held his head because I thought he shouldn't be lying down like that. I thought he would bleed less if I held his head up a little."

Grieco, of Ontario, Calif., said Kennedy "was at the height of his consciousness" when he expressed concern for the others.

"He didn't seem to be in too much pain, although I could see the wound in his head clearly, he wasn't bleeding a great deal," Grieco recalled. "All I could think of was trying to help the man and keep people back as much as I could."

Grieco said the gun "sounded like a kid's cap gun, going off very fast. The next thing I knew I was by Kennedy's side trying to help."

Grieco, employed as a part-time bookkeeper with a Los Angeles construction firm while going to college, said he and a friend who lives nearby decided to "look in at the party in the hotel." Grieco said he is a Republican.

Qc15 Photocopy of typewritten document entitled "Biblegram (telegram) to McArthy," bearing handwritten address, "Departement of Imigration, Mobile, Alabama," and postmarked "Los Angeles, Calif. PM 31 May 1968"

Result of examination:

The typewritten message on Qc15 is a photocopy reproduction. The photocopy was folded and the address and stamp were then added. The address on the front of Qc15 consists of original handwriting which was written with blue-black ink.

The typewriting corresponds to the standard for Underwood pica style of type, having a horizontal spacing of ten letters to the inch. This typewriting was compared with the Anonymous Letter File without effecting an identification. Copies are being added thereto.

The typewritten name "Merle M. Matteson" is included in the questioned typewriting. Based on the name mentioned, a search was made in the files of the Identification Division. The handwriting on Qc15 was compared with signatures on the fingerprint cards located. No identification was made.

Qc15 is being returned separately. This specimen has been photographed.

## LATENT FINGERPRINT IDENTIFICATIONS

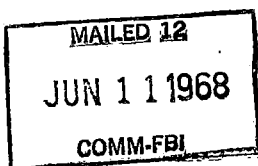

SUBJECT: INCIDENT - Slaying of Abder Rayyan, Jordanian  
Immigrant at Chicago, June 8, 1968

Reference is made to the attached newspaper article captioned "Jordanian is Killed in Chicago", which appeared on page A9 of the June 10, 1968 edition of the Washington Post.

At the request of Mr. Donald Wehmeyer, L/NEA (ext. 5895), Special Agent in Charge Miles Briggs, Chicago Field Office, was telephonically contacted at 10:00 a.m., June 10, 1968 and asked to obtain the local police account relating to the slaying mentioned in referenced news article.

At 1:00 p.m., June 10, 1968 SAC Briggs advised that the victim of the shooting was standing in front of the entrance to his grocery store at 343 East 51st Street, South Chicago, when two (2) male negroes entered the store and one, while standing behind the victim, shot him in the back of the head with a .38 caliber weapon. It is further reported that two (2) male negroes departed the store immediately without attempting to rob the victim or the store; that they entered an automobile and immediately left the scene of the incident; witnesses were able to furnish local police authorities the license of the vehicle and as a result Mr. Arron Myers, male Negro DOB - [REDACTED], was arrested and admitted being the driver of the vehicle involved.

During questioning of Arron Myers, who has been charged with murder, he made a statement to the effect that while working at Neely Brothers Gas Station, 535 East 43rd Street, South Chicago, he was approached by two (2) friends, Mr. Robert Walton aka; and his twin brother Michael Walton who stated that they needed the use of an automobile for a short period of time and would pay Myers \$10.00 for its use; that Myers contacted a friend identified as Clayton and obtained permission to use the latter's vehicle; that he drove Robert and Michael Walton to an address in Chicago where they were joined by a woman identified as Mrs. Walton; that he was then told to drive to a location in the vicinity of the victim's store; that while Mrs. Walton remained in the vehicle with Mr. Myers, Robert and Michael Walton left the vehicle and returned shortly; that they appeared to be excited and ordered the driver to leave the area; that shortly thereafter Mr. Myers observed Michael Walton hand his alleged wife an object rapped in a handkerchief which appeared to be a gun; that they drove to another location where the gun was thrown into a trash can following which they drove to a further location where Robert and Michael Walton and the latter's wife



left the vehicle. Mr. Myers stated that he returned the car to Mr. Clayton and would pay him the money at a later date. Mr. Clayton as registered owner of the vehicle, was interviewed by local authorities and identified Myers as the person to whom he had loaned the car. Predicated on Mr. Clayton's statement, the police interviewed Mr. Myers and subsequently arrested him as mentioned above.

The following represents physical description of the suspects allegedly involved in the shooting of the victim:

Mr. Robert Walton aka: Robert Smith;

V. Walton; James Williams.  
DOB: [REDACTED] Norfolk,  
Virginia. Male Negro; 5'10"; 130 lbs.;  
medium brown complexion. When last  
seen was wearing a blue gold fez bearing  
the inscription "Afro-American"; White  
T shirt and black sandals.

Mr. Michael Walton  
Male Negro; DOB: [REDACTED] Norfolk,  
Virginia; 5'8"; 145 lbs.  
It is reported that Robert and Michael  
Walton are either twin brothers or  
half brothers. No other identifying  
data was furnished.

With respect to a motive for the slaying of Mr. Rayyan, local authorities stated that a rumor is present indicating that the victim is alleged to have said in substance that "King and Kennedy should have been dead long ago". Because of the latter reported rumor, local authorities do not discount the possibility that the victim was assassinated in retaliation for the murder of Senator Robert F. Kennedy in view of the fact that his alleged assassin was a Jordanian immigrant residing in the United States. However, this is inconsistent with the reference newspaper account which states that the victim was an admirer of the Kennedy family; on the wall of his store is a poster with pictures of Abraham Lincoln, John F. Kennedy, and Dr. Martin Luther King, Jr., inscribed "They died to make men free".

For information purposes, the scene of the shooting mentioned in this writing is located approximately five (5) blocks from the University of Chicago where the Shah of Iran is scheduled to visit at 10:00 a.m., June 15, 1968.

# Jordanian Is Killed In Chicago

CHICAGO, June 9 (UPI)—A Jordanian grocer was shot to death in his South Side store yesterday in a motiveless slaying that might have been retaliation for the assassination of Sen. Robert F. Kennedy, police said today.

The victim was Abder Rayyan, 55, who was slain before the eyes of his nephew and daughter and 11 customers. Police said they have been unable to determine any motive for the slaying but it might have been an abortive robbery or revenge for the killing of Kennedy.

Two Negro men walked into the store, which Rayyan had purchased only two months ago. Rayyan was at work at a rear counter, standing over a vegetable bin. One of the men walked up to him, drew a .38 caliber revolver and fired two shots. One of the bullets struck Rayyan behind the left ear.

Rayyan's daughter, Zuhdela, 22, said the two men ran out of the store and down the street to a car parked about a block away. Waiting in the car were several other young men. The group drove away.

Rayyan was the father of nine children. He came to the United States five years ago from South America. Authorities said he left Jordan 16 years ago. His widow and other members of the family live in Quito, Ecuador.

A Jordanian immigrant has been charged at Los Angeles with killing Kennedy.

Police were checking out reports that after the Kennedy assassination a rumor spread through the neighborhood around the store at 343 E. 51st st. that Rayyan had said, "Kennedy should have been dead long ago."

However, Rayyan apparently was an admirer of the Kennedy family. On the wall of his store was a poster with pictures of President Abraham Lincoln and John F. Kennedy, and Dr. Martin Luther King.

He inscribed, "They died to make men free."

ALICE MOTHERSHEAD, DIRECTOR, COMMUNITY LIAISON CENTER, WHICH HANDLES STUDENTS ATTENDING THE SCHOOL WHO ARE ON STUDENT VISAS FROM OTHER COUNTRIES, AND WHO IS IN CHARGE OF THE INTERNATIONAL CLUB, COMPRISED ALMOST EXCLUSIVELY OF FOREIGN STUDENTS, ADVISED THERE WAS NO ORGANIZATION OF ARAB STUDENTS, OR ANY CLUBS RECOGNIZED ON THE CAMPUS WHICH WERE COMPRISED OF FOREIGN STUDENTS OF ONE NATIONALITY. SHE HAD NO RECORD OF SIRHAN SIRHAN EVER HAVING BELONGED TO THE INTERNATIONAL CLUB, AND STATED HE WOULD NOT HAVE BEEN INCLUDED IN A FOREIGN STUDENTS REGISTRY, SINCE HE WAS AN IMMIGRANT, AND NOT IN THE UNITED STATES ON A STUDENT VISA.

DEAN BEAN ADVISED HIS RECORDS REFLECTED A PART TIME NIGHT TEACHER OF ARABIC, ABDULMAJIA A. DABBAS, WHO HAD TAUGHT AT THE SCHOOL FROM JANUARY THIRTY ONE, SIXTY TWO, THROUGH THE SPRING SEMESTER OF SIXTY SIX. DABBAS INDICATED WHEN LEAVING THE COLLEGE THAT HE EXPECTED TO GO TO AN UNKNOWN MIDDLE EASTERN COUNTRY. THE RECORDS REFLECTED TWO ADDRESSES FOR DABBAS WHILE IN THE PASADENA AREA.

SIRHAN, ACCORDING TO STRATHMAN, APPEARED TO CHANGE CONSIDERABLY AFTER A FALL FROM HORSE IN SIXTY SIX. HE APPEARED TO HAVE DIFFICULTY SEEING OUT OF ONE EYE AND SEEMED TO BE IMPATIENT, NERVOUS, AND EMOTIONAL. AFTER THE FALL, SIRHAN BECAME INTERESTED IN HIS STUDY OF MYSTICAL BODIES, WHICH HE WAS STUDYING WITH AN~~X~~ INDIVIDUAL NAMED, PAUL, WHO STRATHMAN NEVER MET.
