





Mrs. Marge Rodak told our Phoenix Office that on Wednesday following Senator Kennedy assassination, her daughter Sherrie Lynn and present wife of Djeredjiam were watching T. V. and saw photographs of subject Sirhan Bishara Sirhan. Djeredjiam was alleged to have said, "know that man" further stated "didn't I tell you (Mrs. Djeredjiam) two days ago that Kennedy was going to be shot and Humphrey would probably be shot next and Ted Kennedy shot if he runs for office." Mrs. Rodak indicated when she queried Djeredjiam regarding his statements, he refused to discuss them. It is noted Mrs. Rodak dislikes her son-in-law intensely, however, Djeredjiam's wife when interviewed, denied her husband made such statements as related by her mother. Further. it was Mrs. Rodak who speculated two days before the assault on Kennedy he would be shot and it was Mrs. Rodak voicing her opinion. Offices receiving this communication are thoroughly checking out Djeredjiam concerning the statements made so that his exact location during the pertinent period will be known. Dallas requested background in Bureau files since Dallas' old applicant file has since been destroyed.

HE SAID THAT WHEN HE ORIGINALLY OBSERVED THE PHOTOGRAPH OF THE ASSASSIN ON TELEVISION, HE HAD CONSIDERED CONTACTING THE FBI, BUT HIS WIFE HAD PERSUADED HIM NOT TO BECAUSE OF THE SEVERE SUN BURN AND BECAUSE HE HAD BEEN INVOLVED IN TROUBLE IN THE PAST CONCERNING DEPORTATION FROM THE UNITED STATES.
