DEDELL ASKED SMITH TO ASK BRUNO IF BRUNO WANTED DEDELL TO BRING BRUNO'S WIFE OUT TO LOS ANGELES. WHEN SMITH AT A LATER TIME GAVE THE MESSAGE TO BRUNO, BRUNO DESCRIBED DEDELL AS A "HANGER - ON" FROM SYRACUSE, NEW YORK.

ON JUNE EIGHTEEN INSTANT, TWO COPIES OF LOS ANGELES
REPORT CONCERNING ASSASSINATION OF SENATOR ROBERT F.
KENNEDY WERE GIVEN TO WILLIAM L. RITZI, ASSISTANT DISTRICT
ATTORNEY, LOS ANGELES COUNTY, WHO WAS ACTING FOR DISTRICT
ATTORNEY EVELLE YOUNGER, WHO WAS AWAY FROM CITY.

RITZI, AT TIME OF DELIVER OF REPORT, INDICATED HIS
DEPARTMENT HAD SOME QUESTION AS TO WHETHER FOUR ATTORNEYS
FROM JORDAN WHO ARE, ACCORDING TO PRESS REPORTS, ALLEGEDLY
GOING TO REPRESENT SIRHAN, ARE LEGALLY AUTHORIZED TO
REPRESENT HIM IN THIS COUNTRY. RITZI STATED HIS DEPARTMENT
DOING RESEARCH IN THIS MATTER TO MAKE SUCH DETERMINATION.

INFORMATION REGARDING SANDRA SERRANO.

ON JUNE EIGHTEEN INSTANT, CAPTAIN HUGH BROWN, LAPD, WHO HEADS SPECIAL TASK FORCE INVESTIGATING THIS MATTER, ADVISED THAT SANDRA SERRANO HAD CONSENTED TO POLYGRAPH EXAMINATION AND THAT SUCH EXAMINATION WOULD BE CONDUCTED ON THURSDAY, JUNE TWENTY NEXT.

ARREST OF MUNIR B. SIRHAN AT
FLAGSTAFF, ARIZONA.

MUNIR BISHARA SIRHAN WAS INTERVIEWED AT HIS RESIDENCE CONCERNING THIS MATTER AND INDICATED HE WAS ARRESTED ON VAGRANCY CHARGE IN FLAGSTAFF, ARIZONA, IN MAY SIXTY SIX, ALONG WITH THREE OR FOUR OTHER INDIVIDUALS. MUNIR STATED HE AND DAVID MYERS HAD LEFT LOS ANGELES TOGETHER ON HITCHHIKING TRIP. HAD BEEN ACQUAINTED WITH EACH OTHER ONLY TWO OR THREE WEEKS BEFORE DEPARTURE. MUNIR STATED HIS BROTHER, SIRHAN, WAS NOT ACQUAINTED WITH MYERS IN ANY MANNER.

OTHER INDIVIDUALS ARRESTED AT SAME TIME NOT KNOWN TO MUNIR PRIOR TO DATE OF ARREST. MUNIR ADVISED WAS NOT ACQUAINTED WITH PHILLIP LEE CLEVINGER AND RONNIE

EDMON HOULEN ARRESTED AT SAME TIME. MUNIR STATED HE AND MYERS WERE TRAVELING TOGETHER AND OBTAINED RIDE WITH OTHER TWO INDIVIDUALS. HAD NOT SEEN THEM BEFORE THAT DATE. MUNIR STATED HIS BROTHER, SIRHAN, WAS IN NO WAY ACQUAINTED WITH ABOVE INDIVIDUALS.

IT IS NOTED THAT PHILLIP CLEVINGER INTERVIEWED IN SAN FRANCISCO, CALIFORNIA, ADVISES SAME INFORMATION THAT HE HAD PICKED UP TWO HITCHHIKERS UNKNOWN TO HIM. HOULEN HAS ADVISED SAME INFORMATION AS CLEVINGER AND MUNIR.

POSSIBLE WITNESSES TO SHOOTING

RE COLONEL JOHN H. GLENN

COLONEL JOHN H. GLENN INTERVIEWED BOSTON, MASSACHUSETTS, ADVISED WAS AIDE IN CAMPAIGN OF SENATOR ROBERT KENNEDY IN CALIFORNIA PRIMARY ELECTION. STATED WAS IN UPSTAIRS SUITE AT AMBASSADOR HOTEL WHEN KENNEDY WAS SHOT ON EARLY MORNING OF JUNE FIVE LAST. GLENN STATED DID NOT SEE CAPTURED GUNMAN ON THAT OCCASION NOR DID HE RECOGNIZE SIRHAN B. SIRHAN FROM PHOTOGRAPHS AS INDIVIDUAL HE HAD EVER SEEN PREVIOUSLY ON ANY OCCASION.

COLONEL GLENN ADVISED ONLY SIGNIFICANT CHANGE HE

COULD RECALL IN CONNECTION WITH SENATOR'S PLANS WAS ON JUNE FOUR LAST. ORIGINAL PLANS WERE FOR SENATOR TO SPEND NIGHTS OF JUNE THREE - FOUR AT AMBASSADOR HOTEL. HOWEVER, AFTER COMPLETE DAY OF CAMPAIGNING ON JUNE THREE, WHICH ENDED IN SAN DIEGO, CALIFORNIA, KENNEDY DEPARTED FOR MALIBU BEACH RESIDENCE OF MOVIE DIRECTOR JOHN FRANKENHEIMER. KENNEDY AND SEVERAL OF PARTY SPENT FOLLOWING DAY AT MALIBU AND RETURNED TO AMBASSADOR HOTEL APPROXIMATELY EIGHT PM JUNE FOUR LAST. GLENN COULD RECALL NO OTHER CHANGES IN REGARD TO KENNEDY'S ITINERARY.

RE JOHN W. GALLIVAN

JOHN W. GALLIVAN, JR. INTERVIEWED SALT LAKE CITY, UTAH, AND ADVISED WAS IN CONSTANT TRAVEL STATUS AS MEMBER OF KENNEDY STAFF SINCE APRIL ONE LAST. ADVISED WAS ADVANCE MAN AND DID EXTENSIVE TRAVELING THROUGHOUT U.S. IN BEHALF OF PRESIDENTIAL CANDIDACY OF KENNEDY. GALLIVAN STATED SPENT MOST OF DAY OF JUNE FOUR AT AMBASSADOR HOTEL AND AT APPROXIMATELY SEVEN THIRTY PM, THAT DATE, WENT TO FIFTH FLOOR SUITE OF HOTEL WHERE KENNEDY AND FRIENDS WERE HAVING PARTY. WHEN TIME

ARRIVED FOR KENNEDY'S APPEARANCE IN BALLROOM OF AMBASSADOR HOTEL, ASSEMBLED GROUP LEFT FIFTH FLOOR ROOM WITH SENATOR AND WENT TO FIFTH FLOOR ELEVATOR. GALLIVAN ADVISED HAD BEEN WITH INDIVIDUAL KNOWN ONLY TO HIM AS "UNO", LNU, (TIMANSON) WHO HE ENGAGED TO ASSIST HIM IN DIRECTING SENATOR WITHIN BUILDING. GALLIVAN ADVISED WHEN GROUP GOT IN ELEVATOR KENNEDY INQUIRED WHETHER OR NOT ELEVATOR WOULD GO TO LOBBY AND UPON LEARNING WAS LOBBY ELEVATOR, DESIRED TO GO IN BACK WAY. GALLIVAN ADVISED THIS HAD NOTHING TO DO WITH SENATOR'S SAFETY BUT THAT KENNEDY WAS TIRED OF FIGHTING LARGE CROWDS. "UNO", ACCORDING TO GALLIVAN, DIRECTED GROUP TO SERVICE ELEVATOR WHICH WENT TO BALLROOM LEVEL. GALLIVAN ADVISED THAT PARTY ENTERED BALLROOM FROM DOOR, NEAR SIDE OF PLATFORM. GALLIVAN WENT ON PLATFORM, MADE ARRANGEMENTS WITH NEWS MEDIA TO OBTAIN PHOTOGRAPHS AND LEFT AS PLATFORM WAS CROWDED. GALLIVAN ADVISED AS SENATOR MADE HIS STATEMENT TO PUBLIC, GALLIVAN LEFT AREA WITH "UNO" TO LOCATE PRESS ROOM WHERE KENNEDY WOULD GO AFTER SPEECH. AFTER LOCATING PRESS ROOM, RETURNED TO SPEAKERS' PLATFORM WHERE KENNEDY WAS STILL TALKING. GALLIVAN

LOOKED SITUATION OVER TO DECIDE WHETHER TO TAKE SENATOR OFF THE BACK SIDE OF PLATFORM OR OFF SIDE OF PLATFORM FROM WHICH THEY HAD ENTERED. GALLIVAN STATED WHEN KENNEDY COMPLETED SPEECH, PARTY MADE EXIT FROM SIDE AND HE DOES NOT KNOW IN WHAT ORDER THEY LEFT. GALLIVAN STATED THERE WAS NO QUESTION IN HIS MIND, AT THIS POINT, AS TO SAFETY OF KENNEDY AND INSTEAD OF SPIRIT OF TIGHT SECURITY, THERE WAS SPIRIT OF RELAXATION AND CELEBRATION DUE TO KENNEDY VICTORY. GALLIVAN STATED AS HE WALKED AHEAD OF PARTY HE HEARD SHOTS BEHIND HIM, TURNED, SAW COMMOTION IN CROWD, BUT COULD NOT DISCERN WHAT WAS GOING ON. GALLIVAN STATED RAN TOWARD SENATOR AND SAW HIM LYING FACE UP ON FLOOR AND PEOPLE BENDING OVER HIM, THE IDENTITY OF WHOM HE COULD NOT RECALL. HE DID RECALL SENATOR'S WIFE AT SENATOR'S SIDE. GALLIVAN YELLED TO BILL BARRY TO TAKE CARE OF SENATOR AND HE, GALLIVAN, ATTEMPTED TO TAKE MAN THAT BARRY HAD BEEN HOLDING. GEORGE PLIMPTON, FRIEND OF SENATOR, HELPED HIM IN STRUGGLE. GALLIVAN STATED WAS UNABLE TO TAKE GUN FROM MAN AND CONCENTRATED ON KEEPING HIM IMMOBILIZED AND LATER ROOSEVELT GRIER TOOK CONTROL OF MAN AND HE WENT BACK TO WHERE SENATOR WAS LYING ON FLOOR.

GALLIVAN ADVISED HE HAD NEVER SEEN SUSPECT BEFORE IN HIS TRAVELS THROUGHOUT THE U.S. OR IN HIS ACTIVITIES AROUND HOTEL. ADVISED THAT FROM HIS OBSERVATION, SUSPECT APPEARED TO BE ALONE AND NOT IN COMPANY OF ANY INDIVIDUALS. STATED HAD NOT NOTED ANY SUSPICIOUS ACTIVITIES DURING TIME IN LOS ANGELES AND AT NO TIME WAS CONCERNED ABOUT SENATOR'S LIFE. Irena will possibly fly again with Max to the U. S. for her (?) sons (?). She wrote to me to come with Emily to Vienna for three days. We shall see. Poor people, they have it so uncertain again - such is the world - disgusting!

I give my best regards to your children, also to the Goldsneiders - Tony and Flerio (?). I think of you and kiss you.

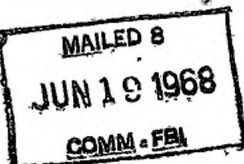
In connection with our investigation into captioned matter, our Los Angeles, California, Office has reported that records of the Selective Service Headquarters for the State of California show no registration for Sirhan Bishara Sirhan or his brothers Saidallah and Munir Sirhan. The remaining brothers, Sharif and Adel Sirhan, are both registered with Local Board 91, Pasadena, California.

Our Los Angeles Office in noting the failure to register for the Selective Service Act on the part of Saidallah and Munir Sirhan advised that all four brothers have apparently been cooperative with the FBI and the Los Angeles Police Department in connection with the investigation into the assassination of Senator Robert F. Kennedy. They have readily furnished background information relative to the activities of Sirhan Bishara Sirhan. According to our Los Angeles Office, further inquiry into the Selective Service status of Saidallah and Munir Sirhan could possibly have an adverse effect upon what appears to be their cooperative spirit thus far.

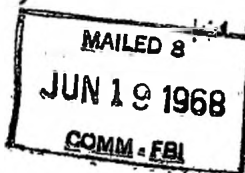

The following concerns most recent developments in connection with our investigation into the assassination of Senator Robert F. Kennedy.

A report from CIA, a copy of which was furnished the White House, indicates a Libyan attorney, Abdussalam Nafa, has offered to defend Sirhan Bishara Sirhan. According to these accounts, Nafa has offered his services free of charge and suggested that if it were not possible for him to defend Sirhan in court he be authorized to select an attorney who is a member of the California Bar Association. Nafa has been issued a three-month visitor's visa by our embassy in Tripoli and is described by CIA as having been active in the defense of the Arab nationalist movement in Tripoli earlier this year. Based on available information he is unidentifiable in Bureau files.

Our Los Angeles Office reports that a check of the Selective Service Headquarters records for the State of California shows no registration for Sirhan Sirhan or his brothers Saidallah Sirhan and Munir Sirhan. The remaining brothers Sharif and Adel Sirhan are both registered with local board 91, Pasadena, California.

Our Los Angeles Office in noting the failure to register on the part of Saidallah and Munir Sirhan advised that all four brothers have apparently been cooperative and have readily furnished background information relative to the activities of Sirhan Sirhan. Los Angeles was of the opinion that to pursue the Selective Service aspect insofar as Saidallah and Munir are concerned at this time could possibly adversely affect their cooperative spirit which has existed thus far.
