Gentlemen:

On either the night of Wednesday, June 5, or the night of Thursday, June 6, 1968 (but I think it was the night of the 5th), while watching films on my TV screen* which I believe were taken at the Ambassador Hotel in Los Angeles right before the shooting of Senator Robert F. Kennedy, my attention was caught and focused for several seconds on the movements of a man in a light-colored shirt, with either his back or profile to the TV camera, running or probably walking at a fast pace through this large crowd. Now I realize that this in itself is nothing and that any number of very sensible reasons could have accounted for his movements, or it may be that he simply felt like moving in that manner, but it was the shooting incident which took place around that time that made me keep wondering why that man seemed to be weaving his way through the crowd with such purpose right then when the rest of the people around him appeared to be either standing approximately in one place or moving about slowly.

I put off writing you for several days about the above question that kept occurring to me as it seemed so silly and insignificant (and it still does, especially on paper). Regardless, this is what I saw at that time. If you think it has any significance, you can take it from there and look for this man while you are looking at the rerun of these films, as I'm sure you will be studying all of these films because of your investigations.





Reference is made to the recent UPI news refease indicating that one Solomov Sirhan had been arrested in Iraq as an Israeli agent. It was further indicated that he was the brother of the subject in the instant case.

James Hunt, Central Intelligence Agency (CIA), furnished the following to the Liaison Agent on June 12, 1968:

Discreet inquiry conducted by CIA in Iraq has disclosed that there is no basis whatsoever for the referenced story. There was no arrest of any "Israeli agent" in Iraq, and there is no evidence that the subject in this case has a brother named Solomon. The news story allegedly originated in Cairo, and CIA surmises that the Egyptian Government fabricated the story in an effort to embarrass the Israelis. The Iraqi Government was so incensed over the news item that it submitted an official apology to the government of Jordan claiming there was no basis for the news item.

Inquiry by CIA in Jordan has failed to disclose any evidence that the subject in this case has a brother named Solomon.
