planned the assassination plot and put \$10,000,000 into the hands of a secondary group. The secondary group was to locate individuals to carry out the assassination. Some of the members of the secondary group were affiliated with the Central Intelligence Agency (CIA) and included Lee Harvey Oswald who was a CIA agent. Jaffe also claimed Oswald was an FBI informant during the time he was in New Orleans. Jaffe stated that the assassination of President Kennedy was accomplished by a total of 95 persons and that the actual assassination shots were fired by four anti-Castro Cubans from several different directions. Jaffe claimed the assassination was held in Dallas, Texas, because "The Committee" had great influence in Dallas which extended into the Dallas Police Department and the Dallas Sheriff's Office. Jaffe stated the individuals in "The Committee" are well known to President Lyndon Johnson and that while Johnson was not associated with "The Committee" and was not connected with the assassination, Johnson now has knowledge of the people who were responsible.

Jaffe claimed Garrison possesses a diary of one of the plotters describing his activities and plans leading up to the assassination of President Kennedy and also has a story written by David Ferrie wherein Ferrie describes his involvement in the plot. Jaffe claimed the FBI also has a copy of Ferrie's story. According to Jaffe, one of the Cubans involved in the assassination of President Kennedy is cooperating with Garrison. Jaffe also claimed Garrison possesses two or more pieces of alleged communications from the FBI Dallas Office to the Director, FBI, which allegedly advised of the existence of a possible plot to assassinate President Kennedy. Mr. Lubic further informed the Los Angeles Office that following his contact with Jaffe he attempted to arrange an appointment for New Orleans District Attorney to meet Senator Robert F. Kennedy. He stated he handled such arrangements through Frank Mankiewicz, Senator Kennedy's Press Secretary. Lubic stated that Mankiewicz told Lubic Senator Kennedy was not interested in meeting with Garrison. Lubic further advised that following the assassination of Senator Robert F. Kennedy, he contacted Garrison to obtain his comments as a matter of personal interest. Garrison reportedly told Lubic that Sirhan Sirhan was a "company man," meaning CIA agent. Garrison claimed Senator Kennedy was killed with the same type bullet that had been used to assassinate President Kennedy and Martin Luther King. Lubic added that Garrison believes that he (Garrison) may be the next victim in the continuing plot because of his ability to expose "The Committee." Garrison indicated he would be traveling to Los Angeles in the near future and would contact Lubic.

#### OBSERVATIONS:

The wild allegations of Jaffe are in the same vein that Garrison has followed during the past 18 months in his news releases regarding the assassination of President Kennedy. The conspiracy plot outlined by Jaffe is absolutely unworthy of belief and strongly suggests that Garrison is insane.

ACTION: Information volunteered by Mr. Lubic to the Los Angeles Office regarding his contact with Garrison's investigator, Jaffe, will be disseminated to the Department.

Referenced teletype reflects that at the outset of the interview of OWEN he advised that upon the conclusion of his interview by Los Angeles Police Department (LAPD) Officers at San Francisco on 7/3/68, he informed them that he was to see representatives of the FBI, and they stated they would rather he did not talk to the FBI but could not stop him if he desired to do so.

As the Bureau is aware, there is currently in force a court order issued by the Superior Court at Los Angeles in connection with this matter prohibiting witnesses and potential witnesses, police and attorneys, from discussing this matter other than with legitimate investigative personnel. The extent of this order is such that a copy was served upon the Mayor of Los Angeles, SAMUEL W. YORTY, in order to preclude the Mayor from making any statements regarding SIRHAN B. SIRHAN.

Concerning this particular matter, Lieutenant MANUEL PINA, LAPD, who conducted the interview with OWEN, was contacted, and he advised that at the outset of the police interview with OWEN on 7/3/68, OWEN informed him that he had an appointment with the FBI to also discuss the assassination of Senator KENNEDY.

OWEN also had advised the police that he had not kept at least one previous appointment that he had made with the FBI. Lieutenant PINA urged OWEN to keep his appointment and to cooperate fully. He also informed OWEN at the outset of the interview of the existence of the court order in this matter that prohibited anyone from discussing this case in public, especially on TV or to news media. At no time was OWEN ever requested or was it suggested to OWEN that he not keep his appointment with the FBI. As a matter of interest, immediately upon his return to Los Angeles, Lieutenant PINA made available the results of his interview and the results of the polygraph examination which showed that OWEN was not truthful.

It is obvious that OWEN has either deliberately or otherwise misinterpreted the admonition set forth by the court that this case was not to be discussed with other than legitimate law enforcement authorities.

In connection with our investigation into the shooting of Senator Robert F. Kennedy at the Ambassador Hotel on June 5, 1968, Los Angeles reports local authorities are continuing extensive safeguards with respect to the accused assailant, Sirhan Sirhan, and are making preparations for his next appearance in court which is scheduled for July 19, 1968.

Under heavy security provisions, local authorities secretly moved Sirhan from the cell in the New County Jail in which he had been incarcerated shortly after his arrest, to the 13th floor of the Hall of Justice. He now occupies a large cell by himself and is under constant observation with an unarmed deputy sheriff in the cell and an additional guard stationed immediately outside. Visitors will not be allowed physical contact with Sirhan and will have to converse with him by telephone, observing him through glass. At his previous appearance in court on June 28, 1968, Sirhan's attorneys requested a 3-week delay to additionally review the facts prior to entering a plea. The hearing is now scheduled for July 19, 1968. Sirhan will be brought to the courtroom by private elevator and vulnerable points along the route will be covered by steel plate. *REC-15 62-587-803*

Of further significance is the fact that polygraph examination of Everett C. Buckner, an employee at the San Gabriel Valley Gun Range, shows much of the information furnished by Buckner was false. You will recall that during the initial stages of our investigation, information was developed that Sirhan, while firing at this gun range the day prior to the shooting, had conversed briefly with an attractive blonde. Buckner indicated he overheard the blonde tell Sirhan to "get out of here or they will recognize us." We have located the woman in question, Claudia Jones. *CALIF*

## HOFFA ALLEGEDLY PLOTTED AGAINST KENNEDY IN THE PAST

We have received information concerning alleged threats made in the past by James Riddle Hoffa against Senator Robert F. Kennedy. Investigation thus far has not shown any link between Sirhan Sirhan and Hoffa.

One development in this regard concerns a television interview about three months ago at Baton Rouge, Louisiana, wherein William Hawk Daniels, formerly with the East Baton Rouge, Louisiana, Parish District Attorney, discussed remarks made by Edward Grady Partin concerning an alleged Hoffa plot years ago to assassinate then Attorney General Robert Kennedy. (Partin is the unsavory Baton Rouge teamsters official who was the Department's chief witness in the 1964 trial which resulted in Hoffa's conviction for Obstruction of Justice.) The Criminal Division advised us that on 6/4/68 (the day before Senator Kennedy was shot) Don George, employed by attorney F. Lee Bailey to investigate Partin's activities, requested the television station to furnish him a copy of the video tape relating to Daniel's appearance.

Partin has not been interviewed since Kennedy was shot to determine whether he has any specific information implicating Hoffa. Likewise, George has not been contacted to determine if there is any significance in his request for the video tape on the day before the assassination. ST-113 62-587-804

A related development is information from a convict, Edward Hugh Pole, that while he was at the Lewisburg, Pennsylvania, Federal Penitentiary around Memorial Day, 1967, he heard Hoffa say at the dinner table, "I have a contract out on Kennedy and if he ever gets in the primaries or ever gets elected, the contract will be fulfilled within six months." Thus far, we have not located anyone else who heard this remark. Hoffa's regular dinner companions are Samuel Desist, a narcotics violator, and Anthony Provenzano, a former teamster's official. They have not been interviewed.

### OBSERVATIONS

While investigation has uncovered no evidence of a connection between Hoffa and Sirhan Sirhan, we should, nevertheless, bring this development to the Department's attention. Since Hoffa is appealing his convictions, any attempt to interview him or his close associates should be cleared by the Department. Accordingly, we should ascertain whether the Department desires us to interview Partin, George, Hoffa or any of Hoffa's close associates such as Provenzano or Desist.

### ACTION

Attached is a letter to the Attorney General with copies to the Deputy Attorney General, Assistant Attorneys General Vinson and Pollak and Special Assistant to the Attorney General Lynch asking whether attempts should be made to interview Edward Grady Partin, Don George, James R. Hoffa or any of Hoffa's close associates such as Anthony Provenzano or Samuel Desist, to see if they have any information regarding the assassination of Senator Kennedy. PA
