

APPENDIXW. E. B. DU BOIS CLUBS OF AMERICA (DCA)

A source advised that on October 26-27, 1963, a conference of members of the Communist Party, USA (CPUSA), including national functionaries, met in Chicago, Illinois, for the purpose of setting in motion forces for the establishment of a new national Marxist-oriented youth organization which would hunt for the most peaceful transition to socialism. The delegates were told that it would be reasonable to assume that the young socialists attracted into this new organization would eventually pass into the CP itself.

A second source has advised that the founding convention for the new youth organization was held from June 19-21, 1964, at 150 Golden Gate Avenue, San Francisco, California, at which time the name W.E.B. Du Bois Clubs of America (DCA) was adopted. Approximately 500 delegates from throughout the United States attended this convention.

The second source advised in September, 1966, that Mike Zagarell, CPUSA Youth Director, stated that in Negro communities the Party still supported the plan to build "left" socialist centers and to solidify the Party base through the DCA. This source also advised in September, 1966, that Daniel Rubin, CPUSA National Organizational Secretary, stated the Party believes the DCA should have a working-class outlook and be a mass organization favorable to socialism, socialist countries and Marxism, and in April, 1967, advised that Gus Hall, CPUSA General Secretary, indicated the DCA primary emphasis should be on developing mass resistance to the draft.

A third source advised in September, 1967, that Jarvis Tyner was elected chairman of the DCA on September 10, 1967, at the Third National Convention of the DCA held in New York, New York, from September 8-10, 1967.

A fourth source advised during August, 1967, that Jarvis Tyner is a member of the National Committee of the CPUSA.

A fifth source advised on September 21, 1967, that the headquarters of the DCA is located at 34 West 17th Street, New York, New York.

Miss ELSA MARIE BUTLER, 1673 North Golden Gate Avenue, Los Angeles, California, advised that she has been employed as a belly dancer for the last 11 months at The Fez, 1508 North Vermont Avenue, Los Angeles, California.

She stated that this is a restaurant which caters to many persons of Arabian descent. It is owned by LOUIS SHALEBY who is also known as LOUIS SHELBY. SHALEBY resides on North Berendo Street, Los Angeles, and has telephone number NO 3-2649. She said that many of the employees and customers have been vociferous in their animosity toward Israel. She noted that Mr. SHALEBY has never expressed any such animosity.

Miss BUTLER has learned that a number of employees and belly dancers have been questioned concerning their associates as a result of the assassination of Senator ROBERT F. KENNEDY. One of the girls so questioned was PHYLLIS YOUNG who is also known as PENNY and is of Jewish descent.

On the night of June 4, 1968, Miss BUTLER came to work at 8:00 p.m. At about 1:00 a.m., June 5, 1968, customers entering the restaurant mentioned that Senator KENNEDY had been shot. There is no television or radio in this restaurant and all information obtained was furnished by customers. When Miss BUTLER verified the fact that a shooting had taken place, she became very despondent and terminated her act. At about the same time, she observed the manager of the restaurant who appeared to be very elated about the news.

The manager is MACHMOUD SIAM who is also known as MIKE. She said that he was clapping his hands and encouraging singing in Arabic. She could not understand the meaning, but noted that the song ended with the Arabic word, "Yehudi" which means, "Jewish". In addition, SIAM stated in English that he was glad that the shooting had occurred and made a statement that he believed the Jewish people had done this.

Miss BUTLER described SIAM as about 30 years of age, good looking, medium complexion, five feet eight inches in height and has eyes which are almost blue. His hair is curly and medium length, and he speaks with a heavy accent. She believes he immigrated to the United States at least five years ago. He resides in an apartment in Hollywood with a younger brother. She believes he was previously married to a school teacher and is either divorced or separated.

She noted that there was quite a bit of discussion among the employees concerning the shooting and that they were all furnishing their beliefs as to the reasons. The bartender, SAM YASIR (phonetic) expressed the belief that the shooting had been perpetrated by the Catholics.

Miss BUTLER said that although a number of Jordanians have frequented this restaurant she has never known SIRHAN BISHARA SIRHAN to be a customer. She said that SIRHAN's brother, ADEL had previously worked at The Fez as an oud player. She stated the oud is a musical instrument similar to a lute and is used to accompany the belly dancers. ADEL left this employment in July, 1967.

Another brother, SHARIF, is a regular customer at The Fez.

She noted that ADEL SIRHAN formerly dated a dancer named MYLENE KAY (phonetic). Miss KAY is an Australian who possibly knows the entire family and who is believed to be currently employed at the Barefoot Bar, Vacation Village, Mission Bay, San Diego.

Miss BUTLER stated that The Fez is usually closed on Mondays only. She stated that The Fez has not reopened since the night of the assassination of Senator KENNEDY. Mr. SHALEBY told her that it was not necessary to report for work until Tuesday, June 11, 1968. He said that he was closing the restaurant temporarily because of the animosity expressed among the customers and employees and he said that it was unsafe to remain open. She stated that SHALEBY is of Eastern Orthodox religion and appeared to be ashamed and upset about the assassination.

Miss BUTLER noted that because of the intense nationalism expressed by the customers and employees the atmosphere of The Fez has been most conducive to fights. She stated that under the current conditions she does not feel that she could return to The Fez. She expressed her sentiments to Mr. SHALEBY at which time he implied that MACHMOUD SIAM would not be returning to his employment.

Miss BUTLER stated that she felt the authorities should be aware of the atmosphere among the employees and the customers of The Fez. She could furnish no further information concerning SIRHAN or his family but expressed a willingness to assist in any way possible noting that she is acquainted with most individuals employed as musicians and dancers in the Arabic community.

ELSA MARIE BUTLER was born [REDACTED] at Toronto, Canada. She is a derivative citizen and her parents, JOHN HAROLD BUTLER and PHYLLIS BUTLER, reside at 2036 Clark Avenue, Long Beach, California. Miss BUTLER's stage name is "FEIROUZ".

MIKE SAID SIAM was interviewed at his residence, 5555 Carlton Way, Number 202, Hollywood, California. SIAM advised that he was born in Palestine on [REDACTED] He is described as a white male, 5'7", 130 pounds, blue eyes, brown hair.

SIAM advised that he was acquainted with the SIRHAN family because he had worked at the "Fez" restaurant with ADEL SIRHAN, the brother of SIRHAN SIRHAN. He stated that he had met the entire family when the sister died sometime ago and that he has been in the SIRHAN home on several occasions.

SIAM advised that he had seen and talked to SIRHAN SIRHAN several times during the year 1967 when SIRHAN was employed at the Santa Anita Race Track. He stated that he saw him around Christmas time 1967, when he had dinner at the SIRHAN home. He stated that during this visit to the family home he had no discussion whatsoever with SIRHAN and he found him to be a very quiet, serious individual who spoke very little. He stated also that on the occasions when he saw SIRHAN at the race track in 1967, their only discussions were concerning either horses or their families and that they never, at anytime, discussed any politics or ideologies. The visits at the race track always occurred on Saturday. He said that SIRHAN never impressed him as being an individual of a violent nature and that he seemed to be only a quiet, reserved individual who had always been polite and well mannered.

SIAM advised that he had not seen SIRHAN since the Christmas season of 1967 when he had dinner with the SIRHAN family, but he stated that he occasionally saw ADEL and SHARIF, two of SIRHAN's brothers, as they visited the "Fez" restaurant from time to time. He stated that ADEL had been employed at the "Fez" at one time as a musician but that he

quit because the girl he was going with at the time was let go because of their association. SIAM stated that it was a policy of the restaurant that the employees were not to fraternize with each other.

SIAM advised that he could furnish no further information concerning the personality or character of SIRHAN SIRHAN, but that if something came to his mind in the future that he thought might be pertinent he would notify the Los Angeles Office of the FBI.

CHARLES HARB, Harb Shoe Service, 806 $\frac{1}{2}$ South Alvarado, Los Angeles, California, was contacted at his place of business and voluntarily advised as follows:

He has known ADEL SIRHAN and SHARIF SIRHAN for approximately five years from his frequenting the Fez Restaurant, 1508 North Vermont Avenue, Los Angeles. ADEL played a guitar at the Fez, and SHARIF would occasionally visit the Fez with ADEL.

He advised his relationship with ADEL and SHARIF was limited to meetings at the Fez and he never saw either of them away from the Fez. He considered ADEL and SHARIF as acquaintances but did not consider them as close friends. He has never engaged in any political or world affairs discussions with either of them.

HARB advised that when he heard Senator ROBERT F. KENNEDY had been shot by a SIRHAN, he wondered if it could have been ADEL or SHARIF, because of the similarity of the last name. He discussed this matter at his place of business and it is possible someone believed he was a close friend of the SIRHANS. When he later saw a photograph of SIRHAN SIRHAN on television and in the newspaper, he immediately knew the alleged killer was not ADEL or SHARIF SIRHAN. He stated he did not know ADEL and SHARIF had another brother, as they had never discussed having another brother and he never heard them mentioned SIRHAN SIRHAN.

HARB stated he has not seen ADEL or SHARIF for about three months, as HARB has not visited the Fez for about three months.

SHAFIK KRADSHEH, Instructor in the Arabic Department, Defense Language Institute (DLI), Monterey, California, furnished the following information:

KRADSHEH has been an instructor at the language school since November 1962. He was born at Nadaba, Jordan, on [REDACTED]. He came to the U.S. in October, 1953, and after living in Pasadena and Los Angeles, California, from 1953 to 1962, he came to teach at the Monterey Language School. KRADSHEH received his U.S. citizenship on January 4, 1963.

KRADSHEH advised that while he was attending Pasadena City College in 1957, he was introduced to SHARIF SIRHAN at Pasadena. He advised that SIRHAN was a recent immigrant from Jordan who had arrived in the U.S. with an older brother, SAADALLAH SIRHAN. KRADSHEH does not recall whether he ever met SAADALLAH SIRHAN. KRADSHEH stated that he had no knowledge of any member of the SIRHAN family from Jordan, but only came in contact with them for the first time in Pasadena in 1957. He said he was an occasional acquaintance of SHARIF SIRHAN and never developed any close friendship with him.

He stated that SHARIF SIRHAN, in his opinion, did not express any extremist views on the Arab-Israeli question, or the relationship of the U.S. foreign policy to this question, but always appeared to take a moderate position on the matter, insofar as KRADSHEH is able to recall. KRADSHEH has no knowledge of any organization to which SHARIF SIRHAN might have belonged during the period of their acquaintance. KRADSHEH stated that to his knowledge SIRHAN had no connection with any Palestinian nationalist organization back in Jordan. KRADSHEH does not recall ever having met SIRHAN BISHARA SIRHAN.

In 1963 KRADSHEH, who at that time was living in Monterey, California, traveled to Pasadena with his uncle, MAJED QUOSSOUS, who was visiting from Jordan. MAJED QUOSSOUS knew the SIRHAN family from Jordan. KRADSHEH stated that his uncle knew the family much better than he, himself, did. They traveled to the residence of the SIRHANS in Pasadena and visited with Mrs. SIRHAN briefly. At that time none of the other members of the family were home. KRADSHEH's uncle, MAJED QUOSSOUS, returned to Jordan shortly thereafter and is presently residing there. The last time KRADSHEH saw SHARIF SIRHAN was around 1958. Other than the brief visit in 1963, KRADSHEH has had no other contact with the family.

Mrs. BESS JACOBS, 2149 North El Molino, wife of JOSEPH E. JACOBS, advised that approximately 11 years ago while residing on Walworth Avenue, Pasadena, she and her husband met a Jordanian woman whom they have just now discovered was the mother of SIRHAN BISHARA SIRHAN.

Mrs. JACOBS related that this one and only meeting with Mrs. SIRHAN occurred at a Market Basket Food Store on Lake Avenue, in Pasadena. She explained that it was on this occasion she and her husband overheard Mrs. SIRHAN speaking Arabic to her young son as they proceeded down the super market lanes.

Mrs. JACOBS stated that although both she and her husband are native born Americans they are both of Syrian heritage and are fluent to a limited degree in Arabic. She related that as she and her husband reached the end of the lane paralleling that of Mrs. SIRHAN they introduced themselves to her and inquired if she might possibly be Syrian. She stated that after the introductions the woman, subsequently identified as Mrs. SIRHAN, then informed them that she was Jordanian and had been in the United States for a very short time.

Mrs. JACOBS explained that her own son, JOSEPH, age 20, formerly attended Longfellow Elementary School with SIRHAN BISHARA SIRHAN, but never knew them to be friendly even at the age of 8, 9 and 10.

She explained that when SIRHAN was identified on television and in newspapers as the alleged murderer of Senator KENNEDY her husband casually announced to both her and her daughter, DEBBIE, that he thought that he had driven SIRHAN SIRHAN to elementary school years ago on one or two occasions when it was raining.

Mrs. JACOBS stated that there has never been any further contact between members of her family and members of the SIRHAN family.

She recalled that one or two days subsequent to the shooting of Senator KENNEDY both she and her husband viewed a photograph of SIRHAN's mother in the Los Angeles Times after which they concluded that this was the woman whom they had introduced themselves to at the Market Basket Food Store in Pasadena 11 years ago.

ROBERT E. RITCHEY, 1128 North Hill, Pasadena, California, was interviewed at his place of employment "RX Express Company", 298 Henrietta, Pasadena. RITCHEY was advised that he was being interviewed concerning his association with SIRHAN SIRHAN, and he advised that he has known the SIRHAN family for approximately ten years.

RICHEY stated that his first contact with the SIRHANS came in 1958 when a brother, ADEL SIRHAN, began working with him at a company then known as B and L Molding Supply Company in Pasadena, California. He advised that this company has since disbanded. He advised that the SIRHAN family, including SIRHAN SIRHAN, then lived at the corner of Mentor and Washington in Pasadena. He further advised that although ADEL quit the B and L Molding Company in 1961, he still maintained contact with ADEL and the SIRHAN family. He advised that he believes at some time in 1962, the SIRHAN family moved to 696 East Howard, Pasadena.

RITCHEY stated that in July of 1967, he and SAIDALLAH SIRHAN, another brother, moved into an apartment together. The address was 1659 North Lake, Apartment 7, Pasadena. He advised that he and SAIDALLAH lived together through November, 1967 at this apartment. He stated that he moved out following an argument which he and SAIDALLAH had. He stated that SAIDALLAH kept a revolver in their apartment and accused him of stealing this revolver along with \$65.00 in cash. RITCHEY stated this revolver was a .38 caliber, and the barrel was approximately three or four inches long. He advised that he does not know where SAIDALLAH obtained this revolver, but he feels certain it was a .38 caliber because of the size of the bullets. He advised that SAIDALLAH also kept a rifle in a closet of their apartment, but he could not furnish the make or model of this rifle.

RITCHEY stated that SAIDALLAH did not get along with SIRHAN SIRHAN. He advised that as far as he knows, SIRHAN SIRHAN never came to their apartment. He also advised that he does not know of SIRHAN's ever using or having possession of SAIDALLAH's revolver. He advised that he does not know of SIRHAN's having his own revolver.

RITCHEY stated that he was not a close friend or acquaintance of SIRHAN SIRHAN. He stated that he knew SIRHAN through his close friendship with ADEL and SAIDALLAH SIRHAN. RITCHEY described SIRHAN SIRHAN as a "loner" type of individual. He advised that he does not know of any friends of SIRHAN. He stated that every time he saw SIRHAN outside of his residence, SIRHAN was by himself. RITCHEY stated that SIRHAN had a great fondness for race horses. He advised that SIRHAN often went to the Hollywood Park Race Track, but he does not know whether SIRHAN had a job there. RITCHEY advised that SIRHAN once mentioned that he was a close friend of a well-known race horse jockey named MILO VALENZUELA.

RITCHEY advised that SIRHAN asked questions of him concerning politics, but never did discuss politics, or express any political viewpoint to him. RITCHEY stated that he could not remember any of the political questions asked by SIRHAN, or even of what nature these questions were. He stated that SIRHAN was the type of person who asked questions about politics, but never discussed politics. RITCHEY also stated that he remembers SIRHAN telling him "your country is against my country". He advised that SIRHAN never mentioned anything to him concerning Jordan-Israel-United States relations.

RITCHEY advised that he last saw SIRHAN SIRHAN approximately two weeks before the shooting of Senator ROBERT F. KENNEDY. He stated that SIRHAN was by himself on a street near his home in Pasadena, and they did not have any conversation with each other.

Mr DON PAUL STAFFORD, 960 East Washington Boulevard, furnished the following information:

He operates the Johnson Motors Service at above address. He has ~~known~~ the SIRHAN family since they first came here from Jordan, and moved into their first home at 1321 North Mentor Avenue, Pasadena, California, which has since been torn down and is now operated as a parking lot by the City of Pasadena. He believes the SIRHANS arrived in Pasadena in 1957 or 1958. The father, whose name he does not recall, only stayed here for about three months and then returned to Jordan. He believes the father was not in favor of coming to this country to begin with and did not like it here.

He stated the children of the SIRHAN family spoke very good English, which he considered surprising. SIRHAN SIRHAN was about 12 or 13 years old. He stated that SIRHAN SIRHAN had a brother named MUNIR, who had a nickname of "Manure;" another brother who was an assistant to a carpenter; and a sister who was about fifteen at the time. He advised that SIRHAN SIRHAN would come across the street to the service station he operated and visit with him. He stated that SIRHAN had no bitterness at all towards anyone or anything. SIRHAN SIRHAN was interested in becoming a mineralogist or a geologist. SIRHAN SIRHAN was always by himself; was not interested in politics; expressed no discontent with this country; and was "just happy to be here" in this country.

He stated the SIRHANS moved to Lexington Street in Pasadena after the city purchased the house and lot for a parking lot. SIRHAN attended the John Muir High School in Pasadena. He stated that after the SIRHANS moved to Lexington Street, a fourth brother appeared. He did not know his name. The SIRHANS were not an ideal family. The mother had no control over the children.

SIRHAN's sister, name unknown, married a wealthy candy man in Palm Springs, California. Although she lived with him, the man did not recognize her as his wife. The sister became sick with leukemia, and came home to die. The girl told her mother that the husband promised to send the family \$250.00 per month for life. The man actually paid the girl's funeral expenses and sent the family a couple of payments of \$250.00. He believes it highly possible that the family held a grudge against the girl's husband because of the way he treated her. SIRHAN may have been influenced by this. He could furnish no other information.

Mrs. SHIRLEY MC CONNELL, 508 Concha Street advised that her daughter, SUSIE, age 18, and DEBBIE JACOBS, age 17, are classmates and close friends at John Muir High School, Pasadena. Mrs. MC CONNELL related that on Wednesday, June 5, 1968, she picked up her daughter and DEBBIE JACOBS at the JACOBS' residence, 2149 North El Molino Street, Altadena and drove them to school. She advised that shortly after they departed the JACOBS' residence, DEBBIE JACOBS mentioned that her father had driven SIRHAN BISHARA SIRHAN to either John Muir High School or junior high school years ago.

Mrs. MC CONNELL related that DEBBIE JACOBS had further indicated that on one or two occasions her mother and father had met the SIRHAN family during the period that they resided in Pasadena. Mrs. MC CONNELL stated that she thought that these disclosures by DEBBIE JACOBS were significant in that she understood that the JACOBS' were from some place in the middle east.

Mrs. MC CONNELL stated that she wanted to make it quite clear that she had no reason to believe that the JACOBS' family was in any way involved in the shooting of Senator KENNEDY but could perhaps shed some light on the reasoning behind SIRHAN BISHARA SIRHAN's alleged assault upon Senator KENNEDY. She concluded by stating that through DEBBIE JACOBS she ascertained that all members of the JACOBS' family were deeply shocked on learning that Senator KENNEDY had died.

GEORGE NEME, 1085 Bresee Avenue, Pasadena, California, was contacted at his residence, where he voluntarily advised as follows:

He has known SAIDALLAH (SAID) SIRHAN, brother of SIRHAN SIRHAN, for approximately one and one-half to two years, as he and SAID were both employed as machine operators at Michael Ganguin, Incorporated, 53 West Union Street, Pasadena.

NEME stated that because of his limited knowledge of the English language, he (NEME) never engaged in any political discussions with anyone at work. He stated he had very few discussions with SAID SIRHAN and never talked politics or world affairs with him.

NEME advised he has not worked or seen SAID SIRHAN for over six months, as he (NEME) had a cancer operation about six months ago and has been bedfast ever since the operation.

The Las Vegas Division of the FBI furnished the following information:

Mrs. MARTHA HAUKE, Deputy, Ormsby County, Clerk's Office, Carson City, Nevada, on June 6, 1968, advised that MUNIR SIRHAN, who she knew as JOE and a brother of SIRHAN B. SIRHAN, was hired by her as a stock man at Nash Department Store, Pasadena, California in about July 1967. She stated he was in this employment when she left that store in October 1967. She advised that she had been employed as Assistant Personnel Manager with Nash Department Store and described MUNIR SIRHAN as a wonderful person who was very pleasant, a good worker, very polite, and had no violent reactions and appeared very sane to her.

Mrs. HAUKE stated MUNIR SIRHAN was single and resided at 696 East Howard Street, Pasadena. She stated that she had never seen or met any of MUNIR SIRHAN's relatives and knew none of his brothers, but recalled that he had a sister who had been very ill.

Mrs. HAUKE stated that MUNIR SIRHAN had previously been employed by the Nash Department Store and had left for two or three years and returned in 1967. She stated she had the impression when he first left this employment, he was involved in some kind of trouble, but that she had had no trouble with him in the store. She stated he appeared to be very popular with other Nash store employees.

Possibly nine or ten years ago, Mr. HALDON LILLENAS (who has been deceased five or six years) had traveled to Jordan and had helped SIRHAN SIRHAN's father transport his family to the United States. He stated that after they arrived in Pasadena, California, about nine years ago, they attended this church for about four Sundays, and then they transferred to another church. The only other information he could furnish was that he had heard SIRHAN SIRHAN's father had a quick temper.

Reverend TIPPETT advised that the above information is all he could furnish concerning this matter.

On June 11, 1968, Mr. RALPH W. HORNBECK, Assistant Superintendent for Instruction, Pasadena Unified School District, stated he was the principal at Longfellow Elementary School, 1065 East Washington Street, Pasadena, in 1958 and 1959.

He recalled at this time, SIRHAN SIRHAN was in the seventh or eighth grade at Marshall Jr. High School in Pasadena, and his brother, MUNIR SIRHAN, was a student at Longfellow School. Mr. HORNBECK recalled SIRHAN transferred from Marshall to Eliot Jr. High School later on because his family had moved. MUNIR would get into trouble from time to time, mainly for fighting with other students who teased him about his name, and the fact that he was foreign. At this time, Mrs. MARY SIRHAN spoke very little English, according to SIRHAN, who took it upon himself to visit Mr. HORNBECK on several occasions to discuss his brother. He stated SIRHAN continually emphasized the honor of his family and stated it was important to preserve this, which he felt MUNIR was threatening by his actions. Mr. HORNBECK recalled SIRHAN as very intense and said SIRHAN would visit him from time to time without any particular incident having occurred in which MUNIR was involved. Mr. HORNBECK could not recall whether SIRHAN visited him during more than one school year, but stated he had never seen SIRHAN after MUNIR left the school in which he was the principal.

Mr. HORNBECK did not recall ever talking to Mrs. SIRHAN and said if he did, it was very briefly.

Mr. HORNBECK stated it was possible, concerning SIRHAN's alleged shooting of Senator ROBERT F. KENNEDY, that in SIRHAN's mind, his action was a matter of honor regarding his people or his beliefs, and would be the type who would totally ignore the opinion of the millions who would condemn his act, if he felt he was acting honorably.

On June 11, 1968, Mr. SAMUEL SOGHOMONIAN, Social Science teacher at Pasadena City College, Pasadena, California, advised he had taught SIRHAN SIRHAN in English and Social Studies for ten hours a week during the 1959-1960 school year when SIRHAN was attending Eliot Jr. High School, 2184 North Lake Street, Altadena, California. Mr. SOGHOMONIAN stated that at that time, Eliot was a 100% Caucasian school and as a result, SIRHAN, being of swarthy complexion and foreign, stood out. He was more or less a loner but very obedient and tractable. He was motivated, and did well academically. Mr. SOGHOMONIAN considered SIRHAN to be intense and with good self-discipline. The other students teased SIRHAN somewhat, and did not mingle too much with him. This did not seem to bother SIRHAN and in fact reinforced his feeling of superiority over the average student. Mr. SOGHOMONIAN stated that he was of Armenian extraction and was quite friendly with SIRHAN, understanding his problem as a foreigner. He stated a possible reason for SIRHAN's action in shooting Senator ROBERT F. KENNEDY might be based in his background of Arab culture, as the Arabs are a very intense and loyal people, with a strong drive to accomplish that in which they believe. He believed their old fashioned philosophy of an "eye for an eye" might have made it logical in SIRHAN's mind to act as he did. Mr. SOGHOMONIAN stressed that this was only surmise on his part.

Mr. SOGHOMONIAN stated he had not seen or heard from SIRHAN after 1960, and was not aware he had attended Pasadena City College. He knew of no Arab club or group of any kind on the campus, but stated he was aware there were such clubs on the campuses of California State College, Los Angeles; University of Southern California; and University of California at Los Angeles.

Mr. MARCUS LE GRAND YOUNG, who resides at 11062 East Andrews Street, South El Monte, California, was interviewed at the John Muir High School in Pasadena, California. Mr. YOUNG advised that he is a teacher in history at that high school and that he is also the Commander of the Cadet Corps. He explained that the Cadet Corps at John Muir High School is similar to a high school ROTC program, except that it is run and financed by the state instead of the Federal Government. He also stated that the Cadet Corps is under the direction of the California State Adjutant General and receives the money for equipment and uniforms and supplies through the State National Guard and Adjutant General's Office. He further stated that in this Cadet Corps, the boys receive basic military training in such fields as drill; including the Manual of Arms, military courtesy, first aid, camouflage, map reading and a brief explanation of firearm safety.

YOUNG advised that he could remember that SIRHAN B. SIRHAN had been a member of this Cadet Corps for the three years that he had attended John Muir High School, and he remembered him as a better than average cadet with a good attitude who accepted discipline well and showed potential and ability in administrative positions. He said that SIRHAN was probably a sergeant in the Cadet Corps at the time of his graduation. He stated that he remembered SIRHAN to be a serious individual but did not consider him to be sullen or moody and he certainly would not have thought him to be an individual of a violent nature. He said that he could not remember any display of temper on the part of SIRHAN towards any other student and, to his knowledge, SIRHAN got along well with his fellow corps members and other students and appeared to be a very nice person.

YOUNG advised that in connection with the Cadet Corps, some of the boys who were chosen to be on the Rifle Team were afforded the opportunity for training and practice with the .22 caliber rifle, however, he advised that SIRHAN

She advised that the student fills in the date at the left hand corner, marks whether they have a parent or guardian and writes their parent's or guardian's name. She advised that the student has the card during the day while in each class. She advised that at the end of the day the student returns to his first period class and returns the card to the instructor. She advised that the instructor then inspects the card to make sure that all instructors have signed the card and that the student has filled in the appropriate blank.

Mrs. MORE stated that she did not see SIRHAN sign the Program Card.

Mrs. CLAIR SCHWARTZ, English instructor, Blair High School, Pasadena, California, was contacted at her residence, 1320 El Cerrito Circle, South Pasadena, California, telephone Number 255-7864, to arrange an interview in regard to SIRHAN SIRHAN being enrolled in her eleventh grade English class in 1962 at John Muir High School in Pasadena. At this time, Mrs. SCHWARTZ advised that when the newspapers carried the story she had checked the high school records to determine if she had taught SIRHAN. Mrs. SCHWARTZ advised that although she had taught SIRHAN, she could not recall him specifically, for he appeared to be neither a very good student or a very bad student. Mrs. SCHWARTZ stated that she had probably checked many of his composition papers, but she could not recall their contents due to the length of time involved and the many students she has had in the intervening six years. Mrs. SCHWARTZ advised she would not be able to observe handwriting samples and state that they were nor were not written by SIRHAN. DAVID OVERHOLT STEVENS, SR., history student, Stanford University, Palo Alto, California, appeared at the FBI Office and furnished the following information concerning SIRHAN B. SIRHAN:

STEVENS stated that he was casually acquainted with SIRHAN at John Muir High School, Pasadena, California, during the school year of 1962-63. STEVENS was a junior and SIRHAN was a senior. He described SIRHAN as a Palestinian Arab believed to have been born in Palestine or some other Arab State. He recalled that SIRHAN at that time was bitterly opposed to and hated Jews particularly Zionist. According to STEVENS, SIRHAN listened to Radio Havana and he believed him to be pro-Castro at that time. He is not aware of any organizational affiliations of SIRHAN and he has no indication that SIRHAN is a Communist. He has not seen SIRHAN since 1963 and is not acquainted with members of his family.

STEVENS stated that one THOMAS D. GOOD, age 23, was a close friend of SIRHAN in high school and may be able to furnish information concerning SIRHAN's political views and a possible motive for the attempted assassination of Senator KENNEDY. STEVENS recalled that GOOD resided in the 1300 block of Elizabeth Street, east of Lake Avenue and just off Hill Avenue, Pasadena, California, where he had an unlisted telephone number. GOOD reportedly graduated from San Jose State College, San Jose, in 1967.

Mr. DARWIN R. RUSSELL, 1001 Altadena Drive, Apartment 5, Pasadena, California, advised he had taught SIRHAN SIRHAN United States History when he was in the 11th grade at John Muir High School, Pasadena, California in 1962. RUSSELL stated he recalled SIRHAN well and considered him very polite, reserved and sensitive. SIRHAN did not have a language problem. RUSSELL recalled no political or social discussions with SIRHAN. He believed, but was not certain, that there was a boy named TOM GOOD in the same class with SIRHAN, however, he believed he recalled that GOOD and SIRHAN were close friends. He stated GOOD was very anti-government and the closest to being an anarchist in type of any boy of that age he had taught. GOOD's father was reportedly a disabled civil service employee and TOM and his family were apparently bitter as they felt his father had been cheated in his settlement made with the government. GOOD did not like to abide by the rules and was frequently in difficulty. RUSSELL recalled GOOD's favorite authors were ERIC FROMM and ALBERT CAMUS, whom he believed was a French - Algerian writer of a Revolutionary type. He considered GOOD to have been unusually aware politically at that age and believed that if GOOD had been a close friend he could have possibly influenced SIRHAN in his political development.

Mr. RUSSELL stated he had not seen SIRHAN after teaching him in the 11th grade.

THOMAS D. ~~GOOD~~ was located at his place of residence, a rooming house at 22 South 11th Street, San Jose, at approximately 1:30 P.M., June 13, 1968. The interviewing agents identified themselves to GOOD through display of FBI credentials. GOOD advised SAs KIDWELL and SAMPLE that he would not be able to talk to them without first consulting his attorney, one AUBREY GROSSMAN, of San Francisco.

GOOD stated that he would attempt to reach his attorney by telephone and get an opinion from him regarding an interview with FBI agents. He placed a long-distance call to San Francisco with Agents SAMPLE and KIDWELL present, and was informed that Mr. GROSSMAN was not available. SA KIDWELL asked GOOD if the name SIRHAN SIRHAN was familiar to him. GOOD responded that he recognized the name. SA KIDWELL asked him if the name was familiar to him over and above what he had read recently in the press. GOOD replied that it was.

SA KIDWELL informed GOOD that the interviewing agents desired to discuss SIRHAN SIRHAN with him. GOOD stated that even though the topic of interview was to be in connection with his knowledge of SIRHAN SIRHAN, he still would need the approval of his attorney before being interviewed. In conclusion, he stated that he would attempt again to reach Mr. GROSSMAN during the afternoon of June 13, 1968, and upon receiving Mr. GROSSMAN's opinion in this matter, would immediately recontact FBI agents.

Mr. HAROLD J. BENSON, who resides at 3180 Crestford Drive, Altadena, California, phone No. 797-0628, was interviewed at Pasadena City College (PCC) where he is an instructor in the Physiology Department.

BENSON advised that he remembered having SIRHAN SIRHAN as a student in one of his classes while he was at PCC. He stated that SIRHAN sat at a table by himself in the classroom and that he did not appear to attempt to mix with the other students although he was always pleasant, and smiling and treated everyone with courtesy and respect. He advised that during the time SIRHAN was in his class he was not even aware of SIRHAN's nationality and that he did not ever have any discussion of politics or ideologies nor did he ever hear anyone else discussing these things with SIRHAN.

BENSON advised that SIRHAN was an average, or slightly above average student, who was very consistent in his work with perfect attendance and that he did not remember any type of disciplinary problem ever arising. He stated that he certainly would never have thought SIRHAN to be an individual of a violent nature as he always seemed to be even-tempered.

He advised that he did not know of any close association between SIRHAN and any of the other students in the classes and that he, BENSON, never saw him except in the classroom on a teacher-student basis. He stated further that he had no contact with SIRHAN after the semester in which SIRHAN was a student in his class.

On June 14, 1968, Miss NINA TIHOMIROV, Russian teacher at Pasadena City College, Pasadena, California, advised she recalled teaching Russian to SIRHAN SIRHAN in the fall of 1964 and the spring of 1965. She stated SIRHAN was not a very good student, although he appeared to have a natural ear for languages. She said he was frequently absent from class, and always had an excuse relating to working too hard, and part of the time because his sister was dying. She did not recall what his employment was. She stated she gave SIRHAN a grade of D in his first semester of work, and in the second semester, finally dismissed him from class due to lack of attendance. She recalled that as she was dismissing him, she learned he was being dismissed from school for general non-attendance. She stated she had never had any discussions with SIRHAN regarding his political or social ideas. She said he was a very nice, friendly person who was always polite, who sat in the front row in her class and was attentive. She had no further information concerning SIRHAN or why he might have been involved in the shooting of Senator KENNEDY.

Mrs. ANNABEL COONEY, Room 129 C, Pasadena City College, Pasadena, California, residence address 787 East Howard Street, Pasadena, California, advised that both she and her husband, MICHAEL COONEY, reside approximately one block from the SIRHAN residence. Mrs. COONEY advised that neither she nor her husband ever knew the SIRHAN family, but that occasionally a young boy by the name of MUNIR would ride his bicycle up and down the street in front of the COONEY residence and occasionally would drive into the driveway and say hello in a neighborly fashion. Mrs. COONEY advised that the boy had never been in her home and that the conversations between them never went any further than an occasional hello.

She stated that it was rumored in the neighborhood, as told to her by her husband, that a few years ago, in approximately 1965 or 1966, this young boy MUNIR left home to live with an older woman, reportedly twice his age. Mrs. COONEY stated at that time that it was believed by both she and her husband that the boy could not have been any older than 15 years of age. It was later rumored that there was a death in the family, a sister, and that MUNIR was so upset at the loss that it shocked him into returning to the family. Mrs. COONEY advised that as far as she knows this boy has never wandered from his parents' home since. She advised that she has never seen any other member of the family and that she never saw the boy MUNIR since his reported return. Her only knowledge of him was as a young boy riding his bicycle on the block.

Mrs. COONEY advised that she was unaware of the fact that MUNIR had an older brother and that she does not remember having SIRHAN SIRHAN in her English class at anytime. Mrs. COONEY furnished her seating chart for the fall semester of 1964 and advised that SIRHAN SIRHAN was not listed as a student of hers during that semester.

The English 1A class is large and very impersonal and since SIRHAN attended infrequently, she knew nothing more about him other than to recognize his picture and his name.
