ALLEGATIONS BY EDWARD HUGH POLE CONCERNING JAMES RIDDLE HOFFA

Reference is made to Denver's communications dated June 14 and June 17, 1968, which set forth in detail results of the interview with Edward Hugh Pole on June 14, 1968, concerning the fact that James Riddle Hoffa had been overheard by Pole around Memorial Day, 1967, at the breakfast meal, Lewisburg Penitentiary, to make the statement "I have a contract out on Kennedy and if he ever gets in the primaries or ever gets elected, the contract will be fulfilled within six months."

Attached is a copy of a communication from the Criminal Division setting forth the Department's response to the Bureau's request as to whether Hoffa or his associates should be interviewed.

In connection therewith immediate investigation should be initiated along these lines to include interviews of Hoffa, Samuel Desist, Anthony Provenzano and others who may be associated with Hoffa at the Lewisburg Penitentiary. Consideration should likewise be given to reinterview of Pole who made the original allegation.

Additionally, interviews should be sought with Edward Grady Partin and Don George.

NOTE

In connection with our investigation into the assassination of Senator Kennedy, information was developed regarding statements attributed to Hoffa while at Lewisburg Penitentiary on Memorial Day, 1967. Desist, who is serving an 18-year term for narcotics, as well as Provenzano, a former Teamsters' official who is serving seven years for interference with interstate transportation, have been named by prison officials as table mates of Hoffa.

In addition, information has been developed indicating Partin, an unsavory Baton Rouge, Louisiana, Teamsters' official who was the Department's chief witness in the 1964 trial of Hoffa which resulted in his conviction, had made remarks several years ago to the effect that Hoffa planned to assassinate Senator Kennedy. The Criminal Division on 6/4/68, the day before Kennedy was shot, advised Don George, employed by attorney F. Lee Bailey, had been attempting to locate video tapes wherein reference was made to Partin's statements.

In accordance with the Criminal Division's communication, investigation is being ordered.


