President that he would be assassinated before Christmas 1963! You answered me that the Bureau did not have the authority to conduct an investigation based on my letter. Do you not think, Mr. Hoover, that before your death you should tell the world the truth? You, sir, know the truth and you also know, as well as I do, who was behind the conspiracy! I entreat you to tell the truth to the whole world before you die. You know what the truth is!

Please let me have the address of Lee Harvey Oswald's mother, if you can. I would also like to ask you to ask the Postmaster General in Washington the name of the person who received my airmail communication on November 21, 1963.

I would like to hear from you as soon as possible. As always, I remain

PURCHASE OF BOOKS BOOK REVIEWS

Re Bureau letter to Los Angeles dated 12/4/68. regarding purchasing a copy of the book "Kennedy and Sirhan... Why?" written by MOHAMMED T. MEHDI and published by the New World Press.

A copy of referenced letter is enclosed to New York for information.

On 12/28/68, SA LESLIE F. WARREN observed that MEHDI appeared as a guest on the Joe Pyne Show aired on KTTV, Channel 11, Los Angeles, 10:30 P.M. to midnight. MEHDI had presented a copy of his book "Kennedy and Sirhan ... Why?", a paperback, to PYNE, who reviewed it and questioned its contents. In substance, MEHDI alleged that SIRHAN SIRHAN, who is charged with the murder of Senator ROBERT F. KENNEDY, was a victim of the ill-treatment of the Arabian countries by the United States and other countries in establishing the state of Israel from Arabian territory. Further, that the subsequent support of Israel by the United States and particularly President JOHN F. KENNEDY and Senator ROBERT F. KENNEDY, at the expense of Arabian countries, was largely responsible for SIRHAN's actions.

JOE PYNE challenged MEHDI on his allegations which resulted in some explosive comments on the part of both. MEHDI brought out that the book was in the process of being published and was expected to be released in the MoesBURG immediate future.

SA WARREN on 1/3/69, ascertained by unidentified telephone calls to Pickwick Books, 6743 Hollywood Boulevard, Los Angeles, telephone 469-8191, and World Book and News Company, 1652 North Cahuenga Boulevard, Los Angeles, telephone 465-4352, that the book "Kennedy and Sirhan...Why?" was not on the market. Further, that the book was known to both firms, who had received calls on it as a result of its review on the Joe Pyne Show on television. A recontact by unidentified telephone call to the Pickwick Books on 1/16/69, disclosed that the book was not in distribution yet and it was not known when it would be. On 1/16/69, a personal pretext inquiry with a man managing World Book and News Company disclosed that although this company eventually expected to handle the book in question, they had not received any copies and had no knowledge when they would receive copies for sale.

Both of the above book stores are two of the principal distributors of books, particularly paperback novels, in the Los Angeles area. On 1/16/69, an unidentified telephone call to California Magazines, Incorporated, 2219 South Union Avenue, Los Angeles, telephone 747-9563, one of the major distributors of paperback books in the Los Angeles area, resulted in the stated fact that this firm had not been aware of the book written by MEHDI.

On 1/3/69, an unidentified telephone call to a female secretary in the office of the Joe Pyne Show, KTTV, 5746 Sunset Boulevard, Hollywood, California, failed to reveal when the book "Kennedy and Sirhan...Why?" would be released. This girl said that Mr. MEHDI had told JOE PYNE that it would be released in the immediate future. She examined the copy which had been given to JOE PYNE and said its cover listed the publisher as the New World Press, 135 East 44th Street, New York, New York, 10017. It was a paperback and had the price thereon as \$1.95. She did not know the whereabouts of Mr. MEHDI, whether he was in Los Angeles, New York or where.

In view of the above, New York is being requested to attempt to obtain a copy.

Los Angeles indices contained no references identifiable with the New World Press. Several references identified MEHDI. The "Los Angeles Times," page G-4, 6/9/68, in an article regarding the assassination of Senator ROBERT F. KENNEDY, referred to Dr. MOHAMMED T. MEHDI as Secretary of the Action Committee on American Arab Relations in New York, who made comments on the background of SIRHAN. Other sources listed the address of the above committee as 441 Lexington Avenue, New York City, New York.

# **GREENE** FOGEL Rebeca

A friend was hit and run the day before yesterday. I don't know what her condition was, all I know is that she was hit by a car. It started all the way back from New Orleans, I mean she was my room mate in New Orleans. She knew everything that was going on, she knew the harassment I had been subjected to and I'm sure that she had been interrogated herself. I don't think she is dead though. I think this is where Mr. GREENE is mistaken because I called New Orleans yesterday to try to find out what happened to my coat and boots that I asked to be shipped here and all the friend of mine could tell me was that the young lady had been hit by a car and that she was not dead and that she would try to check with the Post Office because she had sent out my coat and that was a month ago.

O'k, we got that clear. Do you know Jim GARRISON?

V:I most certainly do.

G: Have you been talking with Jim GARRISON?

V: I had been talking to his office when I was in New Orleans. Mark LANE came to my apartment at 1227 Royal Street and promised me up and down that no-one would intimidate Mr. GARRISON's doctor and that he would arrange an appointment for me and I can assure you Sir I have never yet to see Mr. GARRISON's doctor. Mr. LANE never called me back.

We had better make it clear to everyone. Now wait a minute. Jim GARRISON is the District Attorney for New Orleans?

He certainly is.

He is the one who is conducting an independent investigation into the assassination of John F. KENNEDY?

V: Which he has ceased almost entirely.

G: And it was his findings and these findings have been borne out that there is a very high rate of death of people who had something to do with the characters surrounding the assassination.

And may I say if you are wondering why I'm still alive I can tell you, because everything I have said is in writing. I mean it is in writing in consulates, in embassies, with persons of of very important positions, writers, authors, what have you. If anything happens to me that even remotely looks like an accident, the F.B.I. knows they are going to be left holding the bag and I can assure you if anything, it is doing everything it can to make sure I stay alove and die only a natural death through my diabetes. They will not let me have an accident.

G: Well now, in your conversations with Jim GARRISON. Did he tell you anything else?

V: Jim GARRISON never told me a damned thing. I talked to Mr. Mark LANE.

G: Who is Mark LANE?

V: Mark LANE is the author of "Rush to Judgement" who did all his co-work with Mr. GARRISON supposedly on this case.

G: And what did he say?

V: He said that he believed me and that he was going to arrange for me to see Mr. GARRISON's doctor.

G: Why Mr. GARRISON's doctor?

V: Because I told him I felt every other doctor that I had been to in New Orleans was being pressured by the Federal Government and that I could not get adequate and proper medical treatment for that which was wrong with me.

G: O'k. Anything else Madam?

U/F: No but it sounds to me as if somebody is using her, I mean to slight the F.B.I. or something.


V: Hah

G: Well I don't know. I am going to be frank with you. I don't believe it because it seems to me first of all Miss VOGOL -

U/F: I just think it seems so unlikely I mean that she would be still alive I mean if -

G: The only thing that concerns me here is that so far Miss VOGOL you have not told us of what proof you have. All you are talking about is just an idea that you have. So you saw Sirhan-Sirhan.

Many people saw him.



G: Just because of an opinion?

V: That is correct and it just so happens this opinion happens to be a correct one I think and this is why I have been subjected to all this harassment. If I was not right they would wipe me off as some kind of a nut and just forget about it, there would be no need to go to all these extremes. I mean I have been thrown out of apartments by people telling me that they know about my case and so forth and so on. Look, do you think the Canadian Embassy was the first embassy I came to for political asylum. I am a Jewess. I went to the Israeli Embassy and you can check this out in Washington with Mr. SAMOIN. He said to me, "yes Miss VOGOL, I know about your case but I am very sorry we cannot help you. We do not dare to offend this administration, we need military and economic aid from them. If we help you in any way we jeopardize our position. Please understand and try to go somewhere else".

G: O'k. Thank you very much. We will be back in just a moment.

G: This is CFRA's Greene Line

U/F: Mr. GREENE. I just had to call. I think its wonderful that you would bring this woman on the programme today.

G: Well the only thing I want to make very clear here to you and to everyone is that I don't buy this at all. I cannot see why any Government and certainly not the United States Government would persecute a person to the extent that Miss VOGOL claims they are doing with here simply because she has an idea.

V: I also have a first hand knowledge of two of the individuals involved in these assassinations having met them personally.

G: Who?

V: Namely Clay SHAW and Sirhan-Sirhan.

G: But you only met Sirhan in a bus. Were you talking to him or -

V: I certainly did not. I was tired, I got off the bus and I went home to bed. Who needs him.

- G: Well what difference would that make whether you had been talking with Sirhan?
- V: Because when I tried to report this incident in Washington when I was up there fighting a compensation case, everyone said to forget about it, don't say anything more, get lost or else you are going to have troubles and I wouldn't forget about it and this is when this agent, Mr. SHARRON came to my apartment on Thursday, July 18, 1968 at 2:30 p.m.
- G: Alright, Clay SHAW. Now Clay SHAW is a man whom Jim GARRISON is trying to have indicted in connection with the murder of John F. KENNEDY.
- V: That's correct.
- G: Where have you met him?
- V: I met Mr. SHAW in New Orleans in several of the bars that I used to frequent although I do not drink.
- G: Well I mean have you talked with Clay SHAW?
- V: Not other than to say hello and good-bye, mostly good-bye, certainly not many hello's. Mr. Clay SHAW happens to be an extremely wealthy individual. I do not travel in his stratosphere so to speak as far as the parties which he threw, which are quite notorious in New Orleans and things of that nature.
- G: Well what about Jim GARRISON now. What's his status in New Orleans now? Is he still the District Attorney?
- V: He is still the District Attorney and very, very much under cover right now. He has completely withdrawn from this regardless of what anybody tells you.
- G: Well he claims that it was an F.B.I. ah an F.B.I. plot too does he not?
- V: No he does not. He wouldn't have the adacity to claim that. It was the C.I.A. that everybody keeps trying to put the blame on. In fact, Mr. SHARRON, when he came to my apartment said the same thing to me. He said "you mean the C.I.A."? I said no Sir, I don't think they have the guts to carry out crime like this. It had to be carried out by some-one who knew they could act with complete impunity and it is the C.I.A. that Mr. Mark LANE has been shooting his mouth off about. They may have had first hand knowledge of it but I can assure you as far as I'm concerned it was the F.B.I.

- G: It seems very strange though that you an individual, you are convinced that you have got everything all solved and you are -
- V: No. I don't have everything all solved Mr. GREENE.
- G: The U.S. Government have gone to a great deal of expense and
- V: A tremendous expense and it would have been just as easy to completely ignore me and let me keep shooting my mouth off but the point was that they wanted to break me, it is as simple as that.

  They wanted to show me that you cannot get away -
- G: Thousands of people in the United States don't believe the Warren Commission, thousands of people, millions of people don't believe the Warren Commission.
- V: But not one of them have ever put it in writing.
- G: Oh sure they have.
- V: Name one that ever mentioned Mr. HOOVER's name personally involved in this?
- G: Well there have been a number of -
- V: My investigation goes back as far as -
- G: books -
- V: No books have ever mentioned Mr. HCOVER.
- G: Yes they have.
- V: Then you better check them out again.
- G: Well how about "Rush to Judgement"
- V: Mentions the C.I.A. Sir and not Mr. HOOVER.
- G: Alright. Thank you very much. Anything else Madam.
- U/F: Well this is probably why people don't stand up and express their opinion.
- V: They're scared.
- G: Well do you believe her from what you have heard?
- U/F: I am not saying I believe one way or the other but I can sympathize with how she isn't listened to. People who, I mean if you are not in the right circle you can certainly be put away very easily or people won't listen to you.
- V: That's right mam, you are perfectly right.
- U/F: You know I just sympathize with her and that is why there are so many people now that won't stand up for their beliefs because it wouldn't do them any good.

Particularly in the United States. A reporter asked Mr. HUMPHREY, Vice President of the United States whether he would replace Mr. HCOVER as Head of the F.B.I. Do you know even Mr. HUMPHREY didn't have the guts to give them a direct answer. I have the article right here. He said he would rather not comment. But Senator Eugene McCARTHY gave them a direct answer and as you can see Senator McCARTHY is no longer in the Presidential race. O'k we will move along. Thank you very much.

G: Greene Line

G:

U/F: Hello Mrs. VOGOL. I am listening very intently to what you have to say and the only thing that I feel as a listener that I would like to ask you - it seems very bizarre to me, its very hard to believe so I can't say I'm a believer but I would like to ask you in view of the things that you are saying, does this make you feel a little afraid of well just what people will think and the fact that maybe you do need some help.

Let me try to explain. I'm somewhat of an offbeat individual as it is, very unconventional to say the least and public opinion has ceased to have any shall we say really strong effect on me for a long time because my relation to society is somewhat of a negative one. I will explain to you what I mean by that. I mean I have seen the world as it is by the so-called standards of society and my contention is that if this is what society can bring the world to well I have two words for them which I would rather not repeat on the air.

U/F: Do you feel yourself then that society is completely wrong?

V: Nobody is ever completely wrong or completely right. I am saying that society has reached a point of self interest, of such extreme self interest that they are going to self interest them right out of this world so to speak into oblivion.

G: So what you are saying, what you are claiming to say and I cannot believe under any circumstances is that the F.B.I. plotted to have all these men assassinated because the F.B.I. was in danger from John F. KENNEDY and Senator KENNEDY?

V: Not the F.B.I. but Mr. HOOVER himself and a personal friend of Mr. HOOVER's -

G: John F. KENNEDY was President for several years and didn't dump HOOVER.

V: \*\*

But he was getting ready to on his 70'th birthday. He did not want to cause any sort of a scandal so what he did was take a law that was definitely in effect at the time that every Civil Servant must retire on his 70th birthday and enforce it and just after John F. KENNEDY's assassination in November, Mr. HOOVER turned 70 in 1964, I don't remember the exact date, he isn't exactly a favourite of mine.

G: Alright. Thank you very much Madam we have to skip out for a moment. Bye-bye.

G: Greene Line. Good-Afternoon.

U/F: I would like to discuss something with your guest there.

G: Go ahead.

U/F: I am just wondering would she object to taking some sort of a psychiatric test?

V: No mam. If you can bring about any psychiatric test you want as long as I have valid witnesses available and Mr. GREENE has already gotten an explanation as to why I wanted witnesses available at something like this.

U/F: Well I was wondering then would Mr. GREENE be willing to follow this up?

G: Oh absolutely.

V: And I would be willing to work with him.

G: We made an appointment with a doctor and for some reason or other

V: The doctor did not show up Sir, get that straight.

G: Yes I know

V: I said the doctor did not show up.

G: That's correct.

V: O'k then let's groove with it.

G: 01k

U/F: Circumstances you know one after the other seem to indicate to me that there is certainly something definitely wrong. I was wondering also Mr. GREENE, I think there is a law that Canada doesn't have to or the immigration department doesn't have to state why they are extraditing an individual. Is that true?

V: Well they are not extraditing me they are just throwing me to heck out of the country.

G: Well I have a letter here from the Director of Home Services

Branch, Canadian Immigration which says, "according to information

- G: received from our local office, your application was carefully considered with regard to education, training, occupational skill level, demand for your occupation, age so forth and unfortunately you were found unable to meet the "norms" of assessment as required under existing immigration regulations.
- U/F: Now what does that mean, Norm?
- V: Thank you Mam. That is a good question. I would like an answer myself.
- G: The statement is not mine.
- V: And Mr. GREENE cannot elaborate and I don't blame him because I certainly didn't understand it either.
- U/F: Well I am a little amazed and a little shocked that all these things could go on, that an individual could be harassed this way. I am not necessarily saying I believe everything not having all the facts that Miss VOGOL has. However, I would be interested Mr. GREENE if you could follow a few of these things up and -
- G: That's right. I think I owe it to my listeners to do that -
- V: You owe it to me too because you said you thought I was some kind of nut.
- G: Well I don't know if I used the word nut. I suspect that you may have a persecution complex Miss VOGOL.
- V: I would have thought so myself until Mr. SHARRON sat in my apartment for two hours Sir. Then it wiped out any doubts I ever had in my own mind about myself.
- G: Well we will carry on after. Thank you very much Madam.
- G: Green Line
- U/M: I think it is very commendable that you have gotten this lady on your programme and given her the opportunity to say what she is saying. I agree fully with her and I have been following the assassinations that have been happening in the States in the newspaper myself and have come to very much the same conclusion as she has and I hope that if she can stay in this country that she may be able to help organize some kind of a committee or group to look into and help keep this type of thing out of Canada.
- V: Sir I have been ordered out of your country by the 30th. of November. I can't even organize myself as much as I would like to contribute anything that I could. Now I want to explain something to you. As an American citizen, a self supporting American

V: citizen and I have now a monthly compensation cheque to prove my claim, I am allowed to stay in Canada for a year and all I had to do is cross the border for 48 hours and then come back once again as a visitor. By all legal rights your authorities had no right, I repeat no right to order me out of this country on the 30th. unless they were under some pressure themselves and I can assure you baby they are.

U/F: Yes I can see -

G: I think we have to put everything in its proper perspective though. Rebeca VOGOL tells us that all this persecution has come about because of her ideas but she says that she met Clay SHAW and she met Sirhan Sirhan but she didn't talk with them on either occasion. I cannot see, as I was saying there are millions of people -

V: Mr. GREENE, if I had one iota of what they considered concrete evidence, I mean before I started shooting my mouth off, how long do you think I would have remained alive, how long do you think these twenty other witnesses remained alive after they shot their mouths off about what they knew and they were actually at the scenes of these murders.

G: Just to interrupt you for a moment. I am looking at a cheque that you just handed to me, Treasurer of the United States from Birmingham, Alabama.

V: Yes that is where post office employees receive their compensation cheques.

G: 0 k.

V: This is to show I am self supporting Sir.

G: Thank you very much Sir. Good-bye.

G: Greene Line. Before we go back to the phones again. There was a great deal of consternation and interest in the City of Ottawa over a story which appeared in Look Magazine, the same one that we are talking about regarding a girl that James Earl RAY was supposed to have met in Ottawa. Are you that woman?

V: No indeed.

G: Do you know her?

V: Wouldn't know her if I fell on her.

G: Did you ever know RAY? Did you ever meet RAY? Do you know anything about him?

V: Only what I heard about him in the bars in New Orleans.

G: Do you think he is the one who killed Dr. Martin Luther KING?

V: I would rather not make a judgement in this case unless I have what I consider more evidence to my own satisfaction. I think he was a pawn. I think he was a dupe. I don't know whether he did pull that trigger. First of all I would like to know what he knows about guns and everything because I want to tell you something, the clown who shot Dr. KING shot at a fairly good distance and had to be a darn good shot, like the same type of individual who shot at KENNEDY, I mean John F. KENNEDY.

G: Alright lets go to the phones again.

U/F: Hello, Mr. GREENE. I would like to tell you that I respect many of your views and I enjoy your show but I would like to say that I feel its terrible the way this woman has been harassed like many other callers.

Well we don't know if she is. She says that she is, we as a matter of fact have checked and we cannot see any RCMP officers out in front.

U/F: Well she cannot get any medical attention and she has been ordered out of our country.

G: Well she has been deported. There seems to be some discrepancy there, it seems a little difficult to understand. I have a letter here which says that she cannot remain here which is very strange because you know almost anyone who comes to this country is allowed to stay.

V: I am self supporting mam. I really wish to stress self supporting, asking not a darn thing from your country other than they treat me as they would any other individual that came.

G: Are you working here now?

No. That is a compensation cheque I showed you because I am too ill to work regardless to how loud a mouth I have I am still too ill to work.

U/F: She has much more than I have because I wouldn't have the nerve to -

- V: Mam, I have been pushed around and the only thing I am interested in now is showing who did this pushing and why. As to whether I live long enough to do this, this is irrelevant to me right now because my health is at that bad a stage.
- G: Alright. Lets move along.
- G: Greene Line?
- U/F: On the remotest possibility that your guest is correct may I ask you from all of us listeners, please be careful. What would we ever do without you.
- V: They wouldn't dare hurt him.
- G: I want to tell you. If anybody ever gets me it won't be the F.B.I. or the R.C.M.P.
- V: It will probably be his wife.
- G: Yeh it will probably be my wife.
- U/F: I would like to suggest that there is a remote possibility that she is correct and please do be careful.
- G: Alright. I will be careful. Thank you very much.
- G: Greene Line
- U/F: I was just wondering if the lady had received any reason why she was deported out of Canada.
- G: Well I just read part of the letter she received signed by the Director of the Home Services Branch and in effect it says she was found unable to meet the norms of assessment as required under existing immigration regulations.
- V: I would like Mr. GREENE to read the other letter that preceeded it by only a week. When I am not a postal clerk I'm an electronics worker.
- G: But you are not working now?
- V: No. I am self supporting. There is no grounds to ask me to leave this country.
- G: Yes but you are not self supporting because you are getting compensation now -
- V: That's right and if they would ever permit me to get the proper medical attention I could go back to work.

G: Yes but if you become a Canadian citizen then your support cheques from the United States cease. Is that not correct?

V: That is not correct.

G: Sure. You become a citizen of Canada and you cannot receive



## L. GREENE - Rebeca FOGEL

A friend was hit and run the day before yesterday. I don't know what her condition was, all I know is that she was hit by a car. She knew everything that was going on, she knew the harassment I had been subjected to and I'm sure that she had been interrogated herself. I don't think she is dead though. I think this is where Mr. GREENE is mistaken because I called New Orleans yesterday to try to find out what happened to my coat and boots that I asked to be shipped here and all the friend of mine could tell me was that the young lady had been hit by a car and that she was not dead and that she would try to check with the Post Office because she had sent out my coat and that was a month ago.

G: O'k, we got that clear. Do you know Jim GARRISON?

V: I most certainly do.

G: Have you been talking with Jim GARRISON?

V: I had been talking to his office when I was in New Orleans. Mr. Mark LANE came to my apartment at 1227 Royal Street and promised me up and down that no-one would intimidate Mr. GARRISON's doctor and that he would arrange an appointment for me and I can assure you Sir I have never yet to see Mr. GARRISON's doctor. Mr. LANE never called me back.

G: Now wait a minute. We had better make it clear to everyone.

Jim GARRISON is the District Attorney for New Orleans?

G: Well I don't know. I am going to be frank with you. I don't believe it because it seems to me first of all Miss VOGOL -

U/F: I just think it seems so unlikely I mean that she would be still alive I mean if -

G: The only thing that concerns me here is that so far Miss VOGOL you have not told us of what proof you have. All you are talking about is just an idea that you have. So you saw Sirhan-Sirhan.

Many people saw him.

V: Now let me say something to you Mr. GREENE. I am telling you that most of this has been my opinion as a personal individual and because of my opinion, I have been harassed to a point where my life has been endangered. I have been harassed to a point where they want me to repudiate -

G: Just because of an opinion?

V: That is correct and it just so happens this opinion happens to be a correct one I think and this is why I have been subjected to all this harassment. If I was not right they would wipe me off as some kind of a nut and just forget about it, there would be no need to go to all these extremes. I mean I have been thrown out of apartments by people telling me that they know about my case and so forth and so on. Look, do you think the Canadian Embassy was the first embassy I came to for political asylum. I am a Jewess. I went to the Israeli Embassy and you can check this out in Washington with Mr. SAMOIN. He said to me, "yes Miss VOGOL, I know about your case but I am very sorry we cannot help you. We do not dare to offend this administration, we need military and economic aid from them. If we help you in any way we jeopardize our position. Please understand and try to go somewhere else".

G: O'k. Thank you very much. We will be back in just a moment.

G: This is CFRA's Greene Line

U/F: Mr. GREENE. I just had to call. I think its wonderful that you would bring this woman on the programme today.

G: Well the only thing I want to make very clear here to you and to everyone is that I don't buy this at all. I cannot see why any Government and certainly not the United States Government would persecute a person to the extent that Miss VOGOL claims they are doing with here simply because she has an idea.

V: I also have a first hand knowledge of two of the individuals involved in these assassirations having met them personally.

G: Who?

V: Namely Clay SHAW and Sirhan-Sirhan.

G: But you only met Sirhan in a bus. Were you talking to him or -

V: I certainly did not. I was tired, I got off the bus and I went home to bed. Who needs nim.

I do not travel in his stratosphere so to speak as far as the parties which he threw, which are quite notorious in New Orleans and things of that nature.

### SIRHAN BISHARA SIRHAN

On June 5, 1968, at 12:15 A.M., Senator Robert F. Kennedy, United States Senate, was at the Ambassador Hotel, Los Angeles, California, celebrating his victory in the primary elections for the selection of a Presidential candidate for the Democratic Party for the forthcoming elections in November 1968. At that time Senator Kennedy was shot and killed, and the assassin was taken into custody. The assassin was identified as Sirhan Bishara Sirhan, and he is presently awaiting prosecution in the custody of the Los Angeles County Sheriff's Office, Los Angeles, California.

The Los Angeles Police Department, Los Angeles, California, was furnished a letter addressed to John Weidner, 1380 North Lake Street, Pasadena, California, from one Mr. Esbes, Poste Restante Utrecht, Bernardplain, Utrecht, Holland, which is believed possibly to have been intended for Sirhan Bishara Sirhan. A copy of the letter, envelope, and a copy of a letter sent by the Los Angeles Police Department to the Hoofdbureau, Gemente Politie, Utrecht, The Netherlands, are attached.

The Los Angeles Police Department are most interested in making a determination as to:

- 1. The identity and background of Mr. Esbes.
- The identity of the person for whom the letter was intended.
- 3. If the letter was intended for Sirhan Bishara Sirhan, all information that might be in the possession of Mr. Esbes concerning this individual.

Enclosed is a copy of a letter which was received by an ex-employer of Sirhan B. Sirhan.

Sirhan B. Sirhan, is in custody of the Los Angeles Sheriffs Office for the alleged assassination of United States Senator Robert F. Kennedy.

We are attempting to determine the authenticity of this letter and also the date it was sent from Holland to the United States. Our crime lab interpreted the post mark as being 21 VI 10, 1968. A clarification of this date is requested.

It is further requested that Mr. Esbes, be interviewed and that all information possible with respect to the writer of this letter and his alleged acquaintance with Sirhan be forwarded to this department.

At present there is serious doubt that said writer knew Sirhan. Investigation thus far indicates this letter is a hoax. Please be assured of our cooperation in all matters of mutual interest.
