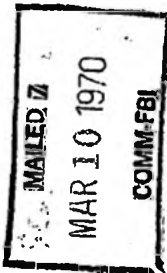

NOTE: A New York source who has furnished reliable and unreliable
information in the past advised that on 2-23-70 Gheorghe Buzdugan,
a Romanian refugee, had furnished information relative to the
death of the late Robert F. Kennedy indicating he knew the
conspirators in Europe who planned Kennedy's assassination.
Among other things he advised he had received a \$10,000 check
from Senator Kennedy shortly before his death. Buzdugan claimed
to have contacted Ambassador Sargent Shriver the day after
Kennedy's death at the American Embassy in Paris and was told to
wait until Kennedy's affairs were put in order before making
further effort to cash the check. The information furnished by
Buzdugan appears to be without foundation, however, we are
checking it out.

EXAMINATION OF HYPNOTIC WRITINGS

(KENSALL)

During the recent American Academy of Forensic Sciences meeting in Chicago, Dr. Seymour Pollack, psychiatrist at the University of Southern California, Los Angeles, presented a discussion of hypnotic writings which he classified as automatic writings.

Dr. Pollack stated that his study followed the claim made in the Sirhan Sirhan trial that the writings in Sirhan's notebook were prepared while Sirhan was under a state of self hypnosis. This claim was successfully refuted during the trial of Sirhan.

Subsequent to the trial, Dr. Pollack conducted experiments concerning automatic (hypnotic) writings. In his experiments he requested that each subject present normal undictated writings prepared prior to the experiment. He also obtained dictated handwriting samples which were written prior to hypnosis. He then obtained dictated writings prepared under hypnosis. Finally, he obtained handwriting samples subsequent to hypnosis.

Dr. Pollack then subsequently presented the handwriting samples to Lawrence Sloan, Sr., document examiner, Los Angeles, with the request that Sloan determine which of the writings were prepared under hypnosis. Dr. Pollack reported that Sloan erred in about 70 per cent of his determinations in labeling as being automatic (hypnotic)

writings certain of the writings examined. This was the result of comparisons with normal writings of the subjects. Sloan also reportedly made 100 per cent error in labeling the writings prepared subsequent to hypnosis as being automatic (hypnotic) writings.

Dr. Pollack appears to be an extremely competent psychiatrist and was very sincere in his discussions. He suggested that Sloan's errors may have been the result of "over predicting," as frequently happens in the psychiatric field. Also, Dr. Pollack stated that he considered the field of hypnotic writings a proper field for experiments.

The above observations would tend to indicate that Sloan may have made a series of speculations in his examinations, that there was an insufficient amount of writings available to suitably permit positive determinations, and possibly that some hypnotic writings cannot be determined from examination.

Immigrant visa number [REDACTED] was issued to GEORGE BUZDOGAN on 8/31/56, and was to expire on 4/30/57. BUZDOGAN entered the US at the Port of Chicago, Illinois, on 3/9/57, and his passport number was [REDACTED]

On 4/21/70, Mrs. ROY WILSON, Confidential Clerk, Chicago, INS Office, advised that BUZDOGAN was required by law to file an alien registration card every year but that he never did so. His file was closed after five years as INS never had any activity on this file.

MARGRETE *MRS. GEORGE*
The only other information contained in BUZDOGAN's INS file indicates that BUZDOGAN allegedly ran up many debts while in Chicago up until 1961 when he allegedly left his wife and two children in Chicago. BUZDOGAN's wife as of 10/9/61, allegedly resided at 824 West Webster, basement apartment, Chicago, Illinois.

The above information concerning BUZDOGAN's activities in Chicago was contained in a series of letters written from 10/9/61, to 3/28/63, to the Chicago, INS Office by Mrs. ROSALIE BERNICE WEBER, 1911 West Berteau, Chicago, Illinois, creditor of BUZDOGAN.

One photograph of GEORG BUZDOGAN was enclosed for NY with referenced Chicago letter.

GEORGE F. A. BOIAN was contacted by SA JOHN J. CRONIN on 5/26/70, and he advised that the photo received with referenced Chicago letter is not identical with GHEORGHE BUZDUGAN. He added that the correct spelling of the name is BUZDUGAN and not BUZDOGAN, and that the description contained in Chicago letter does not match the individual he met.

The article relates that Los Angeles Attorney GODFREY ISSAC filed a complaint against the Los Angeles Police Department (LAPD) and Los Angeles District Attorney's Office on behalf of his client, THEODORE CHARACH. The complaint charges defendants, individual members of the LAPD and District Attorney's Office with supressing facts and evidence relating to the assassination of ROBERT F. KENNEDY. CHARACH later withdrew his complaint to allow the defendent and news media to answer all of CHARACH's framings regarding this matter.

A Letterhead Memorandum (LHM) captioned THEODORE CHARACH furnishing his background was forwarded to the Bureau as an enclosure to Los Angeles Airtel to the Bureau dated 3/29/67, captioned "THEODORE CHARACH, FOREIGN POLICE COOPERATION, BUFILE: 163-17948, LOS ANGELES FILE: 163-1102."

An FD-302 covering interview of TED CHARACH regarding KENSALT investigation appears on page 198 of Los Angeles KENSALT report dated 8/7/68.

The "Free Press" article makes reference to a guard named THANE CESER, who was on duty at the Ambassador Hotel the night that KENNEDY was assassinated. Interview of THANE CESER regarding KENSALT investigation appears on page 75 of Los Angeles KENSALT report dated 6/15/68. CHARACH's name was included in LHM sent as enclosure to Los Angeles teletype to the Bureau dated 12/3/68, captioned KENSALT, LHM captioned "Contemplated List of Witnesses for the Trial of SIRHAN BISHARA SIRHAN" lists potential witnesses listed by Los Angeles County District Attorney's Office.

"Free Press" also makes reference to a DONALD SCHULMAN, KNXT employee, allegedly at Ambassador Hotel on the night of the assassination.

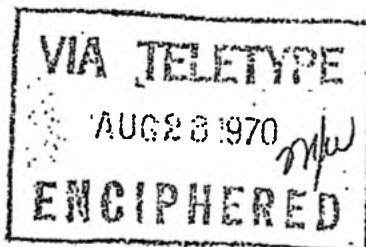

THE COMMANDOS CONCERNED ALLEGEDLY REJECT THE IDEA OF KIDNAPING AN AMERICAN AMBASSADOR IN AN ARAB COUNTRY IN ORDER TO "AVOID THE POLITICAL EMBARRASSMENT" WHICH SUCH AN ACTION WOULD ENTAIL. THE BRITISH SERVICE STATES THAT THIS IS THE SECOND OR THIRD SUCH UNPINNED-DOWN REPORT THAT THEIR OFFICE HAS RECEIVED.

Reference is made to the attached copy of a teletype from New York dated 9-8-70 captioned as above.

At 6:35 p. m. on 9-8-70 the Attorney General (AG) called and in the Director's absence talked with me. The AG stated he is extremely interested in seeing to it that Mary Sirhan, Munir Sirhan, Adele Sirhan and a private investigator traveling with them not be permitted to leave the country. He said they were due to arrive in New York the evening of 9-8-70 at Kennedy Airport and asked that two Agents be sent out there to check into the matter carefully and work with the State Department and Immigration and Naturalization Service to make certain that these people were not allowed to travel beyond New York. They were scheduled to proceed to Athens, Greece, from New York. The AG said that the State Department was instructed to make certain their passports were picked up; however, he was afraid that something might go wrong and wanted the FBI to be present. He asked to be advised of the progress in the matter.

I got immediately in touch with the New York Office and gave instructions to proceed in accordance with the AG's request.

At 7:00 p. m., 9-8-70, the New York Office called the Bureau to advise that the Sirhans' Trans-World Airlines flight from Los Angeles was late and they were not able to proceed to Athens, that steps were being taken at that time to pick up their passports and that the matter was under control. I immediately advised the AG who expressed satisfaction.

This concerns the travel of Mary Sirhan, Munir Sirhan and Adele Sirhan, mother, brother and sister respectively of Sirhan Bishara Sirhan, convicted killer of the late Senator Robert F. Kennedy, and Luke McKissack, attorney for Black Panther Party who may be in touch with Angela Yvonne Davis, currently a top 10 fugitive, to Beirut, Lebanon. The trip ostensibly is to plead for the lives of individuals being held by Guerrilla elements who have hijacked an aircraft. A reliable source has advised Los Angeles that the real purpose of the trip is to attempt to influence Arab Guerrillas to make a request to the United States for the release of Sirhan Bishara Sirhan.

Los Angeles advises that above individuals except Adele Sirhan left Los Angeles 8:45 a.m. 9-8-70 en route to Athens, Greece via New York. New York Port Authority police have advised that the Los Angeles flight as of 1:30 p.m. was over one hour late and they did not feel that the Sirhans and McKissack would be able to make connections with the overseas flight from New York to Athens. Passport official U. S. Department of State (USDS) advised this afternoon that they had received telephone call from McKissack requesting renewal of Sirhan's brother's passport. McKissack and Sirhan's brother are to contact USDS, New York City, upon their arrival in order to make application for renewal of passport. This matter is being followed closely.

Re Los Angeles teletypes to Bureau entitled "KENSALT", dated 9/8/70, and Los Angeles letter to Bureau entitled "MICHAEL ALAN MC COWAN, PRI", dated 5/18/70.

As set forth in referenced Los Angeles teletypes, captioned individual, late during the evening hours of 9/7/70, and early morning of 9/8/70, voluntarily contacted an agent of the Los Angeles Division to advise that LUKE MC KISSACK had made arrangements for MC COWAN, MARY SIRHAN, and ADEL SIRHAN to journey to Aman, Jordan, or Beirut, Lebanon. The SIRHAN's are the mother and brother, respectively, of convicted killer of the late Senator ROBERT F. KENNEDY, SIRHAN BISHARA SIRHAN.

Stated purpose of the trip was for MARY SIRHAN to speak to Arab guerilla elements in Aman, Jordan, and ostensibly plead for lives of individuals then being held by guerilla forces, following their removal off hijacked aircraft in the desert of Jordan.

MC COWAN felt proposed plans of MC KISSACK constituted a grave potential danger to United States relations in the Middle East.

MC COWAN further felt he could be of valuable assistance to Bureau and United States Government by accompanying MC KISSACK, particularly if they were successful in reaching Jordan or Lebanon.

The Bureau and New York were immediately advised of the proposed trip.

Because of the information volunteered by MC COWAN, the New York Office was able to maintain a close surveillance of the activities of the MC KISSACK party, and were kept advised on a timely and continuing basis of the plans, activities, and contacts of MC KISSACK while in New York. MC COWAN was put in touch with agents of the New York Office, which enabled that office to be constantly aware of their plans. In addition, the information furnished by MC COWAN enabled the United States State Department to revoke the passports of MC COWAN and MC KISSACK, preventing them and the SIRHAN's from departing from the United States and entering into activities which might possibly have resulted in embarrassment to the United States Government in the Middle East.

MC COWAN's contact with the New York Division enabled that office to alert the San Francisco Division of the MC KISSACK party's departure from New York on 9/12/70.

Upon arrival in Oakland, California, MC COWAN established contact with agents of the San Francisco Division and continued furnishing information regarding the activity to agents of that office.

While in Oakland, MC COWAN, the SIRHAN's, and MC KISSACK visited with SIRHAN BISHARA SIRHAN in San Quentin Prison.

Upon their arrival in Los Angeles late 9/13/70, MC COWAN advised surveilling agents it was the intention of MARY SIRHAN to return to her Pasadena residence. The surveillance established that MARY SIRHAN, accompanied by LUKE MC KISSACK and his wife NANCY MC KISSACK, did, in fact, proceed to the SIRHAN Pasadena residence.

Upon his arrival at his residence, MC COWAN immediately contacted the Los Angeles Office to reiterate that MARY SIRHAN was proceeding to her residence.

The above activity of MC COWAN from 9/7/70, through 9/13/70, resulted in expenses incurred by him in the amount of \$750. The Los Angeles Division has previously utilized \$400 authorized under SAC authority for payment to MC COWAN for expenses incurred in previous matters of interest to the Bureau.

It is felt that in this particular instance, the sum of \$500 be authorized for payment to MC COWAN to reimburse him for expenses incurred by him in connection with obtaining the information as set forth above.

Bureau permission is further requested to reinstate SAC authority to pay MC COWAN additional funds in the future, on a COD basis for information volunteered, should such be warranted.

LaJeunesse, Jr., of the FBI made the statement to him "The case is still open. I'm not rejecting the 'Manchurian Candidate' aspect of it."

Mr. Kaiser further alleges that Special Agent LaJeunesse heard testimony at the trial of Sirhan Bishara Sirhan by Dr. Bernard L. Diamond, Dean of the School of Criminology at the University of California at Berkeley, and "he seemed convinced that Sirhan was in a trance on the night of June 4."

In prepublication releases Kaiser attributed statements to SA LaJeunesse, Los Angeles, which have been unequivocally refuted.

Attached pertains to review of "Ladies Home Journal" book review of "RFK Must Die". Statements attributed to SA LaJeunesse repeated and Kaiser indicates SA LaJeunesse heard testimony of Doctor Bernard L. Diamond, Dean of School of Criminology, University of California and agreed with Diamond's theories that Sirhan in trance at time of Kennedy's killing.

In further refutation of Kaiser's authenticity, official records show SA LaJeunesse on extended sick leave from March 3 - April 4, 1969, and not present during Diamond's testimony March 21, 24 - 27, 1969.

IN A LADIES' HOME JOURNAL PRE-PUBLICATION OF AN EXCERPT FROM ROBERT KAISER'S BOOK, "RFK MUST DIE", THE FORMER TIME MAGAZINE WRITER ADMITTED THAT HE WAS NOT SURE WHETHER SIRHAN HAD PROGRAMMED HIMSELF TO COMMIT THE CRIME OR WHETHER MEMBERS OF A CONSPIRACY HAD DONE SO. KAISER SAID HE WAS INCLINED TO BELIEVE THERE WAS A "SHADOWY SOMEONE" BEHIND THE 1968 SLAYING IN LOS ANGELES.

KAISER PAID \$34,000 TOWARD SIRHAN'S DEFENSE IN RETURN FOR INTERVIEWS WITH HIM AND PERMISSION TO ATTEND SIRHAN'S SESSIONS WITH A PSYCHIATRIST. HE SAID SIRHAN HAD ASSOCIATIONS WITH EXTREMISTS OF BOTH THE RIGHT AND THE LEFT "AND SOME CONNECTIONS WITH THE SO-CALLED UNDERWORLD."

PROGRAMMING SIRHAN FOR THE CRIME SO THAT HE WOULD HAVE NO MEMORY OF BEING PROGRAMMED HAD A PRECEDENT IN A 1951 CASE IN COPEHAGEN AND WAS THE THEME OF THE PLOT IN THE RICHARD CONDON NOVEL, "THE MANCHURIAN CANDIDATE." KAISER POINTED OUT. HE QUOTES ROGER LAJEUNESSE, THE FBI AGENT IN CHARGE OF THE SIRHAN INVESTIGATION AS CONFIDING:

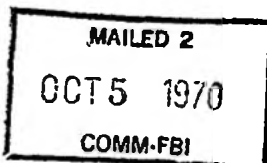

few days, some officers were conducting interviews without ever having seen the pantry, or accurate plans of it.

"A plot, plan, map, schematic, or whatever is applicable, and a brief statement of facts should be laid out, reproduced and made available to every department command, and staff, and to the investigators assigned to conducting interviews," Keene added. Pena recommended a "walk through the crime scene by every officer conducting interviews."

The three supervising officers were also critical of "detective note-taking," and failure to properly describe witnesses. Polaroid photographs would have been useful, serving the same purpose as Keene's recommendation that "there is no place in an operation of this type for handwritten reports." In short, the modern ease of sound tape proved itself.

I would agree with these constructive criticisms of the investigation. In retrospect, anything can be improved. Generally, however, I believe the department responded well in those first hectic, confusing hours. Men like Hughes, Jordan, Sillings, Sharaga, and many others, took the first shock. So did citizens at the scene, men like Dr. Abo, Jesse Unruh, Karl Uecker, Rosie Grier, Rafer Johnson and Juan Romero. They responded without hesitancy.

On July 25, 1969, Special Unit Senator was finally and officially closed out. It had been in existence for more than a year, and the ending marked the completion of the longest, largest and most expensive criminal investigation ever undertaken by the Los Angeles Police Department, possibly the most extensive investigation ever conducted by any local law enforcement agency.

On that date the voluminous SUS files, in four locked

cabinets, were shifted out of Room 803 in Parker Center for storage. Contained in them is more than fifty thousand pages of documentation and material evidence. Evidence too large for the cabinets has been recorded by photography.

The Filing Guide to these records, drawer by drawer, tells the broad story of people, places and events from the birth of Sirhan Bishara Sirhan to the conclusion of his trial. Beyond that, to the final posttrial investigations of the special unit.

The indexed story is a more intimate view into these files and shows, for example, that 4,818 separate interviews and interrogations were conducted. The official correspondence, daily logs, section reports, progress reports, gun and gun-range reports, case preparations, conspiracy-potential investigations seem to be endless. To this small mountain of paper may be added 155 items of booked evidence, 1,700 photographs, 190 reels of tape, and 20 reels of sixteen-millimeter film.

Although I read the reports daily and met constantly with Captain Brown and SUS team heads to explore one aspect or another of the investigation, I was astonished by the sheer mass of the unit's total effort.

Now it has all been boiled down to ten illustrated bound volumes entitled *An Investigation Summary of the Senator Robert F. Kennedy Assassination, June 5, 1968*. These volumes represent my report to the Chief of the Los Angeles Police Department. Two sets will remain with LAPD, and the third set has been forwarded to the Attorney General of the United States.

Throughout the entire SUS investigation, parallel investigations were conducted by the FBI and the District Attor-
