Mrs. HALDOR LILLENAS (LOLA), age 74, 5232 Roe Avenue, Mission, Kansas, advised she and her late husband were sponsors for BISHARA SIRHAN and family. Two oldest children of SIRHAN family remained in Jordan because LILLENAS refused to sponsor them as they were of legal age.

LILLENAS stated she and her husband, who was an ordained minister of the Church of the Nazarene, went on a European vacation in 1955. While visiting in Jordan, BISHARA SIRHAN contacted LILLENAS and inquired as to the possibility of coming to the United States. LILLENAS decided to sponsor the SIRHAN family as their inquiries reflected the SIRHAN family to be a worthy christian family.

Mr. LILLENAS, working through Church World Service and the Friends Organization, became the sponsor of the SIRHAN family and in November, 1957, SIRHAN came to Pasadena, California, and lived in the LILLENAS home for about three months until suitable housing and employment could be obtained.

BISHARA SIRHAN left his family in 1958 and returned to Jordan because he felt living in the United States did not allow him to control his family as in the past. BISHARA SIRHAN wrote letters to his wife requesting her to return to Jordan and if she refused he would obtain a divorce. Mrs. SIRHAN refused to return to Jordan and told LILLENAS since she had been married in the Greek Orthodox Church, no divorce would be granted to her husband.

LILLENAS advised her husband had handled all the responsibilities pertaining to the SIRHAN family and after Mr. LILLENAS died in 1959, she has had only one contact with the SIRHAN family which was in about 1963 when **set a** daughter, died. At this time, LILLENAS saw only Mrs. SIRHAN and she visited for only fifteen minutes. LILLENAS moved from Pasadena, California, to Mission, Kansas, about three years ago and has had no contact with the SIRHAN family since moving to Mission, Kansas.





Dear Sir,

I have a theory on Robert Kennedy's shooting that I would like you to know about. I grew up in Kansas City; I was only vaguely aware of Mafia activities until I roomed with an Italian girl from Kansas City while we were in college. She was at that time dating an Italian boy who was definitely a member of the Mafia. (To my knowledge, she no longer dates him; she was even somewhat afraid to tell him she no longer cared to see him.)

However, one night my roommate and I were intimately talking, and the subject of current events came up. As you know, murderers names are very well-known by all of the Mafia, but never spoken to anyone outside of the Mafia. She said this boy knew the name of <u>Sam Palma's killer</u>, as did many Mafia members. (He didn't tell her so she could truthfully say she didn't know. Also, she didn't want to know.) In addition, my roommate mentioned that it was Mafia knowledge that they had arranged John F. Kennedy's death through Lee Harvey Oswald.

According to my roommate, J.F.K. had made some rather large promises to labor, and had failed to keep them. Also, Robert Kennedy had been too powerful an adversary for organized crime to feel comfortable with. So, the Mafia decided to take action against Robert Kennedy by killing someone very close to him----John F. Kennedy. This, they felt, would serve as a warning to Robert Kennedy not to meddle further with organized crime.

Upon hearing about Robert Kennedy's attempted assassination, it suddenly occured to me that perhaps organized crime had begun to fear Kennedy's ascention to power. They waited until <u>after</u> the crutial California primary to see if Kennedy would be a formidable contender for the Presidency. Another idea that suddenly came to mind was the similar "dead end" backgrounds of Lee Harvey Oswald and the would-be assassin of Robert Kennedy. My roommate had said Oswald had been picked because his background misleadingly pointed to Communism. Surhan's, or whatever his actual name is, background could be misleadingly pointing to the Middle East. It would be convenient for the Mafia to choose a killer who had no criminal record, and therefore no fingerprints on file with the F.B.I.

# Regulations on Visits, Correspondence, Funds, and Packages

## (Revised November 10, 1966)

# 

#### VISITS

- 1. Inmates must request visiting passes not the visitors.
- 2. Visits are not permitted until inmates are assigned to one of the institutions from the Reception-Diagnostic Center (a period of about one month).
- 3. Visitors must have passes and valid identification. Passes are not transferable.
- 4. Visits are permitted daily, except Monday, from 9:00 a.m. to 1:00 p.m. Each inmate is permitted four visits per month.
- 5. No more than two adults and one minor, or one adult and two minors, may visit an inmate at one time. Minors must be supervised properly.
- 6. Visitors may visit only one inmate, except in cases of full brothers or father-and-son relationships.
- 7. When the visiting room is crowded, the number of visitors may be limited, according to the degree of relationship.
- o, Visits in the hospital are limited to two close, adult relatives, and shall not exceed one hour.
- 9. Proposed visitors with criminal records must include this information on the visitors' questionnaire. Decisions will be based on individual cases.
- 10. Visitors shall not bring packages or other articles into the institution.
- 11. Family lunches may be taken to the farms or Fordland, but are subject to inspection.
- 12. Visits to the Fordland Honor Camp are limited to Saturdays and Sundays, from 9:00 a.m. to 1:00 p.m.
- 13. Any visit may be denied on the basis of conduct, use of alcohol, language, improper dress, etc.

#### CORRESPONDENCE

- (a) Mail to inmates at the Penitentiary and the farms must be addressed to the inmate by name and number, Box 900, Jefferson City, Missouri 65101.
- (b) Mail to Fordland Honor Camp must be by name and number. Box 146, Fordland, Missouri 65652.
- 2. Inmates may write two letters per week to approved correspondents.
- 3. Letters to inmates shall contain no more than two pages of regular size, written on only one side of each page. The envelope must carry full name and return address.
- 4. Only approved correspondents may write to inmates,

#### -FUNDS

Do Not send personal checks or cash to inmates. Send only Postal Money Orders, express or cashiers' checks, made payable to: "Treasurer, Missouri State Penitentiary". Address the envelope to the inmate and carry your complete return address on it.

#### PACKAGES, NEWSPAPERS, MAGAZINES

1. Packages may not be mailed to inmates except on special occasions. You will be informed by the inmates when these special occasions occur.

Magazines and newspapers must be mailed directly from the publishers to the inmates.

He said the "man" said he had been arrested by the Los Angeles Police Department, but he did not know what for or when. He said, although he told his brother nothing of the proposition to kill Senator KENNEDY, this man might think he did and might be looking for him to kill him also.

JOHN J. DOOHAN, Head Librarian and columnist, Kansas City Star, 19th and Grand, furnished the following information:

On June 4, 1968, he was attending a newspaper librarian's convention at the Statler-Hilton Hotel, Los Angeles, California. On that evening he and two fellow librarians attending the convention, JAMES SCOFIELD, Librarian, <u>St.</u> <u>Petersburg, Florida, Times</u>, and EDWARD QUILL, Librarian, <u>Boston</u> <u>Globe</u>, went to the Ambassador Hotel in Los Angeles to follow California primary election returns and attend the Senator ROBERT F. KENNEDY rally.

During the evening of June 4, 1968, DOOHAN visited the press room in the Colonial Room of the Ambassador Hotel and attended the rally about midnight at which Senator ROBERT F. KENNEDY spoke. About 1,000 persons were in attendance and he became separated from his two associates. In order to meet the fire department regulations the Embassy Room where the rally was held was closed and the overflow crowd was sent he believes to a room on a lower floor, possibly the Ambassador Room. While he had been in the press room he learned that Senator KENNEDY would visit the press room at the Colonial Room after he spoke at the rally in the Embassy Room. 'Therefore, after hearing Senator KENNEDY speak and watching him leave the stage DOOHAN went directly to the press room to await Senator KENNEDY'S appearance there. It was while he was on his way to the press room that he heard the commotion, although he did not hear any shots, and learned that Senator KENNEDY had been shot.

Although he had not been assigned as a reporter to the California primary or to the KENNEDY party he immediately prepared a story which was printed in the June 5, 1968, issue of the Kansas City Star, the evening Kansas City Times, under his by-line giving his personal account of the assassination which read, as for hows.

"Sen. Robert F. Kennedy had just finished his short victory statement, raised his fingers in a V sign and it was now "on to Chicago.

"I was standing toward the rear of the Embassy room at the Hotel Ambassador, along with more than 1,000 others. Though the ballroom is air-conditioned, it was hot and stuffy. I thought to myself that Kennedy looked as happy as anyone could possibly be.

"As the senator turned to leave the room, I heard a rumor that he was going to pass through a temporary press room on his way to a lower floor of the hotel, where another group of his excited supporters waited for him to appear.

"I headed for the press room. I knew where it was because I had been in there a few minutes earlier talking to Pierre Salinger, press secretary for the New York senator and for his late brother, President John F. Kennedy.

"The press room was near a long, narrow corridor used as a serving room for dinner meetings in the ballroom. Senator Kennedy was to use this passageway on his way to meet reporters.

"Accompanied by his wife, Mrs. Ethel Kennedy; Jesse Unruh, speaker of the California Assembly and a leader of the Kennedy forces here, and others, Kennedy started through the serving galley. Leading the way for him were several Los Angeles police officers, Rafer Johnson, former decathlon champion and now on the R. F. K. staff in California, and Roosevelt Grier, a defensive tackle for the Los Angeles Rams professional football team.

"The room itself contained metal serving and steam tables, which were not in use early today as there had been no program or refreshments served in the Embassy room. The area is 10 to 12 feet wide and 40 to 50 feet long.

"At 12;15 o'clock this morning it was jammed with hotel employees waiting for a chance to see and, perhaps, shake hands with the Democratic presidential hopeful. KC 62-8651

"Predictably, Senator Kennedy paused as he made his way slowly through the galley to shake hands. I was still on my way from the ballroom to the press room-kitchen, when it happened.

"I heard absolute bedlam coming from the narrow hallway, as from a range of less than 10 feet the would-be assassin began firing what turned out to be a .22-caliber revolver, wounding Kennedy and several others immediately clustered around him. I didn't actually hear the shots.

"But I got a chance to peer into the room and saw a young, bushy-haired, dark complexioned man being carried out by police officers. He was wearing blue jeans, tennis shoes and a blue sweat shirt.

"I was told that Johnson and Grier and possibly one or two others tackled and held the man immediately, but, of course, the tragedy was completed.

"We don't know yet who he is. But one thing is clear in my mind. He had to know the ropes. This was all behind the door to the ballroom. It seems to me that he had to know what the Kennedy exit was going to be beforehand.

"People say that a hurricane roars. You could just heard a roar. Then in a short time-just a few momentspeople were crying. All of us were stunned.

"I saw Ethel Kennedy. She was right alongside him all the time. Mrs. Kennedy remained very composed.

"Then Steve Smith, Kennedy's brother-in-law, asked everyone to quiet down and "let's all be orderly." It was hair-raising; Smith's voice sounds just like Senator Kennedy's.

"I was at the hotel in the first place because I admire Senator Kennedy. Our convention business was over for the evening and three of us, a librarian from St. Petersburg, Fla., and another from the Boston Globe had gone out to eat. Instead of going back to our hotel, the tSatler Hilton, we decided to go over to the Ambassador. We had heard that the senator and his California friends had taken quarters there for the night.

"We got there about 9:45 o'clock, and the lobby was already packed with people. There must have been more than 3,000 in the lobby and the ballroom. There was no program; people just standing around talking and catching the latest returns. 2025 RELEASE UNDER E.O. 14176

"That's how I bumped into Salinger. I told him I was from The Star, and he asked about several persons he knows on the paper. Then he told me that Kennedy probably would pass through the press room after making his television statement.

"Thus, I was by happenstance close to the scene of the tragedy, close enough, regretable as it was, to be on the sideline as the senator was carried to an ambulance.

"Some of those closer than I felt Bobby Kennedy was conscious. Someone told me he was able to take a rosary in his hand.

"I have never seen a huge mass of people so crazed in the aftermath of the shooting. Many were knocked known in the hallways as young people ran around. It was shocking.

"I then went back to the shooting scene. The other victims were still lying on the floor. Karl Ucler, an assistant manager of the hotel, told me he was alongside the senator as they came through the kitchen.

"'The senator had paused to shake hands with some of the help when the shots popped," Ucler said. 'I saw the senator fall and several others go down.

"'I saw a small type gun in the gunman's hand. Two guys (apparently Johnson and Grier) pinned him over the counter.'

"I also talked with Norman N. Mamey, president of the Finance Service corporation, who said he was right next to Kennedy when he was struck.

"'We came from the Embassy room and were going through the kitchen area,' Mamey said. 'The senator stopped to greet some of the help, and as he reached for a hand four or five shots were fired.

"'Three men fell and I knew one of them was Senator Kennedy. I ducked in a corner and kind of under the tables. The fellow on my right was hit in the hip, I believe, and the man in front of me was hit in the leg.

"'Everyone else ducked for cover. The women became hysterical.'

"After it was all over, police took over some rooms. Fourteen witnesses were giving statements right in the hotel.

"Obviously, for me, any thought of sleep was out of the question. I returned to the Embassy room, where the frenzied mood was over, giving way to tears and shock.

"'What a country we live in,' one girl said.

"'It just can't be true, it just can't be,' I heard a man say.

"At first it was fairly easy to get out of the hotel. But later entrances were blocked by police. In the press room I was told by an officer that the 14 witnesses were being questioned.

"Still later I was able to leave the hotel. I hired a taxicab to go back to the Statler Hilton. I asked the driver to stop by the Good Samaritan hospital, and he did.

"I guess there were about 150 people at one of the two entrances, just sitting on the curbing, waiting. I asked a policeman, and he said the senator was still in surgery and that there was no word. At the other entrance, about 300 persons we just standing around the doorway and the street. They were stunned, all stunned."

DOOHAN covered the assassination for the next two hours for the Kansas City Star and was stationed at the hospital where Senator KENNEDY was taken.

DOOHAN had no knowledge of any change in plans by Senator KENNEDY to go to the Ambassador Room or any other room instead of proceeding to the press room (Colonial Room). 1

About 1,000 persons were in attendance and he became separated from his two associates. In order to meet the fire department regulations the Embassy Room where the rally was held was closed and the overflow crowd was sent he believes to a room on a lower floor, possibly the Ambassador Room. While he had been in the press room he learned that Senator KENNEDY would visit the press room at the Colonial Room after he spoke at the rally in the Embassy Room. Therefore, after hearing Senator KENNEDY speak and watching him leave the stage DOOHAN went directly to the press room to await Senator KENNEDY'S appearance there. It was while he was on his way to the press room that he heard the commotion, although he did not hear any shots, and learned that Senator KENNEDY had been shot.

Although he had not been assigned as a reporter to the California primary or to the KENNEDY party he immediately prepared a story which was printed in the June 5, 1968, issue of the Kansas City Star, the evening Kansas City Times, under his by-line giving his personal account of the assassination which read as follows. 62-865 SLARCHED INDEXED SERIALIZED, JUN 5 1968 -BI 5 -KANSHS CIT ...re 'a' we de 251 62-8651 6/19/68 Kansas City. "Sen. Robert F. Kennedy had just finished his short victory statement, raised his fingers in a V sign and it was now "on to Chicago.

"I was standing toward the rear of the Embassy room at the Hotel Ambassador, along with more than 1,000 others. Though the ballroom is air-conditioned, it was hot and stuffy. I thought to myself that Kennedy looked as happy as anyone could possibly be.

"As the senator turned to leave the room, I heard a rumor that he was going to pass through a temporary press room on his way to a lower floor of the hotel, where another group of his excited supporters waited for him to appear.

"I headed for the press room. I knew where it was because'I had been in there a few minutes earlier talking to Pierre Salinger, press secretary for the New York ' senator and for his late brother, President John F. Kennedy.

"The press room was near a long, narrow corridor used as a serving room for dinner meetings in the ballroom. Senator Kennedy was to use this passageway on his way to meet reporters.

"Accompanied by his wife, Mrs. Ethel Kennedy; Jesse Unruh, speaker of the California Assembly and a leader of the Kennedy forces here, and others, Kennedy started through the serving galley. Leading the way for him were several Los Angeles police officers, Rafer Johnson, former decathlon champion and now on the R. F. K. staff in California, and Roosevelt Grier, a defensive tackle for the Los Angeles Rams professional football team.

"The room itself contained metal serving and steam tables, which were not in use early today as there had been no program or refreshments served in the Embassy room. The area is 10 to 12 feet wide and 40 to 50 feet long.

"At 12:15 o'clock this morning it was jammed with hotel employees waiting for a chance to see and, perhaps, shake hands with the Democratic presidential hopeful.

"Predictably, Senator Kennedy paused as he made his way slowly through the galley to shake hands. I was still on my way from the ballroom to the press room-kitchen, when it happened.

"I heard absolute bedlam coming from the narrow hallway, as from a range of less than 10 feet the would-be assassin began firing what turned out to be a .22-caliber revolver, wounding Kennedy and several others immediately clustered around him. I didn't actually hear the shots.

"But I got a chance to peer into the room and saw a young, bushy-haired, dark complexioned man being carried out by police officers. He was wearing blue jeans, tennis shoes and a blue sweat shirt.

"I was told that Johnson and Grier and possibly one or two others tackled and held the man immediately, but, of course, the tragedy was completed.

"We don't know yet who he is. But one thing is clear in my mind. He had to know the ropes. This was all behind the door to the ballroom. It seems to me that he had to know what the Kennedy exit was going to be beforehand.

"People say that a hurricane roars. You could just heard a roar. Then in a short time-just a few momentspeople were crying. All of us were stunned.

"I saw Ethel Kennedy. She was right alongside him all the time. Mrs. Kennedy remained very composed.

"Then Steve Smith, Kennedy's brother-in-law, asked everyone to quiet down and "let's all be orderly." It was hair-raising; Smith's voice sounds just like Senator Kennedy's.

"I was at the hotel in the first place because I admire Senator Kennedy. Our convention business was over for the evening and three of us, a librarian from St. Petersburg, Fla., and another from the Boston Globe had gone out to eat. Instead of going back to our hotel, the tSatler Hilton, we decided to go over to the Ambassador. We had heard that the senator and his California friends had taken quarters there for the night.

"We got there about 9:45 o'clock, and the lobby was already packed with people. There must have been more than 3,000 in the lobby and the ballroom. There was no program; people just standing around talking and catching the latest returns. 2025 RELEASE UNDER E.O. 14176

"That's how I bumped into Salinger. I told him I was from The Star, and he asked about several persons he knows on the paper. Then he told me that Kennedy probably would pass through the press room after making his television statement.

"Thus, I was by happenstance close to the scene ) of the tragedy, close enough, regretable as it was, to be on the sideline as the senator was carried to an ambulance.

"Some of those closer than I felt Bobby Kennedy was conscious. Someone told me he was able to take a rosary in his hand.

"I have never seen a huge mass of people so crazed in the aftermath of the shooting. Many were knocked known in the hallways as young people ran around. It was shocking.

"I then went back to the shooting scene. The other victims were still lying on the floor. Karl Ucler, an assistant manager of the hotel, told me he was alongside the senator as they came through the kitchen.

"'The senator had paused to shake hands with some of the help when the shots popped,' Ucler said. 'I saw the senator fall and several others go down.

"'I saw a small type gun in the gunman's hand. Two guys (apparently Johnson and Grier) pinned him over the counter.'

"I also talked with Norman N. Mamey, president of the Finance Service corporation, who said he was right next to Kennedy when he was struck.

"'We came from the Embassy room and were going through the kitchen area,' Mamey said. 'The senator stopped to greet some of the help, and as he reached for a hand four or five shots were fired.

"'Three men fell and I knew one of them was Senator Kennedy. I ducked in a corner and kind of under the tables. The fellow on my right was hit in the hip, I believe, and the man in front of me was hit in the leg.

"'Everyone else ducked for cover. The women became hysterical.'

> "After it was all over, police took over some rooms. Fourteen witnesses were giving statements right in the hotel.

"Obviously, for me, any thought of sleep was out of the question. I returned to the Embassy room, where the frenzied mood was over, giving way to tears and shock.

"'What a country we live in,' one girl said.

"'It just can't be true, it just can't be,' I heard a man say.

"At first it was fairly easy to get out of the hotel. But later entrances were blocked by police. In the press room I was told by an officer that the 14 witnesses were being questioned.

"Still later I was able to leave the hotel. I hired a taxicab to go back to the Statler Hilton. I asked the driver to stop by the Good Samaritan hospital, and he did.

"I guess there were about 150 people at one of the two entrances, just sitting on the curbing, waiting. I asked a policeman, and he said the senator was still in surgery and that there was no word. At the other entrance, about 300 persons  $\psi$  we just standing around the doorway and the street. They were stunned, all stunned."

DOOHAN covered the assassination for the next two hours for the Kansas City Star and was stationed at the hospital where Senator KENNEDY was taken.

DOOHAN had no knowledge of any change in plans by Senator KENNEDY to go to the Ambassador Room or any other room instead of proceeding to the press room (Colonial Room).

An anonymous letter received by the Boston Office on 5-22-58, contained a color photograph taken from page 30 of the 3-29-68, edition of Life Magazine. The photograph which is being forwarded herewith to Los Angeles is that of Senator ROBERT F. KENNEDY addressing a group of students at Kansas University, date and exact location not given, but possibly at Lawrence, Kansas, in the week prior to the date of the magazine.

The letter advised that an individual in the photo bore a strong resemblance to SIRHAN B. SIRHAN. This individual is located in the photo 2½ inches directly to the right of Senator KENNEDY's left hand. He is wearing a blue shirt and has dark curly hair.

The above data is being set forth for information. No leads are being set forth for the Kansas City Office inasmuch as this is being left to the discretion of Los Angeles which office may have information relative to recent activities and travel of SIRHAN, thereby positively eliminating the possibility of his presence in Kansas during the pertinent period.

Miss CAROLINE MARY PETTINATO, Room 208, Hope Hotel, 700 Hope Street, Los Angeles, furnished the following , information:

She was a volunteer campaign worker for Senator ROBERT KENNEDY; and, to help publicize his campaign, she rode a bicycle from San Antonio, Texas, to Los Angeles, arriving in Los Angeles on May 26, 1968. She was present at Senator KENNEDY's victory celebration on the night of June 4, 1968, at the Ambassador Hotel. She heard about four pops in quick succession shortly after Senator KENNEDY left the Embassy Room; but she did not realize at the time that they were shots. She was at the Ambassador Hotel from around 8:00 PM on June 4, 1968, until the time of the shooting, but at no time did she see the man who has been identified as SIRHAN SIRHAN.

On June 9, 1968, Mr. HOLDER, the Desk Clerk at the Hope Hotel, told her that a man by the name of JOHN WRIGHT had said that he was a witness to the shooting and that he knew something about it. She told HOLDER that she would like to talk to WRIGHT; and HOLDER called WRIGHT at the Milner Hotel and had him come to the Hope Hotel. Throughout the course of the afternoon and evening, WRIGHT told PETTINATO the following story:

He was employed as a "kitchen reporter" at the Ambassador Hotel; and he was on duty from 10:00 PM on June 4, 1968, to 8:00 AM on June 5, 1968. He first noticed the man identified in the newspaper as SIRHAN SIRHAN at about 11:00 PM on June 4, 1968. SIRHAN came into the kitchen at that time, and he hung around in there drinking coffee. He noticed SIRHAN because he was dressed differently from the kitchen employees. He saw somebody shake KENNEDY's hand in the kitchen. He saw SIRHAN facing KENNEDY and pointing the gun at him; and he saw KENNEDY fall, but he was watching SIRHAN and he never saw SIRHAN pull the trigger of the gun. WRIGHT observed this from the main kitchen by the refrigerator, and he saw SIRHAN standing directly behind the steam table.

The statements PETTINATO recalled WRIGHT as making are as follows:

He is using an alias now;

He used to be in the Black Muslims;

He used to be a supervisor on construction work in Vietnam;

He had a Playboy Club key;

He was leaving for Penasacola, Florida, on June 10, 1968, to go into construction work for two weeks and then go to Hawaii;

He told police his story;

His name once was DANNY;

A couple of men in the Ambassador Hotel kitchen said they were offered one million dollars to do the assassination of Senator KENNEDY;

Seven men were involved.

PETTINATO advised that WRIGHT seemed to know the cashier at Jerry's Restaurant, Seventh and Hope, who was on duty at 5:30 PM on June 9, 1968.

PETTINATO described WRIGHT as follows:
