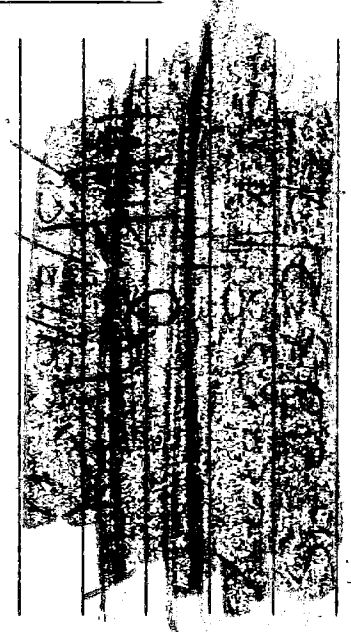

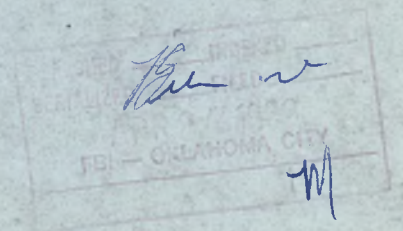

Captain Francis L. Hurt, Fremont, Nebraska Police Department, furnished the following information relating to Oshel, a deaf mute, arrested at Fremont 8:00 p.m., April 24, 1968, following complaint that Oshel had circulated a note among patrons at Woody's Bar in downtown Fremont, bearing a reference to the killing of 1968 Presidential Candidate, Senator Robert F. Kennedy of New York, whose campaign train was scheduled for a whistle stop at Fremont at 6:00 p.m., Saturday, April 27, 1968.

Oshel had been drinking but did not appear to be intoxicated. Interviewed by the Fremont Police Department with assistance of an interpreter proficient in the Manual Alphabet, Oshel denied any knowledge of or even having seen before, what appeared to be a portion of a Kraft type paper bag found in his possession when arrested and bearing the following separate handwritten items: "Deaf I can kill Robert F Kenne - Kennedy," "Can Kill Robert F. Kennedy," and "Assain." Although Oshel refused to write these words in the same order, he did furnish handwritten specimens of the individual words, including the misspelled word "assain" which, it was determined, he understood to mean "assassinate." It was the opinion of Captain Hurt and of Dodge County Attorney Richard L. Kuhlman, who participated in the interview of Oshel, that his handwriting specimens bore resemblance to the handwriting on the note.

Mr. Kuhlman expressed his opinion that the circumstances suggest that in the event an actual threat were involved, it would more likely be that Oshel was seeking an offer to "kill Kennedy" for hire than that he planned to do so on his own initiative.

Re: James Milton Curtis Oshel

With Oshel's consent, officers of the Fremont Police Department searched Room 312 of the Magil Hotel where Oshel was registered April 22, 1968. This search disclosed only personal effects, including apparatus for printing the Manual Alphabet cards from sale of which Oshel apparently subsisted.

In Oshel's billfold was found a small piece of yellow paper bearing the handwritten name "Wilkerson Printing Company, 215 South Cooper, Memphis," which Oshel subsequently advised, was the place of employment of a brother, not otherwise identified.

On numerous occasions Oshel stated, in effect, "I love Martin Luther King," spontaneously and without relevancy to the progress of the interview.
