MORNING OF JUNE SIX LAST, WHILE HE AND STUDENTS OF OLYMPIC  
COLLEGE WERE IN A DISCUSSION WITH NOSAYAN, A STUDENT AT OLYMPIC  
COLLEGE, NOSAYAN RELATED THAT THE ASSASSIN OF KENNEDY WAS  
"JUSTIFIED IN DOING WHAT HE DID." NOSAYAN REPRESENTED THAT HE  
WAS PERSONALLY ACQUAINTED WITH SIRHAN BISHARA SIRHAN, HAVING MET  
HIM IN SAN FRANCISCO. NOSAYAN ADVISED "YOU MUST REMEMBER THAT  
THIS TOOK PLACE ONE YEAR FROM JUNE FIFTH."

ARMSTEAD OPINED THAT NOSAYAN WAS APPARENTLY WELL INFORMED  
CONCERNING STATEMENTS OF SENATOR ROBERT KENNEDY SUPPORTING THE  
SHIPMENT OF ARMS TO ISRAEL.

AFTER ARMSTEAD RELATED TO NOSAYAN "YOU ARABS WILL NOT GET ANYWHERE BY BLOODSHED," NOSAYAN REPLIED " WE'LL BE BACK AGAIN.", APPARENTLY REFERRING TO THE ARAB-ISRAEL DISPUTE.

ARMSTEAD ADVISED THAT IN PREVIOUS DISCUSSION NOSAYAN HAD INDICATED THAT HE DOES NOT HATE THE JEWS AS INDIVIDUALS BUT IS AGAINST THE AGGRESSION OF ISRAEL AND THAT HE HOLDS IT AGAINST THE U.S. AND BRITAIN FOR HELPING ISRAEL.

ACCORDING TO NOSAYAN'S REMARKS TO ARMSTEAD, NOSAYAN HAS SAID THAT NASSAR IS " A GREAT MAN" AND "WE DON'T UNDERSTAND HIM."

NOSAYAN IS FROM TAIR, SAUDI ARABIA, CURRENTLY EN ROUTE VIA PORTLAND, OREGON , TO STOCKTON , CALIFORNIA, TO ENROLL IN SUMMER SESSIONS AT THE PACIFIC UNIVERSITY. DATE OF ARRIVAL IN STOCKTON UNKNOWN..

BUREAU INSTRUCTS NOSAYAN BE INTERVIEWED TO DETERMINE IF HE HAS ANY PERTINENT INFORMATION IN CONNECTION WITH THIS CASE. CONDUCT INTERVIEW IMMEDIATELY AND FURNISH RESULTS TO BUREAN AND LOS ANGELES.

TODAY ERNEST B. SMITH, ASSISTANT LEGAL AFFAIRS SECRETARY, GOVERNOR'S OFFICE, SACRAMENTO, CALIFORNIA, CONFIDENTIALLY ADVISED THE GOVERNOR'S OFFICE HAD RECEIVED A TELEPHONE CALL FROM ONE JOHN LAWRENCE, FIFTY SEVEN WEST TENTH STREET, NEW YORK CITY, TELEPHONE TWO ONE TWO - GR SEVEN - ONE EIGHT TWO SIX. LAWRENCE ADVISED THAT HE IS AN ATTORNEY REPRESENTING A GROUP OF ARABS IN NEW YORK STATE. THESE ARABS HAVE FORMED A COMMITTEE TO INSURE THAT THE U.S. GOVERNMENT DOES NOT "RAILROAD" SUBJECT SIRHAN INTO PRISON.

LAWRENCE ADVISED THE GOVERNOR'S OFFICE THAT HE DESIRED THE GOVERNOR'S OFFICE TO INTERCEDE WITH THE LOS ANGELES COUNTY SHERIFF'S OFFICE TO INSURE THAT SIRHAN'S INCOMING MAIL IS NO LONGER SCREENED. HE STATED THAT MAIL BEING FORWARDED TO SIRHAN WAS BEING SCREENED BY THE LOS ANGELES

MR. SMITH EMPHASIZED THAT THE ABOVE IS BEING FURNISHED ONLY TO THE FBI FOR INTELLIGENCE PURPOSES AND IT MUST NOT BE FURTHER DISSEMINATED. THE GOVERNOR'S OFFICE HAS NOT ADVISED THE SHERIFF'S OFFICE OR THE LOS ANGELES POLICE DEPARTMENT OF THE RECEIPT OF THIS TELEPHONE CALL.

BISHARA SIRHAN or of the other man and woman described by  
Mrs. PENNA ESHOO, 405 North Palm, Turlock, California.

WILLIAM JOHNSON, Deputy Sheriff, Stanislaus County Sheriff's Office, Modesto, California

N. W. BISHOP, Station Agent, Southern Pacific Railroad, Turlock, California; Mr. BISHOP was not on duty, but came to the station to see Senator KENNEDY.

L. D. PETERSON, Cashier, Southern Pacific Railroad, Turlock, California; Mr. PETERSON was not on duty, but came to the station to see Senator KENNEDY.

R. J. Roup, Relief Station Agent, Southern Pacific Railroad, Turlock, California, and the only Southern Pacific employee on duty at the station on the date of May 30, 1968. Mr. ROUP was interviewed at the Southern Pacific Station, Modesto, California.

In addition, the following Modesto and Turlock officials of the Kennedy For President Campaign were interviewed on 6/10/68:

Mr. RAUL N. VALLE, owner, Mar-Val Appliances, 1081 Lander Avenue, Turlock, California. Mr. VALLE departed Turlock, California, early on 5/30/68, boarded the Election Special at Merced, California, and introduced Senator KENNEDY at Turlock.

Mr. PAUL W. TURNER, President, The Grange Company, Modesto, California, residence 1113 Country Club Drive, Modesto, California, who was interviewed at a commemorative tree planting in honor of Senator KENNEDY in Turlock, California. Mr. TURNER and his wife, NORMA TURNER also boarded the train at Merced, California.

Mrs. TURNER telephonically contacted the Modesto Resident Agency on the evening of 6/10/68, to advise that she had seen no one meeting the description of SIRHAN BISHARA SIRHAN; Mrs. TURNER advised that she is of Assyrian descent and knows of no person locally meeting the description of SIRHAN BISHARA SIRHAN.

HARVEY LAZAR, owner, Lazar Fruit Company, 576 Center Street, Turlock, California, and EDDIE SAYAD, Stanislaus County Sheriff's Office, Modesto, California, and both of Arab descent and familiar with the Assyrian-Jordanian population in the Turlock-Modesto area advised that they know of no persons in this area meeting the description of SIRHAN BISHARA SIRHAN.

Mrs. RALF PARTON, 305 North Avenue, Turlock, California, a member of the Kennedy For President Campaign, advised on 6/11/68, that one of the individuals involved in furnishing music for the appearance of Senator KENNEDY at Turlock, California, was a FRED FARAMAZPOUR, an Iranian student at Stanislaus State College. She advised that one MIKE NOLAN, a Kennedy advance man, would have been the individual that would have arranged for music at Turlock, California.

On 6/12/68, FERETBOON FARAMAZPOUR, music student at Stanislaus State College, Turlock, California, was interviewed at his residence, Yosemite Residence Hall, 3500 Geer Road, Turlock, California. He advised that he is an Assyrian in the United States on a student visa from Iran. FARAMAZPOUR stated that he is five feet three inches in height; weight, 140 pounds; black hair; brown eyes; born 6/30/41, in Iran.

FARAMAZPOUR further advised that on 5/30/68, he was at the Turlock Railroad Station with three male and three female students from Stanislaus State College. They were members of a small six-piece musical group. He was asked to play in the group by BARBARA NICHOLS, also a student; however, on arrival, the percussion section of the band was already filled and therefore he did not play. He did stay near the band; however, from about 2:30 PM until they stopped playing after the departure of Senator KENNEDY from the station.

FARAMAZPOUR did not recognize SIRHAN SIRHAN from a photograph and stated he does not know SIRHAN SIRHAN. He saw no one at the station wearing a coat. FARAMAZPOUR wore a short-sleeve shirt and black shoes at the station. He wore a large round Kennedy button that he purchased from a girl who kept the buttons in her purse. He described the girl as being five feet six inches in height and slender with black hair. He could not recall her clothing. He stated there was a second band at the station. The band consisted of three pieces and the musicians appeared to be teenagers. He could not further describe them.

BARBARA NICHOLS, student at Stanislaus State College, Turlock, California, was interviewed at her apartment, Apartment Number Three, the Bee Apartments, 1001 Ceer Road, Turlock, California, on 6/12/68. Miss NICHOLS substantiated information as furnished by FARAMAZPOUR. She saw no one fitting the description of SIRHAN SIRHAN at the station and she does not know the identity of the other small band but believes that they were high school students. She advised that they would have been arranged by MIKE NOLAN.

NOLAN has previously been identified by NORMA TURNER as a graduate student at the Stanford Graduate School of Business, Stanford, California, who resides in Tacoma, Washington, and whose father is Chief Counsel for Weyerhaeuser Corporation, Tacoma, Washington.

ADMINISTRATIVE:

For the information of the Bureau, information in 302's enclosed for Los Angeles include reinterview with Mrs. ESHOO who indicates she is positive she saw SIRHAN BISHARA SIRHAN at Turlock as previously described. She indicates further that this individual talked with a person, not previously mentioned by her, stating to him "let's go" just prior to his departure. She could furnish no physical description but indicated that he was the leader of a small musical group comprised of a drummer, a guitar player and the leader, who played the "bugle." She indicated that she also "suspected" this individual. She indicated that she heard him state that they would not be able to play since they were having trouble with the electricity, but that she did not believe that they were having any such trouble. She indicated that she informed Mrs. SAVANNAH STONER of this fact after departure of the interviewing Agent during prior interview, but that Mrs. STONER advised her not to tell the FBI.

Mrs. SAVANNAH STONER, 405 N. Palm, Turlock, California, and Mrs. EMMA BANKS, daughter of Mrs. ESHOO, 330 N. Palm, Turlock, California, advise that Mrs. ESHOO exaggerates. Mrs. STONER stated that Mrs. ESHOO definitely did not mention the above incident and that contrarily, she told Mrs. ESHOO to tell the FBI everything she knew. Mrs. BANKS advises that she is absolutely certain that the information furnished by her mother is false and both Mrs. STONER and Mrs. BANKS indicate that Mrs. ESHOO is totally uneducated and unable to read or write. Mrs. BANKS indicated that she heard conversation between Mrs. ESHOO and Mrs. MOOSHEY relative to a "suspicious" person but that the description of this person did not materialize until Mrs. ESHOO saw SIRHAN BISHARA SIRHAN on television. She stated that she heard Mrs. MOOSHEY indicate that she heard this suspicious person state "I can get a good shot from here" but discounted the story then and discounts it now.

AT LOS ANGELES, CALIFORNIA: In view of the above information, if additional investigation is desired, it is requested that Los Angeles first reinterview Mrs. MARTHA MOOSHEY to determine if the individual she described was wearing a coat in hot weather which made him "suspicious." In addition, details of any and all conversation with Mrs. ESHOO by Mr. and Mrs. MOOSHEY as previously described, should be obtained to establish the total validity or lack of validity of information furnished by Mrs. ESHOO. UACB or UACOO, no additional investigation in this phase of this investigation is being conducted by the Sacramento Division.

No lead has been set out for Los Angeles to contact MIKE NOLAN at Stanford College or Tacoma, Washington, to identify the leader of the student musical group mentioned herein and this lead is being left to the discretion of the office of origin.

On 6/7/68, at 12:20 p.m., Mrs. JAMES SKAUG, 6905 10th Street, Rio Linda, California, telephone 991-1632, contacted the Sacramento Office to volunteer information that she had learned from her daughter, who is a student at San Francisco State College. She stated that her daughter came home on 6/6/68, and was to have brought with her a student from Kuwait, who also attends San Francisco State. This student did not come with her daughter. Her daughter explained that he had disappeared from the campus and that she had made inquiries and had learned that all of the Arabian students at San Francisco State had disappeared. Mrs. SKAUG was furnishing this information in the event it had any connection with the assassination of Senator KENNEDY.

This information was telephonically furnished to Supervisor GEORGE GALLOWAY at the San Francisco Office so that he might determine if, in fact, the students at San Francisco State had disappeared.

At 5:10 p.m. on the same date, Supervisor GALLOWAY telephonically advised that Inspector CECIL PHARRIS, Intelligence Bureau, San Francisco PD, had contacted his sources at San Francisco State and determined that this information was not true and that as far as known, all Arabian students were still in attendance and present at San Francisco State.





RE: ASSASSINATION OF ROBERT F. KENNEDY  
INFORMATION CONCERNING

FLOYD ARMSTEAD, Instructor, Mathematics Department, Olympic College, Bremerton, Washington, advised on June 6, 1968 that on the morning of June 6, 1968 while he and some Olympic College students were in a discussion with a student named SULAIMAN NOSAYAN, the latter made some statements concerning the assassination of New York Senator ROBERT F. KENNEDY in Los Angeles, California, June 5, 1968.

Mr. ARMSTEAD stated that SULAIMAN NOSAYAN said the assassin of KENNEDY was "justified in doing what he did". He said that SULAIMAN NOSAYAN further said he knew the assassin personally, having met him in San Francisco. However, he did not indicate the closeness of their relationship. Mr. ARMSTEAD said that SULAIMAN NOSAYAN also remarked "you must remember that this took place one year from June 5" (of last year). Mr. ARMSTEAD said further that SULAIMAN NOSAYAN was apparently well informed concerning the statements of Senator KENNEDY and pointed out that Senator KENNEDY had recently made statements supporting the shipment of arms to Israel. Mr. ARMSTEAD said that he, ARMSTEAD, told SULAIMAN NOSAYAN that "you (Arabs) will not get anywhere by blood shed" whereupon SULAIMAN NOSAYAN said "we'll be back again" (apparently referring to the Arab-Israeli dispute).

Mr. ARMSTEAD said that in some previous discussions with SULAIMAN NOSAYAN, whom he described as a soft-spoken individual who is "nice to talk to", SULAIMAN NOSAYAN had indicated that he does not hate the Jews as individuals but is against the aggression of Israel and that he holds it against the United States and Britain for helping Israel. Mr. ARMSTEAD said that SULAIMAN NOSAYAN has also said that NASSER is a great man and we (United States) does not understand him.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

Mr. JACK C. CROSE, Assistant to JESSE M. UNRUH, Speaker of the Assembly, State of California, home address 6418 Oakridge Way, Sacramento, furnished the following information:

On June 4, 1968, he was with Mr. UNRUH in the suite of rooms on the fifth floor of the Ambassador Hotel, Los Angeles, California, along with Senator KENNEDY and his staff, awaiting the results of the California Presidential Primary. People in the ballroom off the lobby were waiting for Senator ROBERT F. KENNEDY to come down to address them and were getting restless. Someone suggested that Mr. UNRUH go down to speak to them. He accompanied Mr. UNRUH to the ballroom where Mr. UNRUH addressed the group at approximately 11:30 p.m. At about 11:45 p.m., Mr. UNRUH requested he go to get Senator KENNEDY and his party as it appeared there were sufficient ballots reported in for Senator KENNEDY to claim victory. He proceeded through the hallway and went to the single elevator at the south end of the building and went to the fifth floor; as he exited the elevator he observed the Senator, FRED DUTTON, BILL BARRY, and about ten or fifteen other people coming down the hall. It was suggested they take the larger elevator because of the size of the group. They took this elevator and exited towards the lobby of the hotel. As they emerged from the elevator someone from the group, possibly Mr. FRED DUTTON, or FRANK MANKIEWICZ suggested they go through the lobby corridor and through the crowd in the room to get to the stage, however, Senator KENNEDY decided to avoid the crowd and go to the platform by way of the Colonial Room and the hallway which leads to the stage.

When they arrived at the stage he found it was jam packed and decided to stay at the foot of the stage. Following the Senator's speech, the Senator proceeded to walk to his right towards a table where PIERRE SALINGER and DICK KLINE were seated, however, someone (unknown to him) but whom he believes was in a tuxedo, pointed him in the direction of the rear of the stage. At this point he himself left the room and went directly back to the fifth floor and was not aware that the Senator had been shot until he heard it on TV. He added that during the evening he made several trips through the kitchen but at no time did he ever see SIRHAN BISHARA SIRHAN nor had he ever seen SIRHAN before or since, except for photographs appearing in newspapers.

He stated he was not aware of any formal plans for the Senator to address the press or of any prescribed route that the Senator was to take to and from the stage. The only planned affair he was aware of was a victory celebration to take place at the "Factory", a discotheque in Hollywood, California, to which he as a member of Mr. UNRUH's staff, had been invited.

Mr. JESSE M. UNRUH, Speaker of the California State Assembly, home address 8315 Byrd Avenue, Inglewood, California, furnished the following information:

On June 4, 1968, he was on the fifth floor of the Ambassador Hotel in Los Angeles, California, along with members of his staff and Senator KENNEDY and his staff, awaiting the results of the California Presidential Primary. People in the room off the main lobby, who were awaiting the arrival of Senator KENNEDY, began to get restless and it was suggested that he (UNRUH) go down to speak to them.

At about 11:30 p.m. he went down and spoke to the group. At approximately 11:45 p.m. he felt there were sufficient returns for Senator KENNEDY to claim victory and sent his assistant, Mr. JACK C. CROSE, to get the Senator and his party.

The Senator came down to the hall and addressed the group congregated there for about eight minutes and then started to walk away. He proceeded to his right, towards a table where PIERRE SALINGER and DICK KLINE were seated. He was propelled, by someone whom he could not see, towards the back of the stage. The stage was so jammed he (UNRUH) decided to go down the stairs from the stage and go to the hallway by the door located at the foot of the stage.

When he stepped out into the hallway Senator KENNEDY had already passed that area and was about ten paces ahead of him. He then heard two or four pops followed by four or five more. At this point he did not realize these were pistol

shots and thought they might be balloons. All at once the crowd parted in front of him as he continued to walk forward. He then observed PAUL SCHRADE lying on the floor with an obvious bullet wound in his head and immediately noticed Senator KENNEDY lying on the floor ahead of SCHRADE. Senator KENNEDY brought his hand down from his head and appeared to clutch at his stomach, hence he believed the Senator had been shot there. Someone had already gotten to the Senator and had undone his shirt.

Inasmuch as the crowd was pressing in, his first thoughts were to make room for the Senator and prevent his being trampled on. He then attempted to push newsmen, photographers, and other people in the area away. Noticing a photographer on top of a table where ROOSEVELT GRIER had pinned SIRHAN BISHARA SIRHAN, he pulled him off the table and into the corridor. At this point it was the first time he had seen SIRHAN BISHARA SIRHAN and at no time did he ever observe SIRHAN holding the gun.

Recalling the fate that had befallen LEE HARVEY OSWALD, and hearing voices in the crowd yelling to kill SIRHAN, he recalls yelling to the group holding SIRHAN to protect him. He could not recall exact words used but, remembering the events in Dallas when OSWALD had been shot, he did not want to see the same thing happen there. He did recall saying something like, "If the system works at all, we are going to try this one".

When the police arrived he attempted to keep the police all around SIRHAN . . . to protect him. He . . . grabbed SIRHAN by the scruff of the neck and helped to propel him down the hallway through the lobby and to a police car parked in front of the hotel.

He accompanied the police officers in the car that SIRHAN was in to the Rampart Division. He sat in front with the driver and SIRHAN was in the back seat between two other

police officers. About the time they entered the car SIRHAN mumbled, " I did it for my country". He could not recall at just what point he (UNRUH) asked the question during the ride, but since SIRHAN looked like a Latin-American he asked SIRHAN, "Why him? Why him? He was trying to do something". SIRHAN muttered, "It's too late, it's too late". He also recalls SIRHAN saying, "I can explain, I can explain". He could not, however, recall the exact sequence of the statements except for the one made as they entered the car.

They arrived at the Rampart Division and SIRHAN was taken into a room there by one of the officers. His sole concern there was that SIRHAN not be in a position to do himself any harm and he was assured by an officer that SIRHAN was still handcuffed and would not be able to do himself any harm. Shortly after their arrival at the Rampart Division he noticed the time was 12:43 a.m.

SIRHAN subsequently was brought out, placed into a police car, and taken to the Central Division. He followed in another car. Upon arriving SIRHAN was taken to an isolation room and interrogated and that is all he saw of SIRHAN.

He added that he was not aware of any formal plans for Senator KENNEDY to address the press. The only plan he was aware of was that there was to be a victory celebration at the "Factory" a discotheque in Hollywood, California, to which he and his staff had been invited. To his knowledge all plans were made by the Senator's staff.

FRANK C. AILES, who is the Chief of Police of the Delano, California, Police Department, furnished the following information and requested that the source of information (himself) be kept confidential:

About five weeks ago, early May, a short time after the shooting of MARTIN LUTHER KING, he and several friends were drinking in the Elk's Club in Delano. He recalls that one of the individuals with him was Lieutenant COMBS of his own Department. The other individuals he does not recall other than a ROY MURRAY who lives in Earlimart, California.

On this occasion, MURRAY advised the group that he had received a long distance telephone call from friends in the Las Vegas area requesting a contribution from him to help pay a one half to three quarter million dollar contract to assassinate ROBERT KENNEDY. MURRAY stated that the assassination was to take place if it appeared KENNEDY was to gain the Democratic Presidential nomination, and that California was considered as the conclusive proof point of that probably nomination.

MURRAY bragged that he had offered \$200 towards this contract. He intimated that these friends were members of the "Mafia". He further stated that he told the people from Las Vegas that he could probably drum up at least \$50,000 to \$100,000 in Delano, California, area alone.

AILES further advised that KENNEDY has been to Delano three times in the past year. Prior to KENNEDY's visits the area was quiet and untroubled, however, since his visits there have been riots, strikes, and picketing.

The wealthy farmers in the area all hate KENNEDY. When KENNEDY came to visit CHAVEZ on his hunger strike he refused to allow any local police to furnish him any protection. When he arrived on these visits he came by private plane which would land at the airport at Memorial Park in Delano. On his last visit very few people met or saw KENNEDY off.

AILES stated he felt that MURRAY was probably just blowing his own horn because of the high feeling against KENNEDY in the area. MURRAY is a reasonable wealthy farmer in the area and does make frequent trips to Las Vegas. At the time the above comments were made the general tenor of conversation had been for the KING assassination and against the JOHN F. KENNEDY assassination. Someone in the group had mentioned that they had shot the wrong KENNEDY and it was too bad it had not been ROBERT instead of JOHN that had been killed. AILES feels that this probably triggered MURRAY's comments.

MURRAY is a known gambler in the area but has no police record for such activities. He frequently loses several thousands of dollars at a time when he visits Las Vegas, but this does not appear to bother him. AILES feels that if MURRAY is confronted with this situation he probably will either admit making the comments or claim that he does not remember making the comments. He feels MURRAY is not the type of individual to back down and that if he did make this statement in jest he probably would admit it if questioned by authorities.

AILES had forgotten the incident and it was only brought to his mind by Lieutenant COMBS after KENNEDY was assassinated immediately after winning the California election.

Mrs. LINDA IRENE WILSON, 173 Hogan Avenue, Vallejo, California, was interviewed and advised the following:

She and her husband, ROBERT CURTIS WILSON, who is employed at Shop 72, Mare Island, Naval Shipyard, Vallejo, California, attended a Kennedy Campaign Program at the Civic Center at San Francisco, California, on Saturday, June 1, 1968, at 8:30 PM.

She stated that she was sitting in Section five, Row T, seat one, and that her husband was in Section five, Row T, seat two. She stated that her attention was first drawn to the two people sitting in front and to her right because they remained seated when the pledge of allegiance to the flag was recited. These two people, a female and a male, were sitting, the female in Section five, Row S, seat three; the male in Section five, Row S, seat four.

She stated she noticed these two individuals again when they remained seated during the playing of the national anthem and since her curiosity was then aroused, she asked the man sitting in front of her in Section five, Row S, seat one, why these two people had remained seated. This individual stated that the two individuals had told him that they were communists.

Mrs. WILSON stated that this made her "sick to her stomach" because she was afraid these two individuals might try to hurt Senator ROBERT F. KENNEDY when he made his appearance at the show.

Mrs. WILSON stated the man whom she questioned and the woman with him sitting in Section five, Row S, seat two, did not appear to be with the two people who had remained seated.

Mrs. WILSON stated that when Senator ROBERT F. KENNEDY did enter the auditorium, everyone in the building stood up and cheered except the aforementioned man and woman and that this man and woman remained seated and motioned "thumbs down" signals at Senator ROBERT F. KENNEDY and booed him. She stated they repeated these gestures several times.

She stated that when Senator ROBERT F. KENNEDY finished his talk and started to leave, she left her seat to try and shake his hand and this was the last she saw of the unidentified individuals.

She stated she did not think of these two individuals again until she heard the news of Senator ROBERT F. KENNEDY's assassination and the description of SIRHAN BISHARA SIRHAN and his female companion came over the television. She stated at this time she called the Sacramento FBI Office.

Mrs. WILSON gave the following description of the male that refused to stand and who was seated in Section five, Row S, seat four:

He corroborated and concurred in his wife's statements as to their trip to the Civic Center in San Francisco, California, on Saturday, June 1, 1968, and the refusal to stand of the two unidentified individuals.

He stated that after the two individuals first refused to stand for the pledge of allegiance to the flag that he paid no attention to them and therefore did not get a very good look at the unidentified male and female. He stated that he could only give the following description of the male who was seated in Section five, Row S, seat four:

He had been at the Civic Center Auditorium at San Francisco, California, on Saturday, June 1, 1968, to attend the Kennedy Campaign Program and that he was seated in Section five, Row S, seat six. He stated he remembered the actions of the people sitting to his left. He stated that next to the aisle in Section five, Row S, seat one there was a male; next to the male in seat two, a female; the next seat, another female; the next seat four, a male; then his girl friend in seat five. He stated that his attention was drawn to all four by their boos and antics but he especially remembered the unidentified male sitting in seat one. He was shown six photographs, one of which was SIRHAN BISHARA SIRHAN and he stated that he did not recognize any of the photographs as being similar to the two male individuals sitting to his left on Saturday, June 1, 1968, at the Civic Center Auditorium.

Mr. JONES stated that he did not remember the individuals well enough to give a description.

SACRAMENTO AND LOS ANGELES REQUESTED TO ADVISE IF ANY KNOWLEDGE OF SUCH INVESTIGATION BY LOS ANGELES POLICE DEPARTMENT IN DELANO. NO ACTION CONTEMPLATED BY SAN FRANCISCO.
