On 6/18/68, REX NEVINS, Reporter for the Riverside Press-Enterprise, Indio, California, advised that REX WESTERFIEID Public Relations Director for Western Division, John Birch Society, held a press conference in Indio that afternoon concerning CAESAR CHAVEZ, Director of United Farm Workers Organizing Committee, AFL-CIO, who is in Indio Area attempting to organize grape workers. WESTERFIELD identified various persons connected with CHAVEZ movement as communists or communist sympathizers. He distributed an article entitled "The Grapes", concerning the Delano GrapeStrike, which appeared in the June, 1966, issued of "American Opinion", Page 4. There is a picture in this article of over twenty persons, among whom was SAM KUSHNER, whom WESTERFIELD identified as communist. At press conference, WESTERFIELD pointed to young man in photograph, who was wearing light colored sweater, and commented that "The FBI was investigating this man as SIRHAN SIRHAN." NEVINS compared a newspaper photograph of SIRHAN with picture of man in light colored sweater and said there was close resemblance.

KUSHNER is a member of the Southern California District Communist Party and was active in covering Delano Grape Strike for Daily People's World.

Reference is made to our communication of June 6, 1968, concerning Mrs. Nadia J. Morales, 915 15th Street, Apartment B. Modesto, California.

Anna Campbell, Personnel Director, Good Samaritan Hospital, Los Angeles, California, advised on June 11, 1968, that Nadia J. Morales formerly employed as helper in hospital's dietary foods Section. Campbell advised hospital records reflect Morales to have been very unsatisfactory employee who was unable to perform even relatively uncomplicated work.

Hospital records failed to reflect any doctor on the Good Samaritan Hospital staff named Cohan Hoseld, Cohan Hussell, or any similar name. Also, hospital records failed to reflect any employee named Vincente who works in the hospital bakery.

Dorothy McDaniel, Chief Dietitian, Good Samaritan Hospital, advised that Nadia J. Morales was poor employee and would have been terminated had she not resigned on April 1, 1968. Morales was incompetent in her work and unable to get along with fellow employees. McDaniel advised that in her opinion Morales was an emotionally maladjusted person.

Morales was grossly incompetent and unable to perform simple work in an acceptable manner. Morales felt that the other kitchen help did not care for her as she was of Arab extraction and most of the other kitchen help was of Spanish descent. Freeman advised that Morales was such an incompetent employee that other employees did resent Morales to a degree. Miss Freeman is of the opinion that Morales may have an emotional problem.

Dorothy McDaniel made available a letter from Mrs. Morales postmarked May 29, 1968, at Modesto, California, wherein Morales writes that, "The old man that wears glasses be works in the bakery" had made her baby Morales wrote that the unnamed person's wife was nitting the child and making the child perform such acts.

Severino Navarro, Baker, Good Samaritan Hospital, is described as an elderly man who wears glasses. Navarro advised that his wife does baby-sit at times but that he does not recall knowing Morales. He stated that he is quite certain that his wife never baby-sat for any one named Morales.

LYLE SANDLIN Los Angeles Police Department is assigned to the Special Unit investigating the KENSALT case, and had planned to interview OWEN, at Palo Alto, but had decided against the interview at this time and planned to wait until OWEN returned to SANTA ANA.

ANDREWS advised that they have learned that OWNES has hired an attorney, MARON GEORGE DAVIS, to represent him, for what reason is unknown, but OWENS will be interviewed by the press in the near future at which time OWENS will have a sack over his head so he can not be identified, due to the threats allegedly made against him.

ANDREWS advised that no such threats are known by the LA office or the Los Angeles PD. He noted the PD considers OWENS to be somewhat "unstable".

ANDRESWS said as yet OWENS has not been interviewed by the FBI, BUT WILL PROBABLE be interviewed when he returns to his home.

She advised that on the afternoon of June 5, 1968 she attempted to docated in the files, the order placed by this individual, but could not. She then dismissed the whole thing until the following Saturday when she read the name of JESUSPFREZ as one the persons who was wounded in the fusillage of shots in the hallway where the Senator was killed. She remembered that a person with the same name had come in about fifteen minutes later and had requested telephone xxx service. She added that her recollection of the PEREZ whom she waited on did not resemble thepicture of the PEREZ appearing the the Sacramento Union of 6/8/68. However, due to the circumstances she decided to inform her supervisor MR. TERROL J. WILSON, Manager of the Commercial Department.

MR. TERROL J, WIISON advised that as a result of the above he had requested an exhaustive search to be made of the records of new and old service in the mames of SIRHAN SIRHAN, IRVIN STROLL, IRVIN STROHL, and JESUS PEREZ.

MRS. SMITH SUBSEQUENTLY ADVISED that on the day Senator KENNEDY, she first heard the news at 6:00 AM and was greatly shocked. At no time during the day, subsequent to her arrival at work, between 0:00 AM and 0:15 AM did she hear anything further in the news until that evening. She noted that at no time did she lave the building during the day, that there are no radios or television sets in the space where she was during the day, and she did not discuss the above with anyone at all during the day. However, she claimed she started searching for the names SIRHAN and STROLL (ph) that same afternoon, 6/5/60. (It should be noted that the name of SIRHAN was not in the news until later on in the day, subsequent to 0:15 am).

MR. WILSON on 6/18/68 advised that after an exhaustive search of every possible record, vg, published and unpublished numbers, requests for new service, chronologically searched 5/24/68 and 6/5/68, as well as all deposits made between those dates, no record could be located for any of the above names. He did note that on 5/31/68 one NESUS CHAVEZ made a request for telephone service and that MRS. SMITH feels that this is the person whom she took for JESUS PEREZ.

MRS. WILSON also advised that MRS. SMITH now feels that she is being followed by two negroes in a blue car, and that this would tie in with her impression that the SIRHAN is Muslin, that the negro who placed had the appearance of being a Muslin and that all this may tie in. Mr. WILSON advised that in view of this, plus the fact that no record could be located of any requests for telephone under any of the names suggested by MRS. SMITH he wondered if MRS. SMITH may not be emotionally overcome in this matter. It should also be noted that MRS. SMITH claimed to be searching therecords for telephone service in the name of SIRHAN during a period of time she admits she had not yet heard the name.

In view of the above no further action is recommended.

He stated he did not know it was SIRHAN until he viewed recent photographs of SIRHAN in newspapers and on television. SIRHAN appeared well educated, spoke intelligently with good English and had only a slight trace of an accent. He stated during the early part of the races SIRHAN's only conversation was about the various horses and matters generally pertaining to racing. He said that later, during possibly the fifth or sixth race, a man's name which appeared to be Jewish appeared on the card and SIRHAN stated he was "an Arab" and began degrading the Jews. He advised SIRHAN was standing with him and his brother from about the third race until they left at the end of the eighth race for a total time span of about one and a half to two hours.

Mrs. HANF stated that on Thursday, May 16, 1968, she was standing in a hallway behind the stage at Freeborn Hall, University of California, Davis, California, prior to the arrival of Senator ROBERT F. KENNEDY, who was to speak to students and faculty on that date. She stated that approximately 3:10 p.m., while back stage she noticed an individual whom she described as Middle Eastern in appearance, dark curly hair, 5 feet 4 inches, slim build in his early 20s, wearing a checked blue and white sport shirt, open at the collar, and dark jeans. Mrs. LOUISE FITZPATRICK, 4345 Rio Tinto Avenue, advised that she is the wife of BARNEY FITZPATRICK, who is a Special Assistant to Dr. MAX RAFFERTY of the California Department of Education, and that she attended a party and victory celebration for Doctor RAFFERTY in the Venetian Room of The Ambassador Hotel in Los Angeles on the night of June 4-5, 1968.

She recalled that at approximately midnight, Doctor RAFFERTY appeared before television cameras in the Venetian Room to deliver a victory speech following his apparent winning of the election.

Approximately ten minutes prior to this time, she observed a person in the middle of the Venetian Room whom she believed resembled SIRHAN BISHARA SIRHAN. This person was wearing light-colored trousers and a blue, lightweight nylon jacket, zipped up the front. She did not know any other person who noticed this individual or if he was accompanied by anyone else, and she did not see him again. She stated she only had a fleeting glance at this person but remembered him because he appeared to be a Mexican or similar minority racial group member. She said he appeared to be tired and thought at the time that he was one of several young people who had been working as stagehands and helpers in the Venetian Room.

Doctor MAX RAFFERTY, Superintendent of Public Instruction and Director of Education, California State Department of Education, 721 Capitol Mall, advised that during the evening of June 4, 1968, he remained in a private room at The Ambassador Hotel, Los Angeles.

During this period he was viewing television election returns with close friends and political supporters concerning his candidacy for the Republican nomination to a seat in the United States Congress.

Shortly after 11:30 p.m. it became apparent that he had won the election so he and his group went to the Venetian Room of The Ambassador Hotel, where his main victory celebration was in progress, attended by 300 to 400 persons.

Doctor RAFFERTY said that at about midnight he began addressing the group in the Venetian Room but was interrupted with the news that Senator ROBERT F. KENNEDY had been shot. He was immediately escorted to another room in the hotel where he remained for the rest of the night under protection of the Los Angeles Police Department.

Doctor RAFFERTY related that he had no personal knowledge of the possible presence of KENNEDY murder suspect SIRHAN BISHARA SIRHAN in the Venetian Room on the

night of June 4-5, 1968. He added, however, that it was his understanding that the wife of his Special Assistant, BARNEY FITZPATRICK, had claimed to have seen SIRHAN there.

Doctor RAFFERTY noted that the June 21, 1968, issue of "Life Magazine" carried allegations that SIRHAN had been thrown out of the Venetian Room and had been refused a drink by a bar hostess there but that no such information had come to his attention from any source who attended the party.

Doctor RAFFERTY said that he did not know if any security guards were present in the Venetian Room or if invitations had been required to gain entry there; however, this information would be readily available at his campaign headquarters in Los Angeles.
