On 6/7/68, JOHN FAHEY, a chemical solvent and cleaning salesman, came to the Los Angeles Office as a complainant, and stated he had met a woman named GILDERDINE OPPENDEUMER (phonetic) in the coffee shop of the Ambassador Hotel on 6/4/68. She struck up a conversation with him, told his she was in trouble and wanted to talk to someone she could trust. FAHEY, who gave the appearance of being rational, talked to the woman, who asked if she could accompany him on a business trip he had planned for the day to Ornard and Ventura, California. FAHEY agreed. In the course of the day, the women told him she was being followed and watched, which FAHEY believed as a car followed them for a time. She stated Senator KENNEDY was "no good", and if complainant attended the "winning celebration" that night, he would be surprised, because they are going to get him". She would not say who was going to be "gotten," stating she did not want him to be involved.

The woman, who appeared foreign, stated she had just arrived in Los Angeles three days before from Eilat, Beirut and Ceiro. She stated she was not staying the hotel and would

TERRENCE A. FELL, 1103 North Catalina, Pasadena, California, was interviewed at the office of the FBI. FELL said that he is attached to the 115th Group of the U.S. Army and is assigned to Military Intelligence stationed at the Presidio of San Francisco. His residence in the bay area is 400 Canal Street, Apartment 311, San Rafael, California, telephone number His telephone number at the Presidio is

FELL stated that he is acquainted with SIRHAN SIRHAN, having met him in 1957 when he, SIRHAN, first came to this country with his family. SIRHAN was approximately four years older than the other boys, but was attending the same grade at Longfellow Elementary School at Washington and Catalina Streets in Pasadena.

After leaving the elementary school, FELL said that SIRHAN and he attended different junior high schools, but maintained occasional contact with a mutual friend, DAVOR PEVEC. FELL said PEVEC had much closer contact with SIRHAN as they both were aliens. PEVEC was a Croatian and SIRHAN an Arab.

Concerning PEVEC, FELL said he resides at 1120 North Mentor in Pasadena and attends school at the University of California, Santa Barbara. He works part time for the Market Basket, 1216 North Lake Street, Pasadena, California. He is not aware of the residence address of PEVEC in Santa Barbara, but believes that he possibly may be out of school for this semester.

FELL said that he and SIRHAN attended the same college, Pasadena City College, but did not have any classes together. He said that he believes the last time he saw him was either in 1964 or 1965 and thinks the occasion was when the Shah of Iran was visiting this country. He is not aware of any political inclinations of SIRHAN, except that he was very much interested in the conflicts between the Arab and Israeli nations. He was

very pro-Arabic and often spoke of going back to his homeland and helping out in the war.

FELL said that he recalls one occasion when they were in either the 6th or 7th grade, when they were playing Monopoly or some other game, that SIRHAN commented how he felt toward the Jewish people. He had apparently seen a close member of his family killed in Jordan and desired to go back some day to his homeland.

FELL said that in 1964 or 1965, when he last saw SIRHAN that FELL's father had the responsibility for the itinerary of the Shah of Iran and is fairly certain that this is the time he saw SIRHAN because he believed that he was going to attend a function or a rally where the Shah was to appear. He is somewhat hazy on this incident but believes that SIRHAN was in support of the Shah.

On one other occasion FELL said that PEVEC told him that SIRHAN did not desire to become a citizen. PEVEC had become a citizen after he had been in this country five years, but apparently SIRHAN did not want to do this, indicating that he someday wanted to return to Jordan.

FELL said he is not aware of any violent nature of SIRHAN, but did say that he seemed to have a "normal Arab temper".

He concluded the interview by saying that PEVEC would have possibly much more current information concerning SIRHAN.

THOMAS D. GOOD was located at his place of residence, a rooming house at 22 South 11th Street, San Jose, at approximately 1:30 P.M., June 13, 1968. The interviewing agents identified themselves to GOOD through display of FBI credentials. GOOD advised SAs KIDWELL and SAMPLE that he would not be able to talk to them without first consulting his attorney, one AUBREY GROSSMAN, of San Francisco.

GOOD stated that he would attempt to reach his attorney by telephone and get an opinion from him regarding an interview with FBI agents. He placed a long-distance call to San Francisco with Agents SAMPLE and KIDWELL present, and was informed that Mr. GROSSMAN was not available. SA KIDWELL asked GOOD if the name SIRHAN SIRHAN was familiar to him. GOOD responded that he recognized the name. SA KIDWELL asked him if the name was familiar to him over and above what he had read recently in the press. GOOD replied that it was.

SA KIDWELL informed GOOD that the interviewing agents desired to discuss SIRHAN SIRHAN with him. GOOD stated that even though the topic of interview was to be in connection with his knowledge of SIRHAN SIRHAN, he still would need the approval of his attorney before being interviewed. In conclusion, he stated that he would attempt again to reach Mr. GROSSMAN during the afternoon of June 13, 1968, and upon receiving Mr. GROSSMAN's opinion in this matter, would immediately recontact FBI agents.

LUZ ELENA CORDOVA-IZURIETA, who is also known as Luzeta Cordova, was interviewed at the residence of Mrs. CHARLES SMITH, 522 Vine Street, San Jose, California. The interviewing Agents identified themselves to CORDOVA through display of FBI credentials. The interview was conducted in both the English and Spanish languages. CORDOVA advised as follows:

She was born on November 20, 1918 at Guaycul, Ecuador. She was admitted to the United States at Los Angeles, California, as a permanent resident alien on October 1, 1961. She exhibited alien registration card She resided in Los Angeles, California in 1961 and 1962 and was employed in that city as a nursing aid at the Community Hospital, View Hospital, and Doctors Hospital.

She moved to Panama City, Republic of Panama in February, 1963, and was self-employed as a private nurse in Panama City. While living in Panama City, she became interested in the Rosicrucian Order also known to her as AMORC. She did not become a member of the organization at this time. In February, 1964, she moved from Panama City to New York City, New York. While in New York, she stayed for a time with a friend, one ALICIA A. WATSON on East 23rd Street in Brooklyn. She later moved to her own apartment at 308 East 90th Street, New York City, Apartment 1-B. She worked as a babysitter and housekeeper for several families in New York and in August, 1966, she traveled from New York City to San Jose, California.

She also recalled that during the period of her residence in New York City she left the United States on one occasion to visit some friends in Peru, South America.

After arriving in San Jose in August, 1966, she lived at the Deanza Hotel on West Santa Clara Street for one month and then moved to the Terry Hotel, 286 West San Carlos Street. It was during this period that she visited the Rosicrucian Park in San Jose and furthered her interest in

She obtained private case work with a Mrs. STONE and Mrs. ROBINSON, working both as a private nurse and housekeeper for these people. On May 11, 1968, she returned to San Jose and took up temporary residence with Mrs. CHARLES SMITH at 522 Vine Street. CORDOVA stated she is unemployed and presently is seeking employment.

CORDOVA stated that she has written many letters over a period of many years to prominent people in the United States. She stated that she has corresponded on more than one occasion with the late Senator ROBERT F. KENNEDY. She advised that she wrote a letter to Senator KENNEDY in November, 1967 from New York City, and in this letter she mentioned the Rosicrucian Order. She stated in the letter that she believed the Rosicrucian Order planned to kill the KENNEDY family.

CORDOVA was asked to give her reasons for this conclusion. She stated that she has no particular reason for making this statement, and she seemed confused when asked this question. The question was repeated several times and in several different ways. CORDOVA was unable to respond to the question except to state that RALPH LEWIS, the present leader of AMORC in San Jose, "is a spy for Russia."

CORDOVA stated that all of the other people connected with AMORC are honest and loyal, explaining that the only person in the organization that she was concerned about was

Mr. LEWIS. She was unable, however, to give any specific reason for her concern. CORDOVA recalled having advised Senator KENNEDY to write to an organization known as Silent Unity, Lee's Summit, Mississippi, and she stated that this is an organization that accomplishes much through prayer. CORDOVA was asked if she thought AMORC or any member of that organization was responsible for the death of Senator KENNEDY. She replied that she did not know, stating that she thought that Mr. LEWIS' action were suspicious.

She could not further explain this remark.

Mrs. Charles SMITH was interviewed at her residence 522 Vine Street, San Jose. The interviewing agents identified themselves to Mrs. SMITH through display of FBI credentials. Mrs. SMITH advised as follows:

She stated that she is a friend of LUZETA CORDOVA who is also known as LUZ ELENA CORDOVA - IZURIETA. advised that she met CORDOVA in August of 1966 when CORDOVA was a resident at the De Anza Hotel in San Jose where she, Mrs. SMITH, was employed in the housekeeping department. She advised that she saw CORDOVA occasionally from August of 1966 until March of 1967 when CORDOVA left San Jose to return to New York City. She stated that CORDOVA is from Ecuador and is an alien having come to the United States in approximately 1961. She has corresponded with CORDOVA on several occasions. During May of 1968 CORDOVA advised her by mail that she was returning to San Jose and since Mrs. SMITH has recently been involved in an auto accident in which she was injured. She suggested that CORDOVA might come to San Jose and live in her home temporarily. Mrs. SMITH explained that CORDOVA obtained employment as a nurses aid or practical nurse and she thought CORDOVA would be of some assistance to her.

CORDOVA returned to San Jose during the first or second week of May 1968 and has been living at the SMITH residence since that time. SHe has been unable to find work which suited her. She obtained one job which she held for 2 days and then quit informing SMITH that her employers at attempted to steal some of her personal belongings.

SMITH stated that CORDOVA has been acting in a rather strange fashion since coming to San Jose. She has difficulty sleeping and will not retire without placing a number of small religious status. on the floor around her bed. SMITH stated that CORDOVA will not leave the home without secreting small religious charms and artifacts in her hair and beneath her clothing. She stated that CORDOVA spends much of her time both day and night writing letters. She is secretive

about persons to whom she is writing and has refused to allow SMITH to enter the bedroom she is occupying. SMITH stated that she is quite concerned regarding CORDOVA's mental and emotional condition. She stated CORDOVA is pleasant and usually nice to be around. She further advised that she is suffering from some rather severe emotional upset and suggested that CORDOVA may be experiencing menopause. Mrs. SMITH was quite concerned that the FBI was interested in CORDOVA. She stated that CORDOVA has been somewhat agitated since the death of Senator ROBERT F. KENNEDY. She advised that CORDOVA has spoken of this event on numerous occasions. Mrs. SMITH was asked if she knew of any fraternal organization in which CORDOVA was interested. She replied that CORDOVA has told her of her interest in Rosicrucians Order which group has their international headquarters in San Jose.

In conclusion Mrs. SMITH stated that she expects CORDOVA to leave her residence within the next two or three weeks after she obtains permanent employment in the area.

He stated that he is presently employed as an instructor in physical education and assistant track and field coach at San Jose State College, San Jose. He stated that he will be leaving this position in the near future to take up similar duties at Mc Gill High School, Spring Valley district, San Diego, California.

Mr. BANKS was shown a photograph of SIRHAN SIRHAN. He stated that the photograph is familiar to him and added that he believes he had SIRHAN in a track and field class at Pasadena City College, Pasadena, California during 1965. He stated that SIRHAN was a fair athlete, he did not attend classes regularly and received either a "D" or a failing grade in the class. He stated that SIRHAN was a difficult young man to understand, not as a result of any language problem, but simply because he did not converse or open up with either his classmates or the instructor. Mr. BANKS stated that he has no other information concerning SIRHAN's general background or his political and nationalistic tendencies. He advised that he has not seen this individual since 1965.

CHERYLE PIERTE, 1963 Oak Street, San Francisco, came to the San Francisco Office of the FBI on June 20, 1968 at which time she advised that she knew SIRHAN SIRHAN as a co-worker at Mr. Weiher Health Food Stores in Monterey Park, California, during the four or six week period of her employment during January to February, 1968.

Miss PIERCE said that she only worked on Sundays and that her knowledge and contact with SIRHAN was limited to that of a fellow employee. She stated that SIRHAN was a conscientious worker. He had no visits by personal friends. He never discussed political matters with her and did not engage in any philosophical discussion. She did not observe any sign of mental instability and thought that he was of Mexican ancestry.

On 6/15/68 Willis Chalmers, Manager, Central Hotel, Eureka advised that about 8:08 pm on 5/23/68 two men who said they were brothers checked into his hotel. They registered as Ahmad L. Abrahaim, 2311 Taraval St., San Francisco.

These men said they were tourists from Jerusalem. Descriptions: age mid 20's, small builds, about 65", 125#, dark wavy black hair, dark eyes, spoke with foreign accent, dark comlexions.

They apparently tried to make a phone call to Jerusalem because late in the evening a call from Jerusalem was received at the Hotel for them. Mr. Chalmers listeded to the call and noted they spoke in a foreign tongue, unknown to him.

These men departed the nextday. Mode of travel unknown, but probably by Greyhound bus on the \$99.00 tour America fare.

Chalmers thought this night be of interest because he believes now this was the same night Robert Kennedy was in Bureka at the Inn.

Available sources reveal that Robert Kennedy was in Eureka on Thursday May 16, 1968 for less than two hours. He arrived by chartered jet plane around 7pm and was gone before 9pm. He spoke briefly at the Inn in Eureka to a large crowd.

RECOMMENDATION: Mr. Chalmers is in error in recalling that Kennedy was in town on 5/23/68 rather than 5/16/68. Therefore the entire basis of his suspicion is removed. It is not felt this needs further inquiry.

BAYER further indicated that he is an amateur photographer and he enlarged this picture and is satisfied in his own mind that it is identical to SIRHAN. BAYER said that he obtained the reprint from a public source, stating that he is collecting articles on communism in this country. He is an escapee from East Germany and has been in this country since 1961.

The above information and enclosure is being submitted to LA for whatever action deemed appropriate.

Enclosed for Los Angeles is a copy of a tape recording of a portion of the Hilly Rose radio show of Memorial Day, May 30, 1968, which need not be returned.

The tape was made available by Mr. RON REYNOLDS, Program Director, KNEW Radio Broadcasting Station, 56 Jack London Square, Oakland, California, on June 19, 1968. Hr. REYNOLDS noted that GEORGE PLIMPTON of New York was the guest of ROSE during his morning broadcast of May 30. An anonymous caller, whose voice was not recognized as a regular caller, estimated to be a male in his 50s or 60s, appeared to be a supporter of ROBERT F. KENNEDY. This caller asked if consideration had been given by ROBERT F. KENNEDY to the possibility that he could be killed as had his brother, JOHN F. KENNEDY. The reply to the caller was that anyone in the public light must expect that such things are a possibility.



CRISPIN CURIEL GONZALEZ, Also Known As Alejandro Zaldovosqui Zamora

On June 17, 1968, Jose Refugio Rubalcava, Assistant Commander, Chihuahua State Judicial Police, Juarez, Mexico, advised that Crispin Curiel Gonzalez had been taken into custody on receipt of information that Curiel had possibly participated in the plot to assassinate Robert F. Kennedy at Los Angeles, California.

Curiel had in his possession, a letter written in English, which alleged that he had planned the assassination of Kennedy while under the influence of a drug which would destroy his memory. Curiel indicated he was an American citizen.

Newspaper reporters at Juarez interviewed Curiel in detail, at which time he admitted having written the letter, but without giving his motive. He then indicated that he had always wanted to do something big, and he spoke out vigorously, denouncing the Kennedy family as trying to establish a dictatorship in the United States. At this time, he stated that he would murder Edward Kennedy at such time as Edward Kennedy became a candidate for the presidency of the United States.

Curiel admitted the use of marijuana and LSD and stated the had left a juvenile detention home in Los Angeles, California.

On June 17, 1968, Curiel was interviewed by Special Agents of the FBI, at which time he stated that he

considered the letter and his earlier interview with Juarez newspaper reporters as a big joke, explaining that newspaper reporters want news and this is what he gave them. He denied all specific knowledge of the Kennedy assassination, and stated that he had only seen Sirhan Sirhan on one occasion in the Main Public Library in Los Angeles, California. He described Sirhan as a "crazy Arab".

When questioned regarding his threat to kill Edward Kennedy, he emphatically denied this, and restated that he was only trying to be a "big shot with the press".

Of a background nature, Curiel stated he had been residing at the Manhattan Project, a juvenile home run by the Salvation Army, 602 South Van Ness, Los Angeles, and he identified his Probation Officer, specific nature of charges not determined, as Robert Wineandy, Vermont Avenue, Metropolitan Division, Los Angeles.

He stated that about three weeks ago he ran away from the detention home, and had been arrested by local police at Healdsburg, California while hitchhiking. He identified himself to the police as Alejandro Zaldovosqui Zamora, a Mexican citizen, born in Colima, Colima, Mexico. He was turned over to Border Patrol authorities and sent to Santa Rosa, California, and was subsequently flown to El Paso from where he was to be deported. At El Paso, he identified himself properly as an American citizen, and he was released from custody.

On June 18, 1968, Warren B. O'Neal, Chief, Investigations Division, U. S. Immigration and Naturalization Service, El Paso, advised that Curiel, as Alejandro Zaldovosqui Zamora, had been arrested in Healdsburg, California by Sergeant Bartoli of the Healdsburg, California Police Department, on May 31, 1968, when he noticed subject was being held forcibly inside a telephone booth.

Healdsburg Police Department records indicate that Zaldovosqui was being detained by Mischa Hain Karioff, 141 Cardiff, Los Angeles, California, telephone 271-4803. date of birth February 21, 1951, and by Byron

Samuel Gamberg, 3748 Westwood Boulevard, Los Angeles, California, telephone date of birth October 7, 1951.

After subject made his claim to be of Mexican citizenship, he was turned over to Border Patrol officials and lodged in the Juvenile Detention Home, Santa Rosa, California, for one day, and was then transferred to Livermore, California, where he stayed three days prior to being airlifted to El Paso.

In El Paso, Zaldovosqui identified himself as Crispin Curiel Gonzalez, an American citizen, born November 10, 1951, at Ephrata; Wahington, of Crispin Curiel Zamora and Maria Cruz Gonzalez.

O'Neal caused a check of birth records at Olympia, Washington, and verified the information as furnished.

Based on this, Curiel was released from Immigration custody at El Paso on June 6, 1968.

On June 18, 1968, "El Fronterizo", a Spanish language daily published at Juarez, Mexico, carried an extensive front page article including a photograph of Curiel, and captioned "Dangerous Yankee who says he is a conspirator in the Robert F. Kennedy crime advises the next one will be Edward Kennedy." This article sets out in detail, the information furnished by Assistant Commander Rubalcava, and the results of interview with Crispin by newspaper reporters.
