Facts of complaint

Information furnished that while in the lounge of the Princess Martha Hotel, St. Petersburg this night an individual, identified only as ALFRED, "struck up" conversation with complainant and during the conversation related the following:


Alfred alleged that he had been approached by individuals he would not, or could not identify by name, who attempted to proposition Alfred to assassinate Senator Robert F. Kennedy. No pertinent details furnished re this matter and complainant advised that Alfred rambled during conversation and that while he was drinking, he did not consider Alfred to be drunk when making allegation re assassination plot.

Alfred alleged that he is retired from a branch of the military by reason of disability; however, complainant advised that he gave a conflicting account of his military service.

William E. Goodrich, bartender, Princess Martha Hotel, St. Petersburg, advised that Alfred has been in his bar three or four times during the past few weeks and he has evaluated Alfred as being a "nut". Advised that Alfred has been loud and very talkative at the bar, but has not caused any incident wherein he should be extricated from the premises. Advised that he has cashed a number of travelers checks for Alfred but does not know where he is residing and stated that he appears to be a transient. Further stated that Alfred is a "well dressed" person and did not give the appearance of being a "bum".

Supervisor Belanger advised and SA Granger designated to contact complainant for more details re matter. SA Granger contacted and info furnished re complaint.

Dear Sir:

The information furnished herewith concerns an individual who is believed to be covered by the agreement between the FBI and Secret Service concerning Presidential protection, and to fall within the category or categories checked.

- 1.  Has attempted or threatened bodily harm to any government official or employee, including foreign government officials residing in or planning an imminent visit to the U. S., because of his official status.
- 2.  Has attempted or threatened to redress a grievance against any public official by other than legal means.
- 3.  Because of background is potentially dangerous; or has been identified as member or participant in communist movement; or has been under active investigation as member of other group or organization inimical to U. S.
- 4.  U. S. citizens or residents who defect from the U. S. to countries in the Soviet or Chinese Communist blocs and return.
- 5.  Subversives, ultrarightists, racists and fascists who meet one or more of the following criteria:
  - (a)  Evidence of emotional instability (including unstable residence and employment record) or irrational or suicidal behavior;
  - (b)  Expressions of strong or violent anti-U. S. sentiment;
  - (c)  Prior acts (including arrests or convictions) or conduct or statements indicating a propensity for violence and antipathy toward good order and government.
- 6.  Individuals involved in illegal bombing or illegal bomb-making.

ALTON OTTER LEWIS CREWELGE

JAMES WALKER, on April 16, 1968, informed that he is a writer for the St. Petersburg Times, a daily newspaper published at St. Petersburg, Florida. He said that during the evening of April 16, 1968, he engaged in a conversation with an individual known to him as ALFRED. He did not know his last name. The conversation, according to Mr. WALKER, occurred in the lounge of the Princess Martha Hotel in St. Petersburg at about 8 P.M. ALFRED told WALKER that he had been approached at an unspecified time by the "head of the white Ku Klux Klan in Texas," who asked him, ALFRED, to assassinate Senator ROBERT F. KENNEDY. The method, time and place were not discussed, but ALFRED, according to Mr. WALKER, rejected the proposal. ALFRED admitted to Mr. WALKER having been previously committed to a mental institution. Further, ALFRED said that he is now undergoing psychiatric treatment. He remarked to Mr. WALKER that he is retired on a disability pension from some branch of the military service.

Continuing, Mr. WALKER said that ALFRED remarked that President LYNDON B. JOHNSON has been responsible for the murder of numerous unidentified people and that he, ALFRED, had written a book revealing this information. ALFRED commented that President JOHNSON had attempted to have him "locked up" for disclosing this information. WALKER said that ALFRED did not disclose his current address, but did remark that he was from the same county in Texas that President JOHNSON is from. Mr. WALKER described ALFRED as a white male, between 35 and 45 years of age, 5'11", 200-220 pounds, husky, with a blonde crewcut. Mr. WALKER expressed the opinion that ALFRED was sober but irrational in his conversation.

ALTON OTTER LEWIS CREWELGE

On April 16, 1968, Mr. WILLIAM GOODRICH, bartender, Princess Martha Hotel Lounge, said that ALFRED had been in his bar about four times within the past three weeks and had cashed several \$20 Traveler's Checks. Mr. GOODRICH, who said that he did not hear ALFRED's remarks about Senator ROBERT F. KENNEDY, said that ALFRED has been irrational in his conversations. He was of the opinion that ALFRED's last name was BAUNGARDNER, BURMEISTER or BALCOM.

On the evening of April 16, 1968, a Special Agent of the Federal Bureau of Investigation in St. Petersburg, Florida informed Mr. ARNOLD PEPPERS, Secret Service, Tampa, of the above information, and Mr. PEPPERS said that, from the information furnished, the individual described as ALFRED was unknown to him.

On April 17, 1968, Mr. WILLIAM GOODRICH remarked that he had learned that the person he referred to on April 16, 1968 as ALFRED, when he left the Princess Martha Lounge on April 16, 1968, proceeded to the Edgewater Lounge in St. Petersburg, Florida.

On April 17, 1968, Mr. JOE SOROKOWSKY, bartender, Edgewater Lounge, St. Petersburg, Florida, said that he observed an individual in his bar late on the evening of April 16, 1968, and that after conferring with his friend, WILLIAM GOODRICH, concluded that it was the same individual who had visited the Princess Martha Hotel Lounge earlier in the evening.

Mr. SOROKOWSKY said that this individual cashed a \$10 American Express Traveler's Check on April 16, 1968 and that the signature appearing thereon was ALTON O. L. CREWELGE. No other information, according to SOROKOWSKY, appeared on the check concerning CREWELGE, and there was no indication where the check may have been issued. He said that a number appearing on the upper right side of the check was AB 71-124-855. He said that another number appearing on the bottom of the check was 8000-0005-12--07112-8553. Mr. SOROKOWSKY said that he did not request any identifying documents from CREWELGE when the latter cashed the check. He said that CREWELGE departed the Edgewater Lounge in an Independent Cab at about 11:30 P.M., April 16, 1968. He said that he possessed no further information concerning

CREWELGE, but concluded by saying that during the time he was in the Edgewater Lounge on April 16, 1968, the other customers there noticeably avoided him, CREWELGE.

On April 17, 1968, Mr. ROBERT CONNELLY, Secret Service, Tampa, Florida, was made aware of the above information, and he said that he had obtained information indicating the possibility that the individual mentioned above is ALTON OTTER LEWIS CREWELGE, a white male, who was born January 22, 1933 at Fredericksburg, Texas. He said that CREWELGE has blonde hair, blue eyes, and is 5'11", weighing 220 pounds.

Further, Mr. CONNELLY remarked that CREWELGE has been adjudged mentally incompetent by the Veterans Administration because of his, CREWELGE's, schizophrenic personality.

Mr. CONNELLY commented that CREWELGE has been of interest to the Secret Service since 1964 in connection with this individual's having allegedly made threats to the President of the United States. He said that the Secret Service last spoke to CREWELGE on March 18, 1968, when the latter was living at the Neuches Hotel, 513 North St. Mary Street, San Antonio, Texas.

On Thanksgiving Day, November 26, 1970, a representative of the Federal Bureau of Investigation observed an unknown white male enter the Soviet Embassy, 1125 16th Street, N.W., Washington, D. C. (WDC) at 9:07 a.m. and depart at 9:14 a.m.

Other representatives of the Federal Bureau of Investigation observed him proceed to the Greyhound Bus Terminal, New York Avenue, and 12th Street, N.W., where he placed his airline flight bag inside a locker.

While at the terminal he was questioned, by use of a suitable pretext, by Officer H. L. Daniels, Wackentat Security Guard on duty at the terminal.

He identified himself as Alton Cremelge and stated he was born January 21, 1933 at Fredericksburg, Texas and he had arrived in Washington from Waco, Texas in order to visit the Australian Embassy to secure employment.

He was described, from observation, as follows:

ALTON OTTER LEWIS CRENWELGE

On April 16, 1968, James Walker, a writer for the St. Petersburg Times, a daily newspaper in Florida, reported details of a conversation he had with an individual in a St. Petersburg bar who was later determined to be Alton Otter Lewis Crenwelge.

Crenwelge told Walker that he had earlier been approached by the "Head of the White KKK in Texas" who had asked him to assassinate the late Senator Robert F. Kennedy, however, he rejected the proposal. Crenwelge advised Walker that former President Johnson was responsible for the murder of numerous people and the President had him "locked up" because he revealed this in a book he had written. Crenwelge admitted having been committed to a mental institution and of undergoing psychiatric treatment at that time.

Walker characterized Crenwelge as sober but irrational.
