He picked up two hitchhikers in Los Angeles on Monday, June 3, the day before the California Democratic primary, which Kennedy won.

Jones says one of the youths was Sirhan Bishara, Sirhan, the Jordanian accused of killing Kennedy. The other was taller, but seemed to Jones to be of the same nationality.

Talked About Horses

Hecause Jones is a horsemak by avocation and buys and sells horses and Shetland ponies, they talked of horses.

Sirhan wanted to buy a pony to exercise race horses so he could get a job at a race track. Jones had one that suited, but Sirban said he would not have the price, \$300, until late that night.

Sirhal asked to be led off ear the Ambassador Hotel "to see a friend in the kilchn." That night Sirhan prowouldn't have the remainder until 8 a.m. Tuesday.

At that time, Sirhan did not show up. Instead there was an older man who appeared to be of the same nationality. Jones quoted him as saying, "Joe couldn't make it." He said Sirhan really wanted the horse and could pay for it Tuesday night at 11 p.m. if Jones would deliver it at the spot near the Ambassador where Jones had let him out.

The Ambassador is where Kennedy was shot.

Preaching Out of Town

Jones said he was preaching out of town and couldn't make it. He gave the older man, whom he described as about 35 and expensively dressed, his buliness card with his unlisted telephone number.

On Wednesday, Jones did not hear that Kennedy had been shot until he was having lunch with friends. A picture of the still-unidentified suspect was flashed on a television show, and Jones said he recognized it as the youth who had wanted to buy the horse.

The next day, Thursday, he got the first threatening telephone call, he said. An unaccented voice he could not recall having heard before told him: "Keep your mouth shut about this horse deal if you

Three days later the voice in another call reminded him he had been warned once before and repeated the profane threat to keep his mouth shut, He told police about the calls, and picked Sirhan's picture out of 30 they showed him.

Told To Hide Out

On Wednesday, he came north, looked up Hardister and told him his story. Hardister advised him to go into hiding and to consult Davis.

phone number is that older man who told me 'Joe couldn't make it," Jones said.

Jones says he went to police because he felt he should and friends advised him to. He describes not only Sirhan and his youthful companion and the older man, but another man, apparently a Jordanian, and a girl. He says he saw Sirhan talk to the girl at one of their stops and later saw her with the older man who came to tell him Tuesday night ¶"Joe couldn't make it."



Trial protection

Sirhan gun shield slated

LOS ANGELES (AP) —Sirhan Bishara Sirhan will sit behind a shield of bulletproof armor plate and glass if he is tried as expected in Los Angeles on a charge of murdering Sen. Robert F. Kennedy.

He will be led to the courtroom from a cell through a sealed passageway whose windows will be covered by heavy steel plates.

The County Board of Supervisors decided Tuesday to author ze unlimited expenditures to assure the safety of the 24-year old Jordanian, accused of shooting Kennedy June 5.

The cost of the protective equipment was estimated at

\$20,000. Of that, \$1,500 would be for work on the passageway and the rest for "armor plate, armor glass, steel plate and wire netting in the courtroom."

SEVERAL threats have been made on the life of Sirhan as well as his lawyer and others connected with the case.

The accused had been expected to enter his plea Friday on the ninth floor of the Hall of Justice, a floor above the courtroom where he probably will be tried. But the plan was canceled because the security measures were not ready.

A precise description of the security devices was not made public, at the request of Superior Court Judge Donald R. Wright. But Supervisor Kenneth Hahn said the shield could be large enough to protect not only Sirhan but also the trial judge, attorneys and jury.

A spokesman for the Board of Supervisors describe the glass as bulletproof with metal reinforcements. There was no further elaboration.

Hahn said the county mechanical department will begin work on the bulletproof shield Friday. A room on the 13th floor of the Hall of Junice is being equipped for use in noncourtroom proceedings with new walls and steel doors.

Los Angeles, June 25—Confrom the courtroom and the old struction of a bulletproof county jail on the 10th floor of inclosure to protect Sirhan Bishara Sirhan at his trial for the murder of Sen. Robert F. Kennedy was authorized today by the county board of supervisors.

The armor plated and armored glass enclave in the courtroom will be expanded also to safeguard the judge, jury and attorneys, it was indicated. Many threats against Sirhan's life have been received by telephone and mail.

Will Enter Plea Friday

- Sirhan, 24, a Jordanian immigrant seized after Kennedy was fatally wounded early on June 5 in the kitchen of the Ambassador hotel, is scheduled to enter a plea Friday to the murder indictment and to five counts of assault to commit murder in the shooting of five other persons.

Supervisor Kenneth Hahn said the county mechanical de-partment will begin building the inclosure Friday unless Sirhan's attorney gets a change of venue. The protective device, which may cost up to \$20,000, was requested by Judge Donald R. Wright, presiding judge of Superior court. Judge Wright and Sheriff Peter Pitchess will direct the construction.

Safeguard Sirhan's Route





Guns Drown Out Voice Of People



It has not been quite a month since the death of Robert Kennedy, but there has been time enough for those who wish to forget him to do so. Some who prefer to pretend that he had not passed this way at all evidently were Bobby Kennedy's colleagues in the Senate of the United States.

Seven who had been his fellow senators voted against his memory; against the pleas of his brother, and against the heartbreak of his family. Those seven are members of the

Senate Judiciary Committee, and their votes last Thursday were sufficient to delay consideration of stronger gun control legislation until July 9.

During the two weeks after an assassin's bullet had made Bobby Kennedy the second martyr of his family, there seemed little doubt that his wasteful death would serve one purpose. The nation would get the gun controls that the people had wanted and needed since the first Kennedy martyr died in Dallas.

The demand of the people was clearly heard, and we were confident that those senators and congressmen who had not had the courage in the past to vote as their conscience told them to vote would be emboldened by the mail from home. For the first

time those of us who want stronger gun controls made more noise than did the National Rifle Assn. and its allies.

But I suppose that what happened last Thursday was predictable. On June 20 I wrote in this column: "We have been favored to win stronger gun controls in other contests in other years, but the gun lobby and the NRA prevailed because, in the jargon of football coaches, 'they wanted it a little more."

 So the gun lobby and its cohorts waited while the mail poured into the Senate and House office buildings from those of us who insist that the three is now for better gun control laws.

They waited because they believed we would grow tired of the game. They waited and then they opened up with their own mail barrage.

So effective were they that most congressmen and senators in Illinois, my home state, reported last week that their mail was beginning to turn against stronger gun laws.

This is a game of wills that should be no contest. The National Rifle Assn, has fewer than 1,000,000 members. There are so many more of us than there are of them, but we must compete. All that is required is a few moments of your time during this holiday week. Write to your senator and to your congressman. If you have expressed yourself to your legislators before, write to them again. Let them know that both teams can play the pressure game.

My sports-columnist accomplice on The Sun-Times, Jack Griffin, and I decided to get into this on the Monday after the burial of Sen. Kennedy. We met in the press box at Wrigley Field and agreed that "we've got to do something."

Arguments Not Valid

SINCE THEN well-meaning friends have said, "Why should a couple of sportswriters stick their necks out?"

Well, one answer is that the arguments of those who are fighting stricter gun controls usually are made in the name of sport. They accuse us of wanting to take their hunting weapons of their hands.

There is no validity to their arguments, and I've heard them all. No qualified person will be denied the right to hunt. What better gun laws might do, though, is reduce the number of women and children who are widowed and orphaned each autimn by "hunters" who shoot men in tead of animals.

Another answer is that Bobby Kennedy and his brother, Jack, stuck out their necks for us.

Calif.—Fire At Sirhan Brother

PASADENA, Calif. — Two shots were fired Wednesday into an auto driven by Saidallah Bishara Sirhan, a brother of the accused assassin of Sen. Robert F. Kennedy, police reported.

Sirhan, 35, told officers the shots came from one of two cars that followed him from Los Angeles to Pasadena on the Pasadena Freeway shortly before dawn.

The first shot struck a coat on the back seat of Sirhan's car, palice said. Sirhan said he ducked, and a second shot zipped past his head and buried itself in the door beside him.

"Had he been sitting upright, the projectile probably would have passed through his nick," a Fasadena policeman said.

A mile beyond where the shots were fired, the two cars — each containing several men — turned off or side streets Sirhan said, and he proceeded to Pasadena Police Headquarters.

Sirhan's 24-year-old brother, Sirhan Bishara Sirhan, is in County Jail awaiting trial on charges he shot Sen. Kennedy June 5 at the Ambassador Hotel.

Saidallah Sirhan is the second eldest of five Sirhan brothers. He is single and unemployed, and has been living in a Pasadena apartment away from the rest of the Sirhan family Pasadena police urged him to move into the family home, which is under heavy police guard.

Woman Reporter

Saidallah Sirhan told officers he had been in south Los Angeles early Wednesday in an unsuccessful attempt to contact a woman reporter from an underground newspaper.

He said he was returning home on the Pasadena Freeway in the downtown Los Angeles area at about 4:30 a.m. when he first noticed two autos following him.

One car, a white Volkswagen bus, contained four men, he said. The other, a green 1959 Chevrolet, contained three men.

After following him efor about six miles, he said, the two autos pulled beside him, the Volkswagen on the right, the Chevrolet on the left. Without warning, a man in the bus—possibly the driver—pointed a pistol at him and fired one shot, Sirhan said.

Two Shots

The shot shattered the right wind wing of his car and buried itself in a coat on the back seat, he said.

Sirhan said he threw himself to the right, seconds before another shot crashed through the wind wing and struck the door beside him.

Police said they recovered two bullets from the car, both 38-caliber.

Saidallah Sirhan entered the United States from his native Jordan in June, 1960, nearly a year after his mother and three of his brothers—including Sirhan Sirhan—immigrated here?

He filed a petition for naturalization on Nov. 27, 1967—the only member of his ramily to apply—but his naturalization was postponed on June 7 of this year when a U.S. District Court decided to investigate reports of alleged traffic violations.



Brother of Sirhan Fired on from Car

[Chicago Tribune Press Service] .. ' Pasadena, Cal., July 3 -Saidallah Bishara Sirhan, 35, an older brother of the accused assassin of Sen. Robert F. Kennedy, narrowly escaped death or serious injury today when two shots were fired at him as he drove along the Pasadena freeway near Los Angeles.

Police recovered two 38 caliber slugs from his car. Saidallah said the shots came from one of two cars which pursued him and drew up beside him on the freeway. He told police he leaned down below window level after the first shot.

"Had the driver been sitting upright," a policeman noted, "the projectile probably would have passed thru his neck."

Auto on Each Side

Saidallah said a white Volkswagen bus came up on his right, and a Chevrolet sedan on his left, and the shots came from the Volkswagen. One bullet passed in front of his chest and lodged in the left front door. The other bullet ricocheted and landed on his jacket which was on the floor by the back seat. There were four men in the bus and three in the other car, Saidallah said.

Saidallah said he had been in Los Angeles, trying unsuccessfully to contact a woman writer for an underground newsparer, and started back to Pasadena at 4:30 a.m.\

Heard Horns Blowing

He first observed the two cars and heard their horns blowing as he drove thru the Chinatown section of downtown Los Angeles. He entered the

middle lane of the freeway, in an interview with the Pasa-Saidallah said, to allow the dena Independent Star - News cars to pass him, but instead they flanked him, a handgun was pointed at him from the Volkswagen and the shots were fired. The pursuing cars then turned off the freeway and Saidallah drove to the Pasadena police station.

He had been notified to appear at the immigration department in Los Angeles June 7 on his application, but the hearing was canceled after Kennedy was shot. It has not been rescheduled pending disposition of the murder case.





Court Warns

Los Angeles, July 7-Donald R. Wright, presiding judge of Los Angeles Suprior court, has warned against premature construction of safety devices for the trial of Sirhan Bishara Sirhan, 24, accused assassin of Sen. Robert Kennedy.

The county board of supervisors has authorized expenditure up to \$20,000 for building of a floor to ceiling enclosure of bullet proof glass and armored netting to protect the Jordanian immigrant defenddant, the jury, the judge, attorneys, and witnesses in the courtroom.

Long Delay Possible

Judge Wright noted that the defense may make a motion for a change of venue from Los Angeles county on a contention that Sirhan cannot get a fair trial here. If such a motion is denied, the ruling could be appealed to the California Sup-reme court and possibly the United States Supreme court, and there could be a long delay before a final decision as to where the trial would be held.

Judge Wright also said if the case is tried here it will be up to the judge whom he assigns to specify what, if any, protective devices are needed in

court.

There is a feeling among some judges and lawyers that too protective conditions in court may be constred as impairing Sirhan's chances for a fair triai.

Applies to Building

Judge Wright stressed that his caution against too quick a start on safety construction applies only to the courtroom not to the other areas of the Hall of Justice which are under jurisdiction of Sheriff Peter Pitchess._

Sirhan has been held under maximum security in the new county jail building, a mile from the Hall of Justice, since early on June 5 when he was seized after Kennedy was mortally wounded and five other persons suffered lesser wounds in the shooting in the Ambas-sador hotel kitchen. He is scheduled to enter pleas on July 19 to indictments charging him with the murder of Kennedy and the attempted murder of the other five.

SIRHAN MOVED SECRETLY TO CELL OF COURT

Los Angeles, July 8—Sirhan Bishara Sirhan, 24, accused assassin of Sen. Robert F. Kennedy, has been secretly removed from the county jail to a holding cell on the 13th floor of the Hall of Justice, it was disclosed today.

If expected defense efforts for a change of venue from Los Angeles fail, Sirhan will be tried in a courtroom on the eighth floor of the hall. Sirhan's cell is isolated and a deputy is always with him. Others patrol the corridor. Heavy shields are being built over windows.

Corridors are being sealed off along the route Sirhan will walk from the cell to the court. Public elevators run only to the eighth floor; above that special jail elevators operate.

Moved by Armed Convpy

Sheriff Peter Pitchess said that Sirhan was moved yesterday from the hospital ward at the county jail, in a heavily armed three-car convoy, the mile to the Hall of Justice.

"This was part of an over-all previously scheduled program of security for the inmate," Pitchess said. It had been planned to move the Jordanian immigrant defendant before his last court appearance June 26, but security measures had not been completed then.

Sirhah was granted a continuance to July 19 to plead to indictments charging him with the fatal gunshot wounding of Kennedy and the wounding of five other persons early on

June 5 in a kitchen of the Ambassador hotel

Arraigned in Chapel

Sirlian's arraignment and the June 26 hearing were in a chapel of the county jail. The July 19 session is expected to be in the Hall of Justice.

Sirhan whisked to new cell

LOS ANGELES (AP) — Sirban Bishara Sirhan has been secretly whisked to a cell in the Hall of Justice where he will face trial on charges of murdering Sen. Robert F. Kennedy.

A convoy of patrol cars manned by seven deputies from the Central Jail completed the move Sunday, Sheriff Peter J. Pitchess announced Monday. The 14-minute move was so secret not even Russell E. Parsons, Sirhan's attorney, knew about it.



After the court session, Parsons told newspaper men: "In another case I handled a man was about to be executed. His father told of how his con had become moody and strange after suffering a head injury in a football game. The man is now in an insane asylum.'

The reference was to Darryl Kemp, who was convicted of the murder, and rape of a nurse, Marjorie Hipperson, in Los Angeles in 1957. Kemp was granted a stay June 20, 1961, the day before he was to die in the gas chamber. A jury later found Kemp insane and committed him to a state hospital.

Thrown from Horse

It was recalled that Sirhan was thrown from a horse Sept. 25, 1966. He later complained to the state department of industrial relations that his eyesight had been affected, and won a \$2,000 settlement.

Asked if he would introduce that injury as part of an insanity defense, Parsons replied, "I can't discuss my

evidence now."

When Judge Schauer asked if Sirhan was ready to plead to the indiciments charging him with fatally shooting Kennedy and wounding five other persons early on June 5 in the Ambassador hotel kitchen, Parsons spoke up, "Not yet, your honor."

Parsons said that Dr. Eric Marcus, one of the two psychiatrists appointed by the court for the defense, had made two preliminary reports, but not a final one, and that the other psychiatrist, Dr. George Abe, had not yet given any report.

Requests Brain X-Ray

Parsons said Dr. Marcus wanted Dr. Edward Davis to make an encephalogram, a brain X-ray, on Sirhan and the assistance of a psychologist, Roderick Richardson Judge Schauer approved.

The judge suggests details of examinations and treatment of Sirhan by Dr. Crahan, the jail physician, be made available to the defense. Sirhan agreed to waive his patient-doctor relationship privilege so those records could be seen.



Superior Judge Richard Schauer set a new date of Ang. 2 after Sirhan's attorney, Russell E. Parsons, said psychiatrists' reports on the 24-year-old Jordanian have not been completed.

The court also authorized one of the two court-appointed. psychiatrists to employ another doctor to make an encephalogram-or brain wave examination-of Sirhan.

Black, Blue Apparel

The 5-foot-3 defendant, as in his court appearance three weeks ago, wore tight black pants, a light blue shirt and black loafers.

Spectators Mostly Newsmed

About 100 spectators, mostly newsmen, gathered in the courtroom.

Sirhan shook hands with his attorney, sat in a leatherpadded swivel chair and shot a smile at his brother, Adel, 29, who sat about 25 feet away.

Judge Schauer asked if the two-week postponement was "algreeable to you, Mr. Sirhan!"

Sirhan replied: "Yes, sir."


