HE KNEW THE MAN ONLY AS "SAMMIE" BUT DISPLAYED A BUSINESS CARD GIVEN TO HIM BY THE MAN, WHICH BORE THE NAME SAMIR M. KHALAF, A.S.P., ST. LOUIS UNIVERSITY, THREE SIX THREE ZERO WEST PINE BOULEVARD, ST. LOUIS, MISSOURI, SIX THREE ONE ZERO EIGHT.

HE STATED HE ENJOYED CONVERSATIONS WITH THIS YOUNG MAN WHO STATED THAT HIS FATEHR WAS CONSUL GENERAL OR AMBASSADOR FROM HIS COUNTRY TO THE UNITED STATES AND INDICATED THAT THE FAMILY LIVED IN WASHINGTON D.C. AND THAT HE HAD A SISTER THERE ALSO. DEEDLE STATED THAT THE MAN WAS A "LITTLE WINDY" AND HE LOOKED UP THE NAME OF THE REAL AMBASSADOR FROM THE COUNTRY, NO SPECIFICALLY RECALLED, AND BELIEVED THE REAL AMBASSADOR'S NAME WAS FARHAN.

HE STATED THAT THE YOUNG MAN QUIT COMING TO THE PLAYBOY CLUB ABOUT ONE AND ONE HALF YEARS AGO, AND HE HAS NOT SEEN HIM SINCE. THE MAN GAVE THE IMPRESSION THAT HE WAS IN THE ARMY RESERVE OR SOME SIMILAR ORGANIZATION IN HIS OWN COUNTRY AND MIGHT HAVE TO SERVE IN THE ARMED FORCES, AND HE ASSUMED HE HAD RETURNED TO THIS COUNTRY DURING THE ARAB-ISRAELI CONFLICT.

THE YOUNG MAN HAD NO AUTOMOBILE AND WAS DESCRIBED AS WHITE MALE, TWENTY ONE OR TWENTY TWO, FIVE FEET EIGHT INCHES, SLENDER BUILD, OLIVE COMPLEXION, BLACK HAIR, AND CLEAN SHAVEN. HE SPOKE FAST AND SPOKE FAIRLY GOOD ENGLISH BUT WITH AN ACCENT. HE ALSO INDICATED HE WAS ENGAGED TO A GIRL BELIEVED ALSO FROM THE MIDDLE EAST, POSSIBLY RESIDING IN WASHING, D. C., AND COMMENTED THAT HE HAD MADE ONE OR MORE TRIPS TO JORDAN OR ARABIAL DURING DEEDLE'S ACQUAINTANCE WITH HIM. HE WAS ALWAYS WELL DRESSED AND CLAIMED THAT HIS FATHER OWNED SOME SUPERMARKETS IN OHIO, PROBABLY AKRON.

DEEDLE STATED HE GAVE THE MAN A RIDE TO HIS DORMITORY ON TWO OCCASIONS, AND HE GOT OUT AT THE ST. LOUIS UNIVERSITY DORMITORY ON THE SOUTH SIDE OF THE STREET ONE BLOCK SOUTH OF LINDELL AND HALFWAY BETWEEN SPRING AND GRAND AVENUE AND CLAIMED TO BE A STUDENT AT ST. LOUIS UNIVERSITY BUT DID NOT MENTION WHAT COURSE HE WAS TAKING.

DEEDLE STATED KHALAF DID NOT DISCUSS POLITICS TO ANY DEGREE BUT OCCASIONALLY EXPRESSED A DISTASTE FOR NASSER BUT WAS GENERALLY COMPLIMENTARY TOWARD AMERICAN OFFICIALS AND

On 6/5/68, the tape of the radio program "Pinpoint" was reviewed. This program was broadcast recently, however, the date was not given in the tape. The host was STAN DALE of WLS News and Roosevelt University. Also on the program were FRANK SPENCER, Chicago ~~News~~ Chief of UPI and WLS News Director BOB BENSON. The guest was DICK GREGORY.

On this program GREGORY talked of his interest in the cause of the American Indians and of his forthcoming imprisonment in a Washington State jail for being a champion of the rights of American Indians.

GREGORY also discussed his campaign for President. He said that he would not run for Vice President on a ticket with either MC CARTHY or NIXON, because "that would be doing it just so they could be safe because if they won with me the Vice President they could be assured they would never be assassinated."

GREGORY thinks a conspiracy was involved in the murder of MARTIN LUTHER KING. He says the FBI Laboratory has said that a bullet taken from KING'S body came from a 30.06 rifle. GREGORY said a bullet as such would go through a tank and if a 30.06 bullet hit KING it would not have stayed in his body nor would it have left anything of his face. GREGORY said the FBI was more sophisticated with laboratory, "to make that kind of mistake unless it was more to it than that."

GREGORY said that KING was killed to create chaos in the black community which would enable some group which he did not identify to move in. Then GREGORY said "I feel that a big white person will be killed and not too long and blamed on a Negro or a Negro brought in to do it to create that other element in the white community. When I first really started getting suspicious it made me cancel my demonstration against the Democratic Convention here for a week before Easter, the three department stores fires you had here in Chicago."

GREGORY then goes on to say that news media were apparently blaming black militants for these fires and GREGORY thought black people were not responsible for the fires. He said 90-95% of shoplifters were black and black people would be watched too closely in the stores to start fires. He felt that this attempt to blame black people was part of a conspiracy.

He thinks good will and trust are needed between black and white people before their problems can be solved, otherwise, he said America will need the "biggest guns money can buy."

Secret Service and advised SA Ciochina that approximately two months ago, while he was attending an Accounting 102 Class at Loyola University, University College Division, 820 North Michigan Avenue, Chicago, his accounting instructor, Mr. John Porter, stated in the presence of the class which was held on a Saturday: "If Kennedy gets the presidential nomination, I would like to see him assassinated."

Mr. Haskell stated that Mr. Porter had made other derogatory remarks on other occasions directed toward the late Senator Robert F. Kennedy. He described Mr. Porter as being politically conservative. A description of John Porter was not obtained.

Mr. Haskell advised that he is residing at 6243 South Evans Avenue, Chicago, telephone number 684-7482, and that he is employed at Commonwealth Edison Company, 5059 West Polk Street, Chicago, telephone number 379-5050, extension 274.
