SECOND SOURCE, RELIABLE IN PAST, MADE AVAILABLE INFO INSTANT DATE CONCERNING TAPED APPEARANCE OF DICK GREGORY ON CHICAGO RADIO STATION, WLS PROGRAM "PINPOINT", ON JUNE THREE LAST. DURING PROGRAM GREGORY WAS ASKED FOR HIS OBSERVATIONS RELATIVE TO ASSASSINATION OF MARTIN LUTHER KING, JR., AND IN COMMENTING GREGORY STATED HE FELT KING WAS KILLED TO CREATE CHAOS IN BLACK COMMUNITY. GREGORY ALSO STATED HE FELT THAT A BIG WHITE PERSON WOULD BE KILLED IN NOT TOO LONG AND SUCH KILLING WOULD BE BLAMED ON A NEGRO OR A NEGRO WOULD BE BROUGHT IN TO DO THE KILLING TO CREATE SIMILAR ELEMENT IN WHITE COMMUNITY. GREGORY EXPRESSED OPINION KILLING OF KING WAS PART OF A CONSPIRACY, AS WAS ASSASSINATION OF FORMER PRESIDENT JOHN F. KENNEDY. SOURCE ADVISED GREGORY OFFERED NO SPECIFICS, BUT APPEARED TO BE STATING HIS OPINION CONCERNING ASSASSINATION OF KING.

AVAILABLE CHICAGO SOURCES (CRIMINAL, SECURITY, RACIAL) CONTACTED THIS DATE AND ADVISED POSSESS NO INFO TO INDICATE ATTEMPTED ASSASSINATION OF SENATOR KENNEDY WILL INITIATE ANY DEMONSTRATIONS OR DISTURBANCES IN CHICAGO AREA. SOURCES HAD NO INFO RELATIVE TO ANY GROUP MOBILIZING TO DEMONSTRATE AS RESULT

At 1:45 this afternoon an unknown male (wouldn't identify himself) advised me that about two weeks ago on the IRV KUPCINET show the guests were DICK GREGORY and CASSIOUS CLAY. He said while viewing this show GREGORY made the statement that some "big name man" (white man) would be assassinated, and stated this was to occur in the month of June. He said when GREGORY was saying this, ABC cut off the sound. This man suggested we call KUPCINET and run the tapes of the program. Evidentially this man feels there is some connection between this program and the attempted assassination and gave this information for what ever use we wanted.

Mr. SHERMAN stated that on Saturday, 6/1/68, he was having coffee in the Sherman House Coffee Shop located at Madison and Randolph Streets with a friend. He advised that a waitress, whom he knows only as LISA, came to the table and stated she had just heard that Senator ROBERT KENNEDY had just been shot in the head. Shortly thereafter, she returned to the table and stated she had been misinformed in this regard.

Enclosed for the Bureau are five copies of a LHM dated and captioned as above. One copy of the LHM has been disseminated locally to U. S. Secret Service, Chicago; Region I, 113th MI Group, Evanston, Illinois; and to the Chicago Police Department.

On the afternoon of 6/7/68 Special Agent ROBERT DICKERSON, U. S. Secret Service, Chicago, telephonically advised that he had located the subject, who admitted having gone to Larson's Restaurant to eat at about 5:00 p.m. on 6/6/68 but instead began drinking and continued until approximately 2:00 a.m., and he believed he had become pretty intoxicated. He could recall making none of the statements mentioned in the enclosed LHM. SA DICKERSON also advised that ELVIN HOLMEN is employed by Coatings Unlimited, 6307 North Pulaski, Chicago, and he stated that he has not, as yet, been able to contact HOLMEN for a verification of the information. DICKERSON added that Secret Service is continuing its investigation to fully develop the background information concerning GREENE.

In the absence of FBI jurisdiction, no further action is being taken in this matter by the Chicago Division.

On the morning of June 7, 1968, Mr. Elvin Holmen, 6668 Sioux Avenue, Chicago, Illinois, telephone number - SP 4-4155, telephonically advised the Chicago Office of the Federal Bureau of Investigation (FBI) that during the evening and early morning hours of June 6 and 7, 1968, while he was at Larson's Restaurant at Austin and Gunnison, Chicago, he met an individual who identified himself as Lou Greene. Greene furnished Holmen with a business card of the Theratron Company, 3235 South Franklin, Chicago, Illinois, telephone number - 427-2825. Greene wrote the telephone number 725-0865 on the back of this card and Holmen presumed that this was Greene's home telephone number, but Holmen was unable to furnish Greene's home address. Holmen stated that during conversation with Greene, Greene made remarks against the Government of the United States and stated that he was glad to see what had happened to Senator Robert Kennedy and that he would have done it himself. Greene also stated that if he could, he would do it to the President.

On June 7, 1968, the above information was furnished to Special Agent Joseph E. Noonan, Jr., United States Secret Service, Chicago, Illinois; to Richard R. Norusis, Special Agent, Region I, 113th Military Intelligence Group, Evanston, Illinois; and to Officer James Riley, Office of Deputy Superintendent, Chicago Police Department, by Special Agent Richard F. Homan.

On 6/24/68, GREGORY SMITH, 119-18 232nd Street, Cambria Heights, Queens, NY, was interviewed in the NYO of the FBI.

SMITH advised that he was in attendance at the lecture given by DICK GREGORY at St. Gregory's College, Shawnee, Oklahoma, in May, 1968. He was also in attendance at the informal discussion following the lecture. He heard GREGORY comment, in discussing the political styles of the various presidential candidates, that both Senator ROBERT F. KENNEDY and Mayor JOHN LINDSAY like to mingle among the crowds of people and that Senator KENNEDY would be shot before the election.

SMITH advises he attached no significance to the comment and does not believe GREGORY had any knowledge of events to come. He did not hear anyone question GREGORY regarding the comment and heard no additional references to that remark.

On 6/7/68, THOMAS MULLIGAN, JR., 1833 Channing Way, Berkeley, Calif., employed at Golden Gate Fields, Albany, Calif., as Head Usher, advised SA DAVID E. TODD that press reports indicated that SIRHAN SIRHAN had been employed at one time by the Rex Ellsworth-Misch Tenney Thoroughbred Breeding Enterprises in Southern California.

MULLIGAN stated that about two years ago, while he was working at Del Mar Race Track, he learned that MISCH TENNEY had been affiliated with some radical group, believed by him to be the Peace and Freedom Party of Phoenix, Arizona, and that TENNEY had attended a convention of this group at Chicago that year, and had also passed out literature of the organization around Del Mar.

He stated he was reporting this due to the possibility that TENNEY may have had some influence on SIRHAN's political views.

TENNEY is now a trainer of horses running at Hollywood Park.

A current copy of the National Insider, a smut sheet, located on an Omaha, Nebraska, newsstand, reflects that it is published weekly. The current issue, described as Volume 13, Number 1, dated June 30, 1968, reflects on its masthead that it is published by the National Insider, Inc., 2713 North Pulaski, Chicago, Illinois, 60639.

Copy of article described above is enclosed for Bureau since Mrs. HIKE was so insistent in her belief that the writer of the article had knowledge of a conspiracy to assassinate Senator KENNEDY that the possibility exist that she will communicate with the Bureau in the future. EVIDIO PEREIRA ACOSTA was interviewed at his place of employment, the Mutual Type Company, 3838 North Kedzie Avenue. He advised that he has been living in an apartment of EVIDIO HERNANDEZ, 5707 Ridge Avenue, Chicago, Illinois. He furnished the following information:

On May 21, 1968, a meeting was held at 3800 Amesbury, Hollywood, California. At this meeting a talk and slides were shown concerning life in Cuba which was slanted in favor of the current FIDEL CASTRO government. He attended this meeting along with a number of other anti-FIDEL CASTRO Cubans. During the meeting he spoke against the present Cuban government and a number of those present took exception to his remarks. An individual seated to his left and near the platform challenged him on several points he made including the fact that life in Cuba today is not as pleasant as the slides at this program would tend to portray. This individual, who challenged him, said that those Cubans who attempted to return to Cuba during the "Bay of Pigs" invasion were mere mercenaries and that the displaced Cubans in the United States were mostly a bunch of "bums".

He stated after viewing a photograph of SIRHAN BISHARA SIRHAN that he was 70 per cent sure that the individual referred to above, who challenged his statements at this meeting, was SIRHAN. He concluded by stating that he could not be certain of this but thought that others present at this meeting might have had a better view of this individual. He suggested that one FRANK GUITIERREZ, a Cuban known to other members of his group at this meeting, might be able to identify this individual. He added that he could not be sure but he thought that SIRHAN may have been with one or two other individuals at this meeting.

On instant date FARIED MASSOUH, 1606 East 50th Place, Apartment 12C, advised JOHN ANTOINE KHOURY was his next door neighbor in Beirut, Lebanon, from 1960 to 1962. He advised that they both lived with their families on Sodini Street. MASSOUH said he moved to the United States in 1962 and KHOURY subsequently moved to the United States about six months later between September and November of 1962.

He advised KHOURY's family were Egyptian. He stated KHOURY's father was troubled over his finances but he could not advise what the father's employment was. He said the mother seemed more stable and appeared to have a better means of income. As far as he knows KHOURY's family held no political offices. The only political aspiration he can remember KHOURY having was when he ran and lost student government presidency at Fulton Junior College in California.

MASSOUH related he last heard from KHOURY when KHOURY was in Chicago for about two months in 1964. He said he has not seen him since that time and has no knowledge of his present whereabouts.

MASSOUH stated KHOURY's family consisted of three children, one girl sixteen years old (name unknown) one brother 22 years old JACK KHOURY, and one brother 18 years old, JOSEPH KHOURY.

He stated his only knowledge of KHOURY's political views concerning the KENNEDY family centered around President JOHN F. KENNEDY and he cannot remember any exact views KHOURY held regarding ROBERT KENNEDY. He said KHOURY had a very high regard for President JOHN F. KENNEDY because he liked the manner in which he dressed, spoke and conducted himself in general. He stated that KHOURY dressed impeccably and was very impressed by well dressed, well bred people. He said he cannot remember KHOURY mentioning anything derogatory regarding the KENNEDY family.

He said he remembers KHOURY making remarks regarding friends and relatives he had in high places. MASSOUH said he considered it to be a joke but could never figure out, due to the family's lack of having any large amounts of money, how KHOURY could own a new Chrysler, have many new suits, and always have the ability to go to the best places.

MASSOUH's only knowledge of KHOURY's associates regarded the following individuals in order of importance:

1. JACK KHOURY, brother, if he is presently in the United States.
2. FOUAD AYOUB, student, living in San Francisco presently.
3. KIM NAFFA, instructor, Fullerton, California, State College.

He could furnish no further information regarding KHOURY but stated he was willing to cooperate with the Federal Bureau of Investigation (FBI) at any time in the future.
