MAY 22, 1975 WHO STATED HE WAS GOING TO KILL KENNEDY AND ALL THE KENNEDY'S. THIS WAS THE FOURTH CALL ROBERT KENNEDY HAS RECEIVED BUT THE ONLY ONE RECEIVED MAY 22, 1975 FROM SERGEANT.

DETECTIVE GARY BITTENBENDER WASHINGTON METROPOLITAN POLICE DEPARTMENT AND DETECTIVE ROLAND HELTON, SPECIAL INVESTIGATIONS U.S. CAPITOL POLICE WERE ADVISED AT 5:47 P.M. AND 5:52 P.M. RESPECTIVELY OF THE ABOVE ON MAY 22, 1975.

ADMINISTRATIVE

SA GERALD A. JAMES RECEIVED AND DISSEMINATED THE ABOVE INFORMATION TO MPD AND CAPITOL POLICE.

SA BURNHAM ADVISED THAT SECRET SERVICE WAS FURNISHING THE ABOVE INFORMATION AS THEY INTERPRETED THE THREAT TO PERTAIN TO SENATOR EDWARD KENNEDY AND JOHN KENNEDY JR. IN VIEW OF THEIR PROTECTIVE RESPONSIBILITY OF JOHN KENNEDY JR. SECRET SERVICE WILL INVESTIGATE THE THREAT. SECRET SERVICE LIAISON IS ADVISING SENATOR KENNEDY'S BOSTON OFFICE AND THE MC LEAN VIRGINIA POLICE DEPARTMENT WHICH COVERS THE SENATOR'S RESIDENCE.

DETECTIVE HELTON ADVISED THAT HE WOULD ADVISE SENATOR KENNEDY'S WASHINGTON OFFICE OF THE THREAT.

LEADS: BOSTON WILL NOTIFY SENATOR EDWARD KENNEDY'S OFFICE OF THE THREAT.

NEW ORLEANS AND PHILADELPHIA MAINTAIN CONTACT WITH LOCAL SECRET SERVICE TO DETERMINE IF SUBJECT IF IDENTIFIED AND IF THE THREAT WAS DIRECTED AGAINST SENATOR KENNEDY.

On 6/4/75, SA RICHARD WAGNER, U. S. Secret Service, Philadelphia, Pa., advised that ROBERT FRANCIS KENNEDY, JR., telephone CH7-3010 (not listed as CA7-3010) resides at 1101 Sydney Street, Philadelphia, Pa., and has a telephone number which is listed. SA WAGNER advised that KENNEDY only received the one telephone call from "Mr. SERGEANT", but stated he receives four or five threatening telephone calls each week, threatening "the KENNEDYS." WAGNER further advised that ROBERT FRANCIS KENNEDY, JR., has a 100% mental disability from the Veterans Administration and has been in and out of several mental institutions.

Copies of this communication are being sent to WFO who received original complaint and for Boston for information because of investigative interest.

Information in referenced teletype furnished to Secret Service, New Orleans, and contact has been maintained with New Orleans Secret Service.

On May 30, 1975, Agent JAY BLY, U. S. Secret Service, New Orleans, advised that their Philadelphia Office contacted ROBERT FRANCIS KENNEDY of Philadelphia and he is 100% mentally disabled and his father advised that he frequently makes these complaints and there is no credibility to this story. He advised that their investigation is, therefore, being closed.

In view of the above, New Orleans is conducting no further investigation.
