Field Office Files

- RIDS LAS requests Field Office files via email using the attached form which now includes a security statement
- Field Office employee packs and ships files to RIDS/Winchester with the attached form and security statement
- Files are shipped via FedEx to Winchester/RIDS at 170 Marcel Drive, Winchester, VA 22602 with the appropriate markings and packaging. (The Field Office notifies RIDS LAS of shipment and RIDS LAS notifies the Security Unit of incoming shipment.)
- Security Unit employees check the incoming box/package and review the attached form with the security statement and releases the box/package to RIDS LAS
- RIDS LAS reviews the files to ensure they do not contain any classified material above the Secret level, coded SCI or otherwise considered sensitive
- RIDS LAS places the appropriate scanning form on each file/enclosure and delivers them to the DocLab. They are setting up a table for us.
- After DocLab scans the material, creates single page TIF and/or CDs, they will return the files to the RIDS LAS with CDs and/or uploads the file to the T-Drive. RIDS will also have access to the DocLab Spreadsheet on the Sdrive, which will indicate that a job is completed.
- RIDS LAS packages files with the appropriate markings, (advises the Security Unit of out-going shipment) and FedEx's the files back to the Field Office


