SUSPECT SIRHAN WAS INTERROGATED BY THE UNDERSIGNED, INV. DUVALL AND MR. ROBINSON. SIRHAN STATED THAT HE WAS EN ROUTE TO PASADENA CITY COLLEGE TO CON-TACT A FRIEND TO WHOM HE OWED \$6, TO REPAY THE MONEY. THAT HE WAS COUNTING THE MONEY AS HE WALKED ALONG THE STREET AND A DIME HAD ROLLED OUT INTO THE STREET UNDER THE BENNETT VEHICLE. SIRHAN READILY ADMITTED THAT HE KNEW WHO THE VEHICLE BELONGED TO. HE STATED THAT THIS WAS THE REASON HE WAS UNDER THE BENNETT VEHICLE, AND HE DENIED THAT HE HAD SEVERED THE LINE. EXAMINATION OF THE LEFT REAR BRAKE LINE BY THE UNDERSIGNED AND ROBINSON DISCLOSED THAT THE LINE WAS SEVERED ALMOST IN TWO APPROXIMATELY SIX INCHES FROM THE T WHERE THE LEFT BRAKE LINE LEADS TO THE LEFT REAR WHEEL. THE UNDERSIGNED DEPRESSED THE PEDAL ON THE 1955 DESOTO WHILE ROBINSON OBSERVED THE BRAKE LINE, AND ROBINSON STATED THAT THE BRAKE FLUID SPURTED FORTH: FROM THE SEVERED PORTION OF THE LINE. THIS LINE WAS PHOTOGRAPHED BY INV. CORRIGAN, REMOVED, TAGGED AS EVIDENCE AND LEFT IN THE LAB FOR FURTHER EXAMINATION.

THE UNDERSIGNED AND INV. DUVALL EXAMINED THE ENGINE OF THE 1955 DESOTO AND FOUND THAT THERE WAS A NEW UPPER GAS LINE LEADING FROM THE FUEL PUMP TO THE CARBURETOR, WHICH HAD APPARENTLY BEEN RECENTLY INSTALLED. WE ALSO NOTED WHAT APPEARED TO BE GUNPOWDER FRAGMENTS LYING ON THE MANIFOLD, WATER PUMP ASSEMBLY AND SPARK PLUGS ON THE RIGHT BANK OF THE ENGINE. THE UNDERSIGNED TOOK SOME OF WHAT APPEARED TO BE GUNPOWDER AND IGNITED SAME AND FOUND THAT SAME DID IGNITE AS GUNPOWDER. A SEARCH WAS MADE OF THE SUSPECT'S VEHICLE. THE UNDERSIGNED FOUND A BOX OF 12-GAUGE SHOTGUN SHELLS UNDER THE RIGHT PASSENGER SEAT CUSHION IN THE FRONT. THESE WERE GIVEN TO INV. WHEN QUESTIONED BY INV. DUVALL, SUSPECT SIRHAN STATED THAT HE HAD TAKEN THE HACK SAW WITH HIM AS HE DID NOT WANT SAME STOLEN FROM HIS CAR. IT IS TO BE NOTED THAT THE SUSPECT'S VEHICLE WAS NOT LOCKED, THE KEYS WERE IN THE IGNITION, THERE WAS A PACKAGE ON THE BACK SEAT CONTAINING TWO NEW BOXES OF CHRISTMAS CARDS. SIRHAN ADVISED INV. DUVALL THAT HE HAD PURCHASED THE HACK SAW FOR THE PURPOSE OF CUTTING FROZEN FOOD. HE FURTHER STATED TO THE UNDERSIGNED AND INV. DUVALL LATER THAT HE HAD USED THE HACK SAW IN CUTTING MISCELLANEOUS PARTS FOR HIS AUTOMOBILE. WHEN ASKED TO SPECIFY WHAT PARTS OR PORTION HE HAD CUT, SIRHAN EXEXMORXMERKX STATED THAT HE DID NOT KNOW.

SIRHAN WAS BROUGHT TO THE STATION AND BOOKED AS ABOVE.

Mr. Bennett came into the station on this date and reported that on 12-6-63 and 12-10-63 someone attempted to set his car on fire.

The car in question is a 1955 DeSoto 4dr. Sedan license number and is registered to the above Mr. Bennett. On December 6th. Miss Linda m. Bennett drove the car to Pasadena and parked it at the south east corner of Rose Villa and Hill Ave. This was approximately 8:00 AM. Miss Bennett then went on to class at PCC. She returned to her car at approximately 10:30 AM and drove same away. She had not gone too far when she smelled gas, and pulled into a service station at 2390 Huntington Dr. San Marino. At this time the station attendant found the fuel line broken, and replaced same. It was felt at this time the fuel line had just worn out. Miss Bennett returned to Pasadena on December 10th, and again parked the car at the same location, only on this date she did not arrive until approximately 11:00 AM. She then went onto class and when she returned and started out in the car she again smelled gas. She went to the same service station and this time the station atcendant replaced the gas line, and at this time he found where the gas line had been cut. When Miss Bennett returned to her home Mr. Bennett examined both gas lines and found that both of them had been cut.

The gas lines in question appeared to have been cut with a hack saw, approximately 4" from the fuel pump.

Mr. Bennett advised this officer that his older daughter Miss Mary P. Bennett used to go with the suspect Mr. Serhan, and after some time they broke up. Mr. Bennett stated that since that timeSMrs.Serhan, started to call and write letters to Miss Bennett. He did not give up, until Mr. Bennett went to the DA and turned over a letter to him from M_{P} . Serhan. M_{P} . Bennett stated that after that the letters stopped comming, but the incident with the car started. Mr. Bennett stated Mr. Serhan knows the car and feels that he is tring to get back at his daughter for breaking up with him.

Investigator Dague took photos of the car, and placed the cut gas lines in the property room. See his report for further information.

DETAILS OF CASE :

On 6-9-66 Agents received information that the above subject was dealing in can quanities of Marihuana in the Pasadena area.

Pasadena Police Department advised that they had two informents who could introduce an Agent to the suspect for the purchase of Marihuana, and further that on 6-9-66 the two in-formants had given the suspect \$10. to show good faith.

On 6-10-66 under the surveillance of Agent Thompson and Sgt. Kilgore and Detective Dosmie of Pasadena Police Department, Agent Miller and two informants met suspect Munir Bisahara Salamsh SIRHAN, (introduced as Joe MUNIR) in an alley north of Colorado to complete a purchase of 2 "cans" of Marihuana.

After introduction of Agent Miller, the following conversation ensued:

INFORMANT: "I couldn't raise enough for the five cans, all I could get was \$5. more. Bill wants a can too."

AGENT: "Yeah, but can't you do better on the price?"

SIRHAN: "Fifteen is the best I can do a can."

AGENT: "Now about on quantity, can you do better?"

SIRHAN: "Fifteen's all I can do."

AGENT: "How about on a ki?"

SIRHAN: "Seed weight or leaf weight?"

AGENT: "Leaf weight."

SIRHAN: "I'll see what I can do. (To informant) Give me the 20 for the two cans."

Agent Miller handed SIRHAN \$20. pre-recorded State funds and at this time Joe directed Agent and informants to wait at the corner of Lake and Walnut.

Agent and informants proceeded to this location and Agent Miller contacted covering Officers and advised them of what had transpired to this time.

Agent Hiller then roturned to the informant's vehicle and at this time observed SIRHAN and another individual subsequently identified as Carlos Arturo GONZALES DEL VALLE walking north on Lake. The two suspects came up to the vehicle and at this time Agent and one of the informants were directed to get out of the vehicle by SIRHAN who said, "Let's take a ride around the block." At this time suspect was placed under arrest for violation of 11531 and 11530 H&S Code, possession and sale of Marihuana; suspect was immediately advised of his constitutional rights, to wit: the right to remain silent, the right to services of an attorney, and that anything he said could be used against him in subsequent legal proceedings.

DETAILS OF CASE:

On 6-9-66 Agents received information that the above subject was dealing in can quanities of Marihuana in the Pasadena area.

Pasadena Police Department advised that they had two informants who could introduce an Agent to the suspect for the purchase of Marihuana, and further that on 6-9-66 the two in-formants had given the suspect \$10. to show good faith.

On 6-10-66 under the surveillance of Agent Thompson and Sgt. Kilgore and Datective Downie of Pasadena Police Department, Agent Miller and two informants met suspect Munir Bisahara Salameh SIRHAN, (introduced as Joe MUNIR) in an alley north of Colorado to complete a purchase of 2 "cans" of Marihuana.

After introduction of Agent Miller, the following conversation ensued:

- INFORMANT: "I couldn't raise enough for the five cans, all I could get was \$5. more. Bill wants a can too."
- AGENT: "Yeah, but can't you do better on the price?"
- SIRHAN: "Fifteen is the best I can do a can."
- AGENT: "How about on quantity, can you do better?"
- SIRHAN: "Fifteen's all I can do."
- AGENT: "How about on a ki?"
- SIRHAN: "Seed weight or leaf weight?"
- AGENT: "Leaf weight."
- SIRHAN: "I'll see what I can do. (To informant) Give me the 20 for the two cans."

Agent Miller handed SIRHAN \$20. pre-recorded State funds and at this time SIRHAN directed Agent and informants to wait at the corner of Lake and Walnut.

Agent and informants proceeded to this location and Agent Miller contacted covoring Officers and advised them of what had transpired to this time.

Agent Miller then returned to the informant's vehicle and at this time observed SIRHAN and another individual subsequently identified as Carlos Arturo GONZALES DEL VALLE walking north on Lake. The two suspects came up to the vehicle and at this time Agent and one of the informants were directed to get out of the vehicle by SIRHAN who said, "Let's take a ride around the block."

SIRHAN, GONZALES DEL VALLE, and one of the informants then left the area. A short time later SIRHAN and the informant returned and at this time Agent and informant entered the vehicle where the following conversation ensued:

SIRHAN: "You still want the ki?"

AGENT: "Sure, when can you get it?"

SIRHAN: "When do you want 12?"

AGENT: "Whenever you can get it; how about price?"

SIRHAN: "Neme a figure."

AGENT: "Is it good weed, name a price."

SIRHAN: "It's good weed, what can you pay for it?"

AGENT: "How about a bill."

SIRHAN: "Oh man, you're kidding."

At this time the informants vehicle was pulled over by covering Officers and the informant driving advised Agent Miller that the suspect SIEHAN had the two cans in his pocket. That he had received the two cans from suspect CONZALES DEL VALLE after CONZALES DEL VALLE had returned from a residence and that CONZALES DEL VALLE was SIRHAN'S connection. He further advised that GONZALES DEL VALLE had been dropped off at the pool hall on Colorado.

Agent Miller and Sgt. Kilgore and Detective Downie went to the pool hall on Colorado and placed subject GONZALES DEL VALLE under arrest for 11531 H&S, sale of Marihuana and transported him to Pasadena Police Department.

At Pasadena Police Department suspect GONZALES DEL VALLE was advised of his constitutional rights by Sgt. Kilgore, to wit: right to remain silent, right to an attorney, anything he said could be used against him.

While inventories were being taken, \$10. recorded State funds were recovered from subject.

STATEMENT OF DEFENDANT:

Refused to make any statement.
