

PRESENT OFFERSE

DEFENDANT WAS TAKEN INTO CUSTODY ABOUT 7:30 P. W. ON THE RIGHT OF JUNE 10, 1966 BY STATE NARCOTIC OFFICERS AND THE PASADENA POLICE DEPARTMENT. HE MAS BOOKED FOR INVESTIGATION OF 11530 AND 11531 HEALTH AND SAFETY CODE, BUT APPARENTLY POSTED BAIL AFTER THREE DAYS IN CUSTODY. HE WAS CHARGED IN THE INFORMATION AS SET FORTH ON PAGE ONE OF THIS REPORT. COUNT I ALLEGES THAT ON OR ABOUT JUNE 10TH THE DEFENDANT VIOLATED SECTION 11530 HEALTH AND SAFETY CODE BY BEING IN POSSESSION OF MARIJUANA. THE JURY WAS WALVED AND MATTER SUBMITTED ON THE PRELIMINARY TRANSCRIPT, AND ON OCTOBER 13, 1966 IN NORTHEAST B SUPERIOR COURT BEFORE JUDGE WILLIAM FOX, HE WAS FOUND GUILTY AS CHARGED ON BOTH COUNTS, MATTER BEING CONTINUED TO 2:00 P. M. ON NOVEMBER 17, 1966 FOR PROBATION AND SENTENCE HEARING, DEFENDANT PERMITTED TO REMAIN ON BAIL.

INASHUCH AS THERE HAS BEEN A TRAIL IN THIS MATTER,

THE DEFENDANT WAS THEN MANDED \$20 IN MARKED FUNDS FOR THE TWO CANS OF MARIJUANA ( A TEN DOLLAR BILL AND THO FIVE DOLLAR BILLS), AND THE DEFENDANT AT THIS POINT STATED THAT HE BOULD SEE HIS CONNECTION AND DIRECTED WILLER AND THE OTHERS TO LAKE AND WALNUT TO WAIT FOR HIM. THE GROUP DID THEN GO TO LAKE AND WALNUT DURING THE DEFENDANT'S ABSENCE AND MILLER CONTACTED COVERING OFFICERS ADVISING THEM OF WHAT HAD HAPPENED. AFTER MILLER RETURNED TO THE CAR THE DEFENDANT AND ANOTHER PERSON, CARLOS ARTURO GONZALES-DEL VALLE APPROACHED THE CAR. STRHAN AND ANOTHER MAN THEN LEFT IN THE CAR. SOON RETURNING AND THE CONCERSATION REGARDING THE PURCHASE OF THE KILO OF MARIJUAMA WAS RESUMED. (A KILO IS 2.2 POUNDS) THE DEFENDANT THEN ASKED IF MILLER WERE STILL INTERESTED IN PURCHASING A KILO, AND MILLER STATED THAT HE WAS. OTHER OFFICERS THEN ARRIVED AND THE DEFENDANT HAS SEARCHED, AT WHICH TIME HE HAS FOUND TO BE IN POSSESSION OF A QUANTITY OF LOOSE MARIJUANA AND WAS TAKEN INTO CUSTODY. HE WAS ALSO FOUND TO BE IN POSSESSION OF SOME OF THE REGISTERED CURRENCY. DEFENDANT'S STATEMENT:

THE DEFENDANT'S WRITTEN STATEMENT HAS NOT BEEN

HE WAY OR MAY NOT BE DEPORTED. THIS IS UP TO THE HEARING OFFICER.
BE BOULD GO AHEAD AND PROCESS THE CASE WHETHER HE IS COMMITTED TO
STATE PRISON OR NOT."

A LENGTHY TELEPHONE CONVERSATION WAS HAD WITH THE DEFENDANT'S WOTHER, WHO IS QUITE PROTECTIVE. SHE DENIES THAT HE IS INVOLVED IN ANYTHING ILLEGAL WHATCOEVER, AND REFUTES THE COURT CONVICTION. SHE STATES IN PART, "THIS RAS ALL FOOLISHNESS ON HIS PART. IT HIGHT HAVE BEEN ASSOCIATIONS HE HAD. THE POLICE ARE LIARS. HE DIDN'T MEAN IT."
