Further Details (Describe property stolen or lost, loss (make, model, serial number, and value of each article. Tell how crime was committed):
On arrival of the police, Officer Salzman was observed resisting the efforts of Dr. Otto to treat him. Salzman had a large laceration on his forehead. Dr. Otto stated that the subject could not walk. He tried to take the suspect into medical help, but was observed that he was in pain and unable to care for his wounds for the sake of others. The suspect was placed under arrest and transported to the Emergency Center. At the Emergency Center the suspect was treated on the head wound. Dr. Otto stated that the suspect would be all right to walk in the afternoon.

While at the hospital, suspect Koch approached this officer and related the following. He stated that suspect Salzman called him a name that he could not understand. He further stated that he walked up to him suspect Salzman, removed his shoe and tried to strike him with it. Suspect Koch defended himself by striking suspect Salzman in the face with his fist. Suspect Salzman fell to the ground, hitting his head on the corner of the building at 505 W. Holly Street.

When suspect Salzman was asked about the incident in jail, He stated that the undersigned struck him in the head causing the wound. He made no further statement other than he was going to sue the undersigned.

Suspect Shirkman fell to the ground, striking his head on the corner of the building at 500 W. Holly Street.

When suspect Shirkman was asked about the incident in jail, he stated that the undersigned struck him in the head causing the wound. He made no further statement other than he was going to see the undersigned.

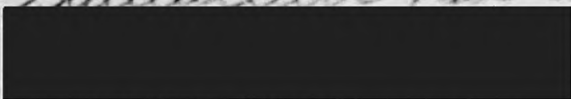

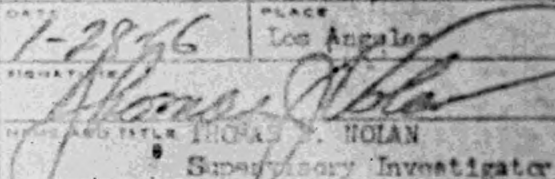

SYNOPSIS

Investigation developed that SUBJECT had had an arrest in addition to what he admitted when filing Petition for Naturalization, and that he has resided at an address not revealed when filing Petition, and has since change residence and employment without reporting.

Neighborhood investigation reveals SUBJECT owes \$32 to former landlady.

DETAILS

With respect to 1617 No. Lake Avenue, Pasadena, California, where SUBJECT claimed, on Form N-400, to have resided from June 1960 to January 1962, the present owner, Rosco Rosco stated on January 11, 1966 that SUBJECT's name and photo were totally unfamiliar to him. Rosco bought this property, which has several rental units, in December 1962; he claimed he did not know the address of the former owner, one Mike Wilson.

The only nearby resident who was found to have any recollection of SUBJECT as a former neighbor was one Jack Thomson, 1659 No. Lake Avenue, who stated on January 11, 1966 that SUBJECT had resided in one of the apartments at 1617 approximately during the period claimed. He recalled that SUBJECT was one of several members of the same family, that they were "a very happy family", that they were good neighbors and were not known to have been involved in any trouble. On the basis of his knowledge, Mr. Thomson would recommend SUBJECT for naturalization.

As shown by Pasadena Police Department Arrest Report contained in the file, SUBJECT gave 1617 No. Lake Avenue as his address when arrested October 2, 1962 for driving under the influence of intoxicating beverage. Four weeks later, when arrested on an intoxication charge, SUBJECT's address was given as 1711 Corson Street, Pasadena.

January 11, 1966 it was observed that 1711 Corson Street is a non-existent address, all houses in that block having been torn down or awaiting removal in preparation for construction of a freeway. According to the 1962 Pasadena City Directory, it was in 1962 the residence of Harry and Fessie Izmirlian. Voters Registration records and telephone directories give no later address for Izmirlian.

With respect to 128 No. Sierra Bonita, Pasadena, where SUBJECT, on Form N-400, claimed to have resided from January 1962 to January 1965, repeated calls at this address and nearby residences have failed to contact the landlord or to determine place of employment. However, on January 26, 1966 next-door neighbor, Mrs. Patricia Fine (resident alien), 132 No. Sierra Bonita, identified SUBJECT's photo as that of a roomer at 128, who moved out about a year ago and who had lived there previously about three years (approximately as claimed by SUBJECT). She knew of no trouble, and had no reason to doubt character.

With respect to 308 1/2 Burton Court, Pasadena, where SUBJECT claimed to have resided since January 1966, the landlady, Mrs. William Muehlberger, stated on January 12, 1966 that SUBJECT had resided there from January 1965 to November 21, 1965. He had got behind in the rent one month (\$32 rent), and disputes the landlady's claim, so she hasn't made an issue of it, or taken him to court. Since SUBJECT

moved away, Mrs. Muehlberger has been visited by at least one bill collector, who was looking for SUBJECT. Except for SUBJECT's slow pay of his rent and eventual default, she regarded him as an ideal tenant: quiet, orderly, never involved in trouble.

When SUBJECT moved away from 100 Burton Court, according to Mrs. Muehlberger, he left no forwarding address, but indicated he was going to be managing an apartment building.

On January 11, 1966, Ella M. Giles, Apartment #8, 1020 No. Lake Avenue, Pasadena, identified SUBJECT's photo as relating to a man who has lived at her apartment complex about six weeks. His address now is 1020 No. Lake. He is a quiet tenant who has given no trouble or cause to complain; otherwise, nothing is known about his activities or employment.

SUBJECT claims to be self-employed as a painter. His last employer was the B. & B. Enameling Company, Inc., 1830 Locust, Pasadena, where the owner, Mr. Jay Bogert, on January 10, 1966 produced records showing SUBJECT was hired October 27, 1962 and quit in May 1964. SUBJECT gave his address at time of hiring as 1711 Corson Street, Pasadena. He was a good worker who was not known to be involved in trouble of any kind. Otherwise, nothing is known about his personal affairs. When he quit, he indicated he was going back to Pennsylvania, or some place "back East".

On Form N-400, SUBJECT gave his next previous employer as "Instrument Enameling". This was determined to be a firm previously operated by one Gordon H. Ritchey at 1170 No. Fair Oaks, Pasadena. According to Mr. Jay Bogert (see next paragraph above), Mr. Ritchey quit business and left town. Several people have been looking for him without success.

At the Miller Dial and Name Plate Company, 1400 No. Temple City Blvd., El Monte, on January 10, 1966, Payroll Clerk Mrs. Camarella Miller, produced records showing SUBJECT was employed there between August 1, 1961 and March 16, 1962, when he quit because he couldn't work with chemicals. It was Mrs. Miller's recollection that SUBJECT developed an allergy to the particular materials used at this establishment. He was a good employee, with no derogatory characteristics. Social Security No. [REDACTED]

File also contains Record Searcher Samuel Klein's copy of Los Angeles Police Department arrest report dated January 23, 1962, when SUBJECT was arrested for drunk driving. According to FBI Identification Division records, he was fined \$150 and "8 plus 1" days in the County Jail.

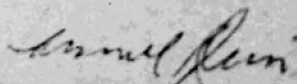

5. Coin Test—Pick up coins from floor. (If desired have suspect place coins on table and arrange in order, with largest sized coins on right. Identify heads or tails. Observe ability.)
6. Speech—Repeat the following test phrases: ELECTRICITY, METHUEN EPISCOPAL, AROUND THE RUGGED ROCK THE RAGGED RASCAL, RAN.
7. Handwriting—Copy a sentence, or several words such as the test phrases in No. 6 above), or sign name, so that handwriting can be compared. Space at top of this sheet may be used for this purpose.
