1. (FOLU) KIDNAPPING OF BG JAMES DOZIER, AS REPORTED BY GERALDINE WILSON, ANDRY TARASEWICH, AND EARBARA KURIK PATTEN, KENT, WASHINGTON, PHOME (206) 631-6806 (OFFICE), 631-8918 (HOME), PARAPSYCHOLOGISTIC REPORT, SAB, 2024 COZ JAN 82.

2. (U) SECOND REPORT.

3. (A) (FOUD) UN 21 JAN 82, FLMID WAS RE-CONTACTED BY WILSON, WHO HAD FURTHER VISIONS CONCERNING "THE PLACE OF THE SHEPHERDS" THAT SHE DESCRIBED IN THE INITIAL REPORT. IN HER PSYCHIC TRANCE, WILSON LUCKED INTO ONE OF THE SHACKS. THERE WAS A BEAUTIFUL GIRL SINGING TO A SHALL BABY. SHE PLACED THE BABY IN A CRIB AND WENT UP THREE STEPS INTO ANOTHER ROOM. IN THE ROOM THERE WAS AN OLD MAN-NOT BG DOZIER-LYING IN A BED. THE GIRL AND THE CLD MAN ARGUED IN ITALIAN; WILSON FELT HE WAS THE GIRL'S GRANDFATHER. HE KEPT SHAKING HIS HEAD. "NO." AHE KEPT SAYING, "YES." IN THE MIDST OF THEIR ARGUMENT, A ROUGH LUCKING YOUNG MAN WITH DARK HAIR WALKED IN. HE WAS DRESSED IN RAGS AND TATTERED CLOTHING. THE GIRL AND THE OLD MAN STOPPED TALKING, AND WILSON FELT THAT THEY WERE AFRAID OF THE YOUNG MAN. SHE ALSO FELT

STRURGLY THAT THE YOUNG MAN HAD SCHETHING TO DO WITH BG DOZIER. AND THAT THE GENERAL WAS SUMEWHERE CLOSE. WILSON SAW THE SHEPHERDS CO-OPERATING WITH THE CAPTORS, AND FELT THAT THE RED BRIGADE HAD HIDDEN WITH THE SHEPHEROS BEFORE. SHE FELT STRONGLY THAT THE SHEPHERDS HAD HIDDEN GROUPS FROM THE LAW, AND SHE WAS CERTAIN THAT THIS TIME THEY ARE HIDING BG DOZIER'S CAPTORS. THE SHEPHERDS TRUST NO ONE: THEY FOLLOW ONLY THEIR OWN LAWS. THEYARE ALSO FEARFUL OF THE KIDNAPPERS. SHE FELT THAT THERE WAS A CASTE SYSTEM WITHIN ITALY, AND THAT THESE SHEPHERDS WERE ALMOST AN ALIEN NATION. ABOUT THE "PLACE OF THE SHEPHERDS," WILSON TRIED TO LOOK AT THE MAN ON THE MOUNTAIN DURING A PSYCHIC TRANCE. HE WAS DRESSED AS A SHEPHERD, BUT ON THE MOUNTAIN HE CHULD HET BE TENDING HIS SHEEP, SU SHE FELT STRONGLY THAT HE WAS A LICKCUT FUR THE CAPTORS. WILSON FELT THAT THE "PLACE OF THE SHEP-HEXDS," AND BU DOZIER WERE DEFINITELY CONNECTED. C. (FOUR) ON 21 JAN 1982, BARBARA KUBIK PATTEN TELEPHONED THE FLMID AND STATED THAT SHE WISHED TO ASSIST FIMID AND ANY OTHER GOVERNMENT AGENCY IN LOCATING BG DOZIER. SHE ENUMERATED OTHER LAW ENFORCEMENT ASENCIES THAT SHE HAD WORKED WITH; HER CONNECTION WITH OTHER AGENCIES HAS NOT YET BEEN VERIFIED. PATTEN STATED THAT IN SIX OCCASIONS SHE HAD BEEN ABLE TO SUCCESSFULLY LOCATE MISSING PEOPLE. WHEN SHE PASSES HER FINGERTIPS OVER A MAP. IT FEELS LIKE THERE IS AN ELECTRIC CURRENT WHEN SHE GETS TO A POINT WHERE THE MISSING PERSON IS. THE CURPENT INCREASES DRAMATICALLY. PATTENT WENT TO THE CITY LIBRARY, KENT, AND WENT OVER NUMERCUS MAPS OF ITALY, INCLUDING THE ONE PROVID-EU BY TARASEWICH. PATTEN FELT NO PARTICULARLY STRONG VIBRATIONS FROM THAT MAP. PATTEM STATED THAT SHE HAD NO FIRST HAND KNOWLEDGE OF THE DIZIER KIDNAPPING UNTIL SHE DISCUSSED IT WITH WILSON AND TARASEWICH CN 10 JAN 82. AT THAT TIME SHE HAD BEEN HAVING VISIONS OF A STEAMER TRUNK AND A SMALL BLUE CAR. ON 21 JAN 82, WHILE READING A COPY OF A NEWSMAGAZINE. SHE REALIZED THAT IT WAS OBSCLETE INFORMATION. AT THE TIME, SHE DID NOT KNOW THE SIGNIFICANCE OF THOSE VISIONS. PATTER'S FURTHER VISIONS SINCE 10 JAN 82, CONCERNING BG DOZIER, HAVE BEEN OF CLANGING METAL, POSSIBLY AS IT RELATES TO A METAL FACTORY OR FOUNDRY. IN HER VISIONS SHE SAW A HALLWAY WITH LOTS OF CEMENT BEHIND METAL SHE FEELS STRONGLY THAT SARS. SHE CONTINUED TO HEAR CLANGING METAL. COMMUNAL WAY OF LIVING, THEY WERE IN EMPATHY WITH THE COMMUNISTS (WHICH WILSON CONSTRUES AS THE RED BRIGADE). THE SHEPHERDS THINK THAT THE COMMUNISTS WILL CHANGE THEIR STATION IN LIFE. WILSON FUR-THEK THINKS THAT THE ITALIAN POLICE ARE AFRAID OF THE HERDSMEN. FEELS VERY STRONGLY THAT THE POLICE DO NOT WANT TO GO INTO THE SHEP-HERDS! TO SEND BU DOZIER OUT OF ITALY TO RUSSIA OR LEBANON, BUT REALIZED IT WOULD BE TOO DANGEROUS. SHE SEES THE PED BRIGACE MEMBERS AS ANGRY AND IMPATIENT, FEELING THAT THE WHOLE WORLD IS AGAINST THEM. WILSON SEES A LOT OF BLOOD-SHED, AND FEELS THAT THE FAMILIES OF US SERVICE—MEMBERS IN ITALY SHOULD RETURN TO THE US. SHE IS CERTAIN THAT THE ITALIAN POLICE WILL NOT SEARCH IN THE "PLACE OF THE SHEPHERDS." SHE IS ALSO CERTAIN THAT THE "PLACE OF THE SHEPHERDS" HAS NO FORMAL NAME, ALTHOUGH IT IS WHERE THE SHEPHERDS AND THE KIDNAPPERS ARE CURRENTLY LOCATED. SHE IS SURE THAT US SOLDIERS AND INVESTIGATORS WILL BE THE ONE WHO LOCATE BG DOZIER AND THE KIDNAPPERS. SHE IS ADAMANT ABOUT THE US NOT ABANDONING THE SEARCH FOR THE KIDNAPPED GENERAL.

7. (FOLG) IN THE FIRST CONVERSATION WITH PATTEN, SHE INDICATED THAT, "SHE WAS NOT INTERESTED IN THE \$2 MILLION." THIS WAS THE FIRST INDICATION THAT ANY OF THE SOURCES HAD A FINANCIAL STAKE IN THE INFORMATION THAT THEY WERE PROVIDING. PATTEN FURTHER STATED THAT SHE WOULD ONLY BE INTERESTED IN EXPENSES AND PROTECTION WERE WE TO REQUIRE HER TO GO TO ITALY TO ASSIST IN LOCATING BG DOZIER. SHE

STATED THAT SHE HAS ONLY BEEN ACQUAINTED WITH WILSON AND TARASEWICH FOR THREE MONTHS. ALL SHE KNOWS IS THAT THEY APPEAR TO BE COMPETENT AT PSYCHIC PHENOMENON, AND THAT THEY ARE IN FINANCIAL DIFFICULTY. WILSON AND TARASEWICH EXPRESSED TO PATTEN THEIR INTEREST IN THE \$2 MILLION (\$1.8 MILLION) REWARD BEING OFFERED FOR INFORMATION LEADING TO THE SAFE RELEASE OF BG DCZIER. PATTEN STATED THAT SHE WAS NOT INTERESTED IN THE REWARD. IT IS HIGHLY LIKELY THAT WILSON AND PATTEN WILL CONTINUE TO CONTACT FLAID ON A REGULAR BASIS TO PROVIDE INFORMATION ABOUT THIS MATTER, AND ANY OTHER MATTER THAT THEY PERCEIVE IS UP INTEREST TO MILLITARY INTELLIGENCE.
