SUBJ: ALERT NOTICE - POSSIBLE KIDNAPPING ATTEMPTS (U)

1. (C) AN UNEVALUATED PSYCHIC SOURCE HAS REPORTED A POSSIBLE KIDNAPPINGS TO BE ATTEMPTED 15 JANUARY 1982 AGAINST TWO U.S. GENERAL OFFICERS, ONE IN FRG (IDENTIFIED AS POSSIBLY GENERAL KROESEN) AND ONE IN LUXEMBOURG (NFI). SOURCE SAYS THESE KIDNAPPINGS ARE PART OF AN OVERALL PLOT WHICH INCLUDED THE KIDNAPPING OF BG DOZIER.

2. (S/NOFORN) INFORMATION IN PARA 1 WAS PROVIDED TO DIA BY DA, DCSOPS. IT WAS OBTAINED FROM OTHERWISE UNEVALUATED PSYCHIC SOURCE

WHOSE RECENT REPORT ON THE BG DOZIER KIDNAPPING INCIDENT IS CHARACTERIZED BY SETAF AS THE MOST RELIABLE RECEIVED TO DATE. DIA CANNOT EVALUATE THE SOURCE OR HIS INFORMATION. HOWEVER IN LIGHT OF THE APPARENT ACCURACY OF THE DATA THIS PSYCHIC PROVIDED ON THE BG DOZIER KIDNAPPING, HIS PERCEPTION OF A THREAT TO U.S. OFFICIALS IS FORWARDED FOR YOUR PERUSAL AND ACTION AS DESIRED.

3. {C} SOURCE IS BEING QUERIED FOR FURTHER DETAILS WHICH WILL BE PROVIDED AS OBTAINED AND IF PERTINENT.

4. {C} ALTHOUGH DIA CANNOT CORROBRATE THIS DATA SENIOR MILITARY OFFICIALS THROUGHOUT THE NATO AREA ARE STILL CONSIDERED PRIME TARGETS FOR FURTHER TERRORIST ACTION IN THE NEAR FUTURE.

5. {U} PARAS ONE, THREE AND FOUR RELEASABLE TO HOST GOVERNMENT AUTHORITIES IF YOU DEEM APPROPRIATE.
