1. (S/SK/WINTEL) The mission of the SUN STREAK Prototype Operational Group (POG) is to undertake operational intelligence applications using an aspect of psychenergetics known as remote viewing (RV). An integral part of that mission is to train personnel in RV. [redacted] and [redacted] are responsible for the development and implementation of the in-house training program. Attached is their training report for second quarter of CY 1986.

2. (S/SK/WINTEL) Also attached is the SUN STREAK Activities Report for the second quarter CY 1986. This report covers the number of training sessions, the number of operations and operational sessions, and the number of Utility Assessment targets and sessions worked. Evaluation of the operational work is in progress and the results will be recorded when available.

3. (S/SK/WINTEL) Attention is invited to paragraphs 2a and 2b of the attached activities report wherein the characteristics of the two types of Remote Viewing taught by this office are discussed.

4. (S/SK/WINTEL) One item not covered in the training report is the time spent in training the trainers. Both [redacted] and [redacted] are doing excellent jobs as training officers. Many hours are still spent, both working with [redacted] and working and reading on their own, to perfect their skills as training officers and interviewers.

b. (S/SK/WNINTEL) Source #21 completed the final stages (S5/S6) of training on 17 June. Source #18 is currently undergoing S5/S6 training.

2. (S/SK/WNINTEL) 'Post Graduate Training': The training matrix will continue to reflect the participation of fully-trained viewers in 'novel' training sessions. These sessions are selected to provide site stimuli which induce the firing of cognitrons that would not normally be exercised in day-to-day operations. These breaks in routine serve a dual purpose; they maintain the source in an alert state and result in richer descriptions (greater range of data) of operational targets.

2. (S/SK/WNINTEL) The SUN STREAK office uses three different methods of Remote Viewing (RV):

a. (S/SK/WNINTEL) Coordinate Remote Viewing (CRV)

- (1) Site acquisition by coordinate designation
- (2) Monitor present during viewing
- (3) Highly structured reporting format
- (4) "Alpha/Beta State" environment
- (5) Trainable

b. (S/SK/WNINTEL) Extended Remote Viewing (ERV)

- (1) Variety of site acquisition techniques
- (2) Interviewer present during viewing
- (3) Primarily verbal reporting combined with sketching when appropriate
- (4) "Delta/Beta State" environment
- (5) Trainable


c. (S/SK/WNINTEL) Spontaneous Remote Viewing (SRV)

- (1) Site acquisition by sealed envelope
- (2) Monitor/Interviewer not present during viewing
- (3) Reporting by written summary of perceptions
- (4) Viewer's choice of working environment
- (5) Not trainable - used only with experienced viewers

3. (S/SK/WNINTEL) Development of the Utility Assessment target pool continues. If all goes as planned, the third quarter of 1986 will include an increased volume of Utility Assessment RV sessions. Now that three sources have completed "basic" CRV training, operational sessions will increase and training sessions decrease for these individuals.
