MEMORANDUM FOR RECORD

SUBJECT: CENTER LANE Interview Summary - CL-1026/8307/01 (U)

1. (S/CL-3/NOFORN) On 120900 July 1983, source #01 was interviewed in an attempt to determine if he could provide information relevant to a group of unidentified buildings. The project 8307 sponsor had provided geographic coordinates of the buildings, a photograph of the buildings, and a map showing their relative location (see Incl 1).

2. (S/CL-3/NOFORN) For this interview source was given the geographic coordinates provided by sponsor. Other information provided by the sponsor was not shown to the source as the collection plan called for its use as "feedback" and cuing material for possible subsequent interviews.

3. (U) A transcript of the interview was prepared including a narrative explanation of the drawing which source provided (see Incl 2).

4. (U) A DA Form 341 (Agent Report) was prepared for the sponsor. This report related the salient points of the interview. Attached as an exhibit to the DA Form 341 was a copy of source's drawing (see Incl 3).

- #66: Okay. With the "H" shape building to your back, the "C" shape buildings to the left and right, move down between the "C" shaped buildings, down, down, down and describe what's in front of you.
- #01: ...Large square.
- #66: All right. Now as you're standing looking at this large square, describe the surface you're standing on.
- #01: White pavement.
- #66: Okay. Now, as this white pavement proceeds towards the large square, describe.
- #01: Goes up,...it's tiered. Ah...seems like there's a

- #01: A lot of white pavement.
- #66: Okay. Listen carefully for movement exercise. You're moving now from, down the white pavement area, from the "H" building, between the "C" buildings, moving now towards the square opening in front of you. And you're now moving to 100 feet beyond the square opening, describe.

 a "U", bent ends like a horseshoe.

- #01: Pointed away from me.
- #66: Okay, let's turn and look the opposite direction.
- #01: Large, block white square.
- #66: All right. We have a mirror reversal of directions here, so when I tell you then to face, what you know as north, then you see the flanking "C" shaped buildings and the large white square?



DRAWING EXPLANATION

- #01: Okay, this is just drawing #1. I'll label it a #1. I've labeled what's a main street out here and how it comes in through a arched area. And goes around a white square shaped object and there's some kind of a black opening, I'll call it a black opening. What it is, is just a black rectangle against the white concrete like, "C" shaped buildings and "H" shaped building. And they are very distorted views of what the buildings look like. I got a feeling like they're much larger and you can just define the "C" part, you know like the legs of the "C" and the legs of the "H", like the "H" building is much wider and thicker. But I'm not sure which side the "H" is formed on, it's just an "H" shaped building.
- #66: Okay, in terms of numbers of stories, are these single story or multi story buildings?
- #01: Oh, they're multi story. They're like 5 or 6 stories, somewhere between 4 and 6.
- #66: And then when I ask you what was to the southeast of this?
- #01: There's a lake with an island in it, a lake or a pond with some kind of an island in it.
- #66: Okay. Anything else?
- #01: That's all.


