OPERATIONS. TO DATE, THE PROGRAM HAS CONDUCTED MORE THAN _____ OPERATIONAL MISSIONS IN SUPPORT OF _____ PROJECTS FROM SUCH AGENCIES AS THE CIA, NSA, DIA, SECRET SERVICE, THE JOINT CHIEFS OF STAFF, INSCOM, ETC.

SAMPLES OF INTELLIGENCE COLLECTED THROUGH REMOTE VIEWING ARE CONTAINED IN OUR PROJECT BOOK. PRIOR TO ITS REVIEW, HOWEVER, I WOULD LIKE TO EMPHASIZE THE FOLLOWING POINTS:

NOT ONLY IS REMOTE VIEWING PASSIVE, BUT THERE IS NO KNOWN DEFENSE AGAINST IT. FURTHERMORE, NEITHER TIME, TARGET SIZE, NOR DEGREE OF DIFFICULTY HAVE ANY APPARENT EFFECT ON COLLECTION. EQUALLY IMPORTANT IS THE LOW COST IN RELATION TO VALUE AND VOLUME OF INTELLIGENCE OBTAINED.

LET ME STRESS, HOWEVER, THAT REMOTE VIEWING IS NOT A "MAGIC LAMP," NOR IS IT A SUBSTITUTE FOR TRADITIONAL INTELLIGENCE WORK. REMOTE VIEWING IS A UNIQUE, HIGHLY CONTROLLED, AND FORMALLY ESTABLISHED INTELLIGENCE CAPABILITY, THAT SERVES AS AN EXTREMELY VALUABLE COMPLEMENT TO MORE PROSAIC COLLECTION METHODS.

REMOTE VIEWING HAS BEEN SUCCESSFULLY USED AGAINST 5 PRINCIPAL TYPES OF TARGETS, EXAMPLES OF EACH OF WHICH ARE INCLUDED IN THE BRIEFING BOOK, WHICH WILL NOW BE PRESENTED.
