AS YOU MAY RECALL, GENERAL DOZIER WAS KIDNAPPED THE EVENING OF 17 DECEMBER 1981. On 18 DECEMBER, WE CONDUCTED OUR FIRST SESSION.

BRIEFING THE COMMANDER SETAF THAT THE SEARCH FOR GENERAL DOZIER SHOULD BE CONCENTRATED IN THE PADUA AREA. THIS BRIEFING WAS DONE TWO DAYS PRIOR TO GENERAL DOZIER'S ACTUAL RESCUE.

THIS DRAWING CAME FROM THE THIRD SESSION. NOTE THE NAME PADUA THIS SESSION TOOK PLACE ON 20 JANUARY 1982, EIGHT DAYS PRIOR TO THE RESCUE OF GENERAL DOZIER. THE REMOTE VIEWER INDICATED WE SHOULD CONCENTRATE ON THE CITY OF PADUA. THIS DRAWING, HOWEVER, WAS NOT FORWARDED TO ITALY. AT THE TIME THE ITALIAN POLICE WERE HAVING DIFFICULTY SORTING THE INFORMATION THEY WERE GETTING FROM PSYCHICS ALL AROUND THE WORLD. TWO OPERATIONS BASED UPON PSYCHIC INFORMATION WERE UNSUCCESSFUL AND RATHER EMBARRASSING. BECAUSE OF THIS, THEY WERE RELUCTANT TO ACT ON ANY FUTURE PSYCHIC INFORMATION. FOR THIS REASON, THE ITAC ANALYST CHOSE NOT TO FORWARD THIS DRAWING.

AFTER GENERAL DOZIER'S RELEASE, WE INITIATED A REVIEW OF OUR DATA TO DETERMINE IF ANALYSIS BY

A KNOWLEDGEABLE ~~INDIVIDUAL~~ ^{ANALYST} MAY HAVE MADE BETTER USE OF THE INFORMATION. THAT PROJECT IS CONTINUING. THE FOLLOWING GRAPHICS DESCRIBE SOME OF THAT WORK:

BASED UPON KNOWLEDGE OF THE RED BRIGADE, INTELLIGENCE COMMUNITY ANALYSTS ASSUME^D FIRST: THAT GENERAL DOZIER WOULD NOT BE MOVED OUT OF ITALY AND SECOND: BECAUSE OF ANTICIPATED POLICE REACTION AFTER THE KIDNAPPING, GENERAL DOZIER WOULD BE HELD SOMEWHERE WITHIN 1 1/2 HOUR'S DRIVE FROM VORONA.

AMONG OTHER INFORMATION OBTAINED IN THE FIRST REMOTE VIEWING SESSION WAS THE FOLLOWING CONCERNING THE LOCATION OF GEN DOZIER:

BASED UPON THE COMMUNITY ANALYSTS' ASSUMPTIONS, THE ONLY CITY WE LOCATED IN NORTHERN ITALY WHICH FIT THE DESCRIPTIONS WAS PADUA.

WAS PADUA.

THIS GRAPHIC DEPICTS TOTAL STATEMENTS AND THOSE WHICH HAD CORRELATION WITH THE TARGET. THE OVERALL ACCURACY WAS OVER 40 PERCENT, ~~HOWEVER, WE JUDGED THAT ONLY 4 PERCENT,~~ HOWEVER, WE JUDGED THAT ONLY 4 PERCENT HAD POTENTIAL FOR LOCATING BG DOZIER.

THE REMOTE VIEWER WAS TOLD TO GO TO THE TARGET WHOSE PHOTOGRAPH WAS IN THE SEALED ENVELOPE. ONCE IT WAS DETERMINED THAT HE WAS AT THE TARGET, HE WAS TOLD TO DESCRIBE HIS PERCEPTIONS OF ITEMS OR ACTIVITY OF INTELLIGENCE INTEREST. THE FOLLOWING DRAWINGS WERE DONE BY THE REMOTE VIEWER.
