1. (S/NF/SK) INTERVIEWER TASKING: Approximately one year ago this office began a periodic Remote Viewing mission of the [REDACTED] located in a large, unusually configured building [REDACTED] walls. The specific target was a special private room adjacent to a larger "operations type room" in which the senior members of the [REDACTED] meet to discuss various matters in relative privacy and in a more informal manner. For the last several months other commitments have prevented continued exploitation of this facility. In an effort to rejuvenate this target, Source was provided this mission with the expectations that specific time parameters could be obtained by which this office can more effectively determine the nature and "time relevance" of the data obtained during these periodic sessions.

2. (S/NF/SK) SOURCE TASKING: Source was told that this was a continuation of a target that, "...You have worked before. In Your own words, it involves a polyhedron shaped building in which a small group of men are involved in discussions". Source was further told that the Interviewer would, "provide you with coordinates and when You acquire the structure You are to remain outside until I provide you with further tasking". At the beginning of the session, Source was also provided encrypted coordinates of the site, 112170/018605, as per Extended Remote Viewing (ERV) protocols. No other cuing or descriptive data was provided to Source prior to the session.

3. (S/NF/SK) INCLEMENCIES: There were no reportable incidents or anomalies which may have influenced the data obtained in this session. Source was not told until just prior to the beginning of the session that He would be tasked utilizing the ERV technique vice



the Coordinate Remote Viewing technique in which Source has been fully trained.

4. (S/NF/SK) SUMMARY: Source furnished the attached summary which was prepared following the session and submitted to the Interviewer within 24 hours after the session. The completeness of the typewritten summary has been compared to the Interviewer's notes and all omissions, changes, and/or corrections have been verified as acceptable by the Interviewer. The information provided in the summary was found to be complete and did not require further modification, clarification or additions by the Interviewer.

5. (S/NF/SK) COMMENTS: Although Source has previously reported on this target, His previous sessions were conducted in the Coordinate Remote Viewing technique and were conducted over six months ago. For this reason, this report has been labelled "Session #1" for clarity and ease of future reporting since this does in fact represent a new phase concerning this particular target. It is anticipated that Source will be tasked to report on this facility on a monthly basis and that future efforts will concentrate on "locking down" the specific time period in which Source is reporting that data. Once this is accomplished, this "date" will provide an anchor by which Source can be tasked to move forward or backward in time to obtain specific plans and intentions data. It should be noted that during the actual session, Source had several AOL perceptions of the Pentagon when trying to describe both the shape as well as the functional gestalt of the structure. This is indicative of a successful target acquisition and a keen appreciation of the actual mission of the target.
