1. () TASKING: Prior to the session, the Source was told that she would be re-targeted on the same site she had worked in the previous session. This was the first time that Source had ever knowingly been re-targeted on the same site in consecutive sessions. She was told to return to the area of the site and to initially attempt to perceive the entire area first before moving into the "underground facility that you told me about in the previous session". Just prior to beginning the actual session, the Source was again provided the same encrypted coordinates as before in keeping with accepted Extended Remote Viewing (ERV) protocols. No other cuing or descriptive data except as stated above was provided to the Source pertaining to this site.

2. () SESSION: There were no unusual occurrences, inclemencies or external environmental conditions known to the Interviewer which may have influenced the results of this session. This session was conducted entirely utilizing ERV protocols.

3. () SUMMARY:

a. () The following narrative contained within quotation marks is an abridged copy of Source's post-session written summary. This summary has been editorialized, (as indicated), by the undersigned for clarity, grammar and structure. The actual unabridged summary is maintained in the mission field dossier at this location along with any other material produced during this session, e.g., sketches, notes, etc. BEGIN NARRATIVE: "(The site has a) submarine-like atmosphere (with) low ceilings, curved doorways that you had to step up and over, overhead pipes and "crew-type" quarters with bunk beds. There is a tall, (3 story

room) with metal platforms and narrow stairs and a narrow walkway on the second level (which reminds me of) an observation platform. There were a lot of pipes - both vertical and horizontal (throughout this facility). Some of them (the pipes) reach from the lower to the upper levels. (The) atmosphere was hot and humid. (I) next (came to) a small enclosed room, (very dark), with a thick plate glass window looking down on a circular room. The circular room had walls about 20 feet (high) and at the upper levels (of these walls), there were windows. The windows (appeared) to be black on one side. The (circular) room was very brightly lit. (There were) several consoles on one side of the room (described as following)

- (1) A piece of equipment like a polygraph (with) scrolling paper and pens making squiggly (sic) lines (on the paper).
- (2) (A piece of) equipment with dials, gauges and toggle switches and small green and red lights.
- (3) A teletype-like machine with paper rolling out.
- (4) A small desk top monitor and keyboard.

(At) the lower level (there is) a large round white metal tank. It is cold to the touch. (There is) icy condensation on the side. (There is a) piston-type gadget keeping the tank pressurized. There is a glass tube gauge on the side (of the tank). People in (this) area (are) dressed in protective clothing with hoods, boots and gloves. (I also see) a small, heavy, silver canister with a heavy viscous liquid inside".

b. () During the actual session, Source reported other data which may impact on the final assessment of this target. That data is listed below in raw unevaluated form:

(1) () To augment Source's written reference to being in a "submarine atmosphere", she further stated that this area had a reverberating, echoing feel about it with areas of metal platforms and steps leading to different levels. Upon closer examination, however, the depth and sheer numbers of these levels belied the possibility of this area being a "submarine" and as the session progressed this initial analytical overlay disappeared and the site "adopted" a more conventional structured appearance.

(2) () Source reported a white metal tank within this structure and men working around this object. According to Source the tank contained a volatile and extremely cold substance. Men working around this device are seen to be wearing protective

clothing consisting of full body covering including thick gloves, a dome like helmet and some sort of material pull over their shoes and tied around the ankles giving the impression of wearing "baggies" on the feet. The substance in the tank is very unstable and devices attached to the outside of the tank measure the state of the material inside the tanks.

4. () OPS FEEDBACK: Source's descriptives in many aspects closely parallel the reporting of other Source's who have "worked" this site. No definitive explanation of the actual purpose of this site by this Source was discerned during this session. It is planned to utilize this Source in future sessions directed at this site at a time yet to be determined. It should be noted that Source's first experience at a "re-visit" tended to confirm a hypothesis that repeated targeting does not, as presumed, cause the Source to AOL the reported data but rather they tend to "sort out" previously reported material in a more clear and non-ambiguous manner.
