

1. (S/NF/SK) Monitor Tasking: Attempt to identify the "end use" of the product(s) leaving the target (facility).
2. (S/NF/SK) Source Tasking: The Source was instructed to begin the session in Stage IV. Directions were to "determine whether anything connected with the target leaves the area identified in session #2" and, if so, "describe whatever it is that is taken out and track it to its destination".
3. (S/NF/SK) Summary: The Source's summary is attached. Please note that the "secured complex" is not the original target site (Refer to session #2).
4. (S/NF/SK) Comments: As the session progressed, it became very difficult for the Source to avoid the idea of "uranium/plutonium reprocessing", etc. (see data). Therefore, as insurance against AOL drive, both monitor and Source jointly agreed to a cooling-off period prior to proceeding against this target.

The target is a product. At this time the product is leaving a secured complex in a large, white van. The van is stopped at the main gate and paperwork is being processed by an armed, uniformed security guard. This appears to be a routine action. The inside of this van is spacious, uncluttered, and there are shelves lining each side of the interior. There is also a heavy-gauge, wire-mesh divider present. Its function and description are unknown at this time.

The product of importance, located inside this van appear to be *like analysis* small, heavy, cylindrical, pellet-like objects. It feels metallic, but *yes* not quite. An impression of a powdery substance, in solid form is present.

COMMENT: Getting an impression of a controlled, hazardous material. AOL - like radioactive material.


