1. (S/NF/SK) During the period of 6 October 1988 - 17 October 1988, two remote viewers conducted a total of 5 CRV sessions in an effort to address requirements concerning possible drugs on board the vessel These requirements are enclosed at TAB A. Enclosed at TAB B are the viewers' sessions.

(S/NF/SK) 003 reported that there were drugs aboard the vessel though he sensed that the drugs were "like" marijuana not cocaine. The drugs were stored in 10-20 rounded, hollow, cylindrical containers which looked "similar to" emergency liferaft containers. These 10-20 cylindrical containers were stacked inside a large, rectangular/oblong metallic container with corrugated sides "similar to" a CONNEX container. This large rectangular container was below-deck in a low, central location $oldsymbol{\mathcal{U}}$ inside the large, forward portion of the vessel. This container was surrounded and covered by other items and materials. One impression of these other materials was that of large, banded stacks of dimensional lumber. The drugs were off-loaded somewhere in the vicinity of the mouth of the Albemarie Sound in North Carolina, near Nag's Head/ Kitty Hawk. The ultimate destination for the drugs is Los Angeles, Boston, New York City and Knoxville. The drugs will not end up in either Chicago or San Francisco. The drugs will be transported in a two-axle, yellow, silver-colored box-body truck moving a long distance from east to west.

3. (S/NF/SK) 018 reported that the drugs were in a squarish, round-edged, flat object that is approximately 1x3x3 feet in size. It was of a dark, matte color, but there were shiny parts on it that reflected light. This object was located in a dark, metallic room that had an opening near the top where one could climb down a metal-runged ladder into the room. There was also a door in the wall opposite the position of the object. This room is in the forward, port side of the ship, just below deck.

O18 identified 6 final destinations for the drugs; St. Louis, MO (weak feeling); Cincinnati, OH (weak feeling); Washington, DC (weak feeling); Las Vegas, NV (strong feeling); Boulder, CO (strong feeling) and San Francisco, CA (very strong feeling).
