I started the session initially at 1015 but ended up at a site different from the target. I knew it was different, because it smelled and looked totally unlike the site from yesterday. This 'wrong' place was two buildings on flat yellow land. They were at an 120 degree angle to each other. One was like a factory with lots of pipes and tanks on it. The other was a facility which stored drums of flammable chemicals. This storage facility had several large, metal, garage-like doors. The chemical was a thick liquid with a greenish tinge to it. I don't know why I was drawn to this place -- AOL that a fire would occur. This place had absolutely no relationship to the target.

After I completely objectified this I called a break. At 1102, the session was resumed, starting from scratch (stage 1) I started to get on site then again felt myself veering away. The previous caused too much of an AV for me to work through after such a short break. I will make myself available to work tomorrow to make up for today.


