1. (S/STD/NF) On 05 April 1990, five remote viewers (# 018, 025, 032, 079 and 095) conducted a total of five SOLO sessions in an effort to answer requirements against the probable narcotics smuggling vessel known as [REDACTED] with call sign [REDACTED].
SG1A The customer provided the following EEI:

- a. Determine if the vessel is indeed carrying contraband narcotics.
- b. Determine current location of the vessel.
- c. Where is the narcotics contraband located on board the vessel?
- d. Where will the off-loading/transfer of the narcotics take place?

2. (S/STD/NF) 018 reported that the vessel is currently (05 1115L APR 90) located at 17 N 63 W. The vessel is carrying contraband in the form of hard, white "bricks" or blocks which are in plastic baggies inside large (50 lb) bags of feed or grain. These are located on both starboard and port sides of the ships hold, amidships (C 4-6, F 4-6 on notional grid). 018 had the impression that the baggies were inserted into the larger bags by personnel on board. The drugs were unloaded to the vessel from a submarine at the same location in the very recent past.

3. (S/STD/NF) 025 reported that the current (05 0730-0930L APR 90) location of the vessel is near the Virgin Islands at 18 N 63 E. The vessel is carrying contraband cocaine which is wrapped in clear plastic bags which are in small attache suitcases with metal handles. These are located near the bow, close to the center-line of the vessel (E2 on the notional ship grid). The intended destination of the contraband is toward Nassau at 27 N 78 W. However, the vessel itself is moving northward and could go as far as Canada. The vessel is bi-level, light on the bottom and dark on the top deck. The captain has dark hair and a beard. There are at least three men aboard the vessel with handguns.

4. (S/STD/NF) 032 reported that the current (05 1100L APR 90) location of the vessel is 17 50' N 77 05' W vicinity of Portland Point/ Harbor Bay Jamaica. The vessel does not have contraband on board though it has carried it in the past. The vessel will take to port in the vicinity of Santa Rosa Sound in NW Florida.


5. (S/STD/NF) 079 reported that the current (05 1330-1430L APR 90) location of the vessel is 78 W 22 N. The vessel is carrying contraband located midships near the centerline of the vessel (D4 on the notional ship grid). The contraband will be unloaded in the Florida Keys at 83 W 26 N. There is additional smuggling activity occurring at the mouth of the Gulf of St Lawrence between Nova Scotia and Newfoundland.

6. (S/STD/NF) 095 reported that the vessel is currently located east of Trinidad at 11 07'N 56 40' W. The vessel will follow a northwesterly route between Grenada and Barbados and then between the Grenadines and St Lucia toward the southern side of Puerto Rico. The vessel is currently carrying contraband which white, semi-transparent, hard, solid cocaine. This is located below deck above the waterline in an area midway between the center and the portside, forward of the stern a distance 1/4 of the vessel's length (C7-B on the notional ship grid). An unloading point for the contraband was not determined, however, the vessel will stop south of Puerto Rico at 17 05' 30" N 67 12' W.

7. (S/STD/NF) Located at TAB A is a map showing all the points and approximate routes of the vessel(s) provided by all viewers. Located at TAB B are all the viewers' session summaries and EEI report sheets.
