TO: BRANCH CHIEF, DT-S

1. (S/NF/SK) On 09 April 1990, four remote viewers (# 018, 025, 032 and 079) conducted a total of four SOLO sessions in an effort to answer requirements against the probable narcotics mothership known by call sign [redacted]. This vessel was last known

[redacted] The vessel was believed to be heading to rendezvous with U/I associates to engage in a surface transfer and/or unload provisions. The customer provided the following EEI:

- a. Identify (name and description) the mothership.
- b. Is the mothership carrying contraband?
- c. If so, where on board is it located?
- d. Determine the date, time and location of the contraband transfer/off-loading point.
- e. Identify (name and description) associated vessel(s).
- f. What is the route and speed of advance of the mothership from the last known location?

2. (S/STD/NF) 018 reported that the mothership's name approximates "REINA" or "PUNTA REINA." It has chipped dull yellow paint with a bright red symbol angled across the superstructure. There is a strange triangular opening low on the ship (above waterline, below deck level) through which one can see the horizon on the other side of the ship (see sketches included with viewer summary TAB B). The vessel is not currently (09 0930L APR 90) carrying contraband. It is currently (09 0930L APR 90) located at 16 30' N 74 30' W heading northward between Haiti and Cuba. A large shipment of contraband will be loaded onto this vessel on 12 SEP 90 at 11 22' N 73 21' W (northern coast of Colombia).

3. (S/STD/NF) 025 reported that the mothership is carrying cocaine near the center of the vessel, midships near below deck near the level of the waterline (E-5 on notional ship grid). From its last known location the vessel travelled in a southwesterly direction, then circled around Haiti to its current location of 21 N 73 W. The vessel is heading in the direction of the Caicos Islands to 22 N 68 W. At this location, in a matter of days the drugs will be off-loaded to a little ship.



4. (S/STD/NF) 032 reported that the name of the mothership approximates "SANTA CARIBE" or "SANTA CARMEL." It carrying contraband narcotics located aft and on deck (B 8-9, G 8-9 on notional ship grid), sealed inside 6-12 plastic containers which are normally used as buoys or flotation devices. From its last known location the mothership is travelling 20-25 knots in a north, northeast (heading 022 degrees) direction. This is sporadic with numerous stops at small unobtrusive ports. The mothership is currently (09 1030L APR 90) located at 24 05' N 64 05' W. The vessel will transfer/off-load the contraband on 17 APR 90 under the cover of darkness at 46 02' N 62 05' W.

5. (S/STD/NF) 079 reported that the mothership is not currently (09 0930L APR 90) carrying contraband. The mothership unloaded the contraband onto a smaller vessel 2-3 days ago (6-7 APR 90) at 15 26' N 64 W. This smaller vessel is currently located northwest of Bermuda at 32 53' N 65 24' W. It will off-load the contraband at Savannah, GA. The ultimate destination of the contraband is Augusta, GA. After the transfer the mothership sailed south and is currently (09 0930L APR 90) at Georgetown, Guyana.

6. (S/STD/NF) Located at TAB A is a map showing all the points and approximate routes of the vessel(s) provided by all viewers. Located at TAB B are all the viewers' session summaries and EEI report sheets.



SUMMARY OF INFORMATION:

1. (S/STD) Identify and describe the probable narcotics smuggling mothership known by the callsign 

a. Perceived name as (approximation of) "REINA" or "PUNTA REINA".

b. Repeated indications of chipped, dull yellow paint, with a bright red (company symbol?) angled across the superstructure (see sketch, Fig. 1)

There also appears to be a strange (to me) triangular open area underneath the ship out of which one can see the open water (see sketch, Fig. 2).
2. (S/STD) Is the vessel carrying contraband?: Repeated attempts to find contraband drugs turned up no drugs presently (0930-0945 9 APR 90) on board.
3. (S/STD) Where is the vessel located?: Present (0920 9 APR 90) location is approximately 16 deg. 30' N / 74 deg. 30' W.
4. (S/STD) Identify any associated vessel(s): cursory search did not reveal any. Detailed search not addressed in this session due to time constraints.
5. (S/STD) What is the route and speed of advance of the mothership?: Present (9 APR 90) route is northward from present location turning northwesterly to go between Haiti and Cuba (see arrowed line on Map, Fig 3).
6. (S/STD) Give the date and location of the transfer point: Search for





It is moving fast, carrying cocaine, and is headed for the Caicos Islands to 22°N - 68°W. A transfer is involved to a little ship at this location in a matter of days. The drugs are aboard the main vessel  at E5 near the water line.




