SUMMARY OF INFORMATION

The target ship is a masted vessel with a dark green almost black hull. The rigging on the vessel is white with white sails and a white band around the ship just below the hand railing.


The ship was in for repairs recently and during that time the contraband was positioned. I perceived the contraband being positioned inside the masts — they are hollow and appear to made of metal. The drugs are not wrapped to offer any concealment they are simply in clear plastic.

The ship is presently located in the Atlantic (See tracing sketch).

The ship has a control wheel (wheel box) to the rear of the vessel. It looks like an older wheel but the vessel reminds me of a more modern type. The design of the vessel's hull looks sleek, and looks like it is made of fiberglass. The vessel looks like it is 5 or 6 meters wide, with a fairly deep draft — due to the keel.
