SUMMARY OF INFORMATION

The vessel associated with the call sign  is a small off-shore fishing vessel with three or four masts. The vessel was dedicated to a man who was a hero and the vessel itself may have a man's name. The number 2411 can be found written in black on the lower side of the vessel. The word's "Forth Writer/Forth Rider/Fourth Writer/Fourth Rider" phonetically surfaced in association with the vessel and/or call sign.

SG1A

This small off-shore fishing vessel is currently located at 117 Degrees North and 24 Degrees West. See ENCLOSURE 1.

The contraband is boarded "down under the shaft" of the vessel. The contraband is with the cargo wrapped in gift boxes.

This vessel will travel into the Gulf of California and off load the contraband at Yuma, Arizona. See ENCLOSURE 2.

The contraband will then be placed on a much smaller vessel and will travel in an easterly direction on the Gila River. \*

The ultimate destination of the drugs is Phoenix, Arizona.

The individual associated with the call sign  phonetically surfaced as "Delay/Delany/Dallie/Daly/Dialy/Dale."





ALBERT AZIMUTHAL EQUAL-AREA PROJECTION




