1. (S/NF/WN/NC) THE FOLLOWING INFORMATION IS TRANSMITTED IN THE ORDER OF PERCEIVED ACCURACY AND RELIABILITY BASED ON DISPLAYED PERFORMANCE.

A. SOURCE 079 INDICATED THE COCAINE IS CURRENTLY LOCATED IN THE WEST INDIES AT GEO COORDINATES 21 50 N / 74 50 W. IT WAS TRANSPORTED IN THE HULL, NEAR THE SHAFT OF A "BIG WHITE AND GREEN VESSEL. THE VESSEL IS EITHER OF PANAMANIAN REGISTRY AND FLYING AN AMERICAN FLAG OR OF AMERICAN REGISTRY AND FLYING A PANAMANIAN FLAG. THE NAME [REDACTED] APPEARS ON THE REGISTRY PAPERS. THE EXPRESSIONS "FAMOUS ANDY AND FLYING COLORS ARE ASSOCIATED WITH THIS VESSEL. SOURCE 079 PERCEIVED PART OF THE COCAINE AS ALREADY FLOATING IN WATER.

B. SOURCE 025 INDICATED THE COCAINE WAS ABOARD A SHIP CURRENT LOCATED IN THE CARIBBEAN AT 19 N / 85 W. THE VESSEL IS BOUND FOR MALABAR, FLORIDA (28 N / 80 30 W) VIA THE GULF OF MEXICO. THE VESSEL IS DESCRIBED AS BEING BI-LEVEL, LONG WITH YELLOW TRIM. THE COCAINE IS WRAPPED IN ROUND PLASTIC PACKAGES STORED IN A LARGE BIN ON THE LOWER LEFT SIDE OF THE VESSEL.

C. SOURCE 049 PERCEIVED THE COCAINE AT ITS STARTING POINT (NFI) BEING LOADED ABOARD SHIP, NFI. THE COCAINE IS VIEWED AS BEING TRUCKED OVER THREE MOUNTAINS AND THREE VALLEYS TO GET TO THE VESSEL.
