REFERENCE YOUR SESSION OF 16 JUN 92 AND 19 JUN 92

----YOUR SESSION 01 OF 16 JUN 92 INDICATES A DEPARTURE FOR NORTH AMERICA IN ABOUT TWO WEEKS (O/A 30 JUN 92).

- o Need to determine if vessel is sailing.
- o If so, determine its current location.

----YOUR SESSION 02 OF 19 JUN 92 INDICATES THE TARGET VESSEL WILL OFF-LOAD IN AN AREA LOCATED NEAR THE US/CANADIAN BORDER.

o Recommend you conduct search to determine location of the projected point of off-load.

----YOUR PHONETICS ASSOCIATES THE OFF-LOADING LOCATION AS BEING ASSOCIATED WITH THE WORDS "CASPER/CHICO/CARTER."

o A search of available material indicates a "Chico" located west of Seattle and about 5 miles northwest of Bremerton.

----YOUR SESSION 02 INDICATED THE PRESENCE OF UNIFORMLY-SHAPED BLOCKS WRAPPED WITH THICK COVERING.

o Recommend you feel them for density, taste them, and determine colors - in short identify the substance through descriptives.

----YOUR SESSION 02 INDICATES AN AREA OF STORAGE FOR THE CONTRABAND.

o Suggest you sketch a side view of the target vessel to indicate the location of the storage area.

----Recommend you give phonetics a shot to determine "call sign(s)" used to communicate with the target vessel.

[YOUR BOTTOM LINES TO DATE ARE THAT THE TARGET VESSEL WILL OFF-LOAD O/A 29 JUNE 92 AT A GEO LOCATION FOUND IN THE VICINITY OF THE US AND THE CANADIAN BORDER.]


SG1A ----Your Session 01 finds the target vessel's current target location as being northwest of the Colombia/Panama border area. the is apparently en route to Buenaventura, Colombia, to load contraband in the form of illegal drugs. Moreover the vessel is expected to sail within about two weeks (o/a 29 Jun 92).

----The essential EEI deal with "when and where" the illegal contraband will be off-loaded at sea or in port.

----Need to concentrate further on the nature of the cargo, where it is stored and how it is wrapped.

----We also need to identify associate personalities and vessels, if any.

----We must also pursue a route of travel towards a destination.
