- 2. (S/NF/SK) VIEWER CUEING: "Today's target is the object which was discovered in yesterday's session."
- 3. (S/NF/SK) COMMENTS:
- a. This session evidences O25's increased willingness to draw rather than give perceptions in long, run-on sentences. O25 has been encouraged to "probe" the drawings for Stage 4 perceptions. I am aware that this is dangerously close to encroaching on major parts of Stage 6 training, but it has proven to be a very useful tool. Not only does O25 find it easier to gain perceptions from probing a drawing than from probing a Stage 4 column, but it also necessitates more drawing, since I will not allow O25 to go back up the page past an AOL break. This requires that O25 make another drawing to probe for further Stage 4 perceptions. Each new drawing is made with the benefit of closer site contact, and therefore appears to be more accurate, and to provide more accurate perceptions.
- b. 025 experienced some amount of AOL drive near the end of this session, but nothing drastic. Drive did not create incorrect perceptions, but only resulted in the tendency to tie the correct ones together incorrectly.
